HOUSE RESOLUTION NO. 18

1 A RESOLUTION EXTENDING THE GREETINGS OF THE HOUSE OF
2 REPRESENTATIVES TO PRINCE JUSTICE ZULU, QUEEN MANTFOMBI ZULU AND
3 THE DELEGATION FROM THE REPUBLIC OF SOUTH AFRICA AND WELCOMING
4 THEM TO THE STATE OF MISSISSIPPI.

5 WHEREAS, a distinguished delegation of royalty, educators and
6 businessmen from the Republic of South Africa is visiting the
7 State of Mississippi, and will be officially presented to the
8 Mississippi House of Representatives; and

9 WHEREAS, Prince Justice Zulu is the direct descendant of King
10 Shaka. His father, King Bhekuzulu, is also the father of King
11 Zwelithini. He is, therefore, the brother to the present King.
12 He is a lawyer by profession; he is also a legal advisor to the
13 King; and

14 WHEREAS, Queen Mantfombi is the third wife of King
15 Zwelithini. She is by birth a princess of the Swazi Royal family,
16 a daughter to King Sobhuza II of Swaziland; and

17 WHEREAS, Professor Sihawukele Emmanuel Ngubone is from
18 Maputoland, along the Mozambique and Swaziland border in the
19 Republic of South Africa. Professor Ngubane is currently the Head
20 of IsiZulu at the University of Natal where he teaches the first
21 and second language students from different backgrounds; he is the
22 moderator for most universities and technicians in the country:
23 University of South Africa, University of Zululand, University of
24 Durban Westville; M.L. Sultan Technikon, Promat and Edgewood.
25 Professor Ngubane is a key member of African Renaissance
26 Development Trust KZN and has chaired the three International
27 Festivals held in Durban in 1999, 2000 and 2001 and is employed by
28 Economic Development and Tourism as Head of the Ministry, (Durban)



29 South Africa; he currently serves as an executive of the Minara
30 Chamber of Commerce and is a board member of the KZN High Road; he
31 is currently studying for a masters in law through the University
32 of Port Elizabeth; and

33 WHEREAS, Frank Marawa is a businessman, travel and tour
34 operator, Director of the Durban African Tourism Board, Director
35 of the KwaZulu Natal Tourism Authority and board member - M.L.
36 Sultan Technikon; and

37 WHEREAS, it is with great pride that we recognize this
38 distinguished delegation from the Republic of South Africa, who
39 honor us with their presence:

40 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
41 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, That we do hereby
42 extend the greetings of the Mississippi House of Representatives
43 to Prince Justice Zulu, Queen Mantfombi Zulu and the other members
44 of the delegation from the Republic of South Africa and officially
45 welcome them to the House of Representatives and to the State of
46 Mississippi.
