- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 45-7-5, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 45-7-5. (1) Subject to the provisions of subsection (2) of
- 8 this section, the board of supervisors may compensate the county
- 9 patrol officers in an amount not to exceed Five Hundred Dollars
- 10 (\$500.00) per month for any one (1) county; in no case shall any
- 11 one (1) patrol officer receive compensation in excess of Two
- 12 Hundred Dollars (\$200.00) per month. In addition to such
- 13 compensation, the board of supervisors may furnish the patrol
- 14 officers means of transportation.
- 15 (2) (a) The board of supervisors of any county having a
- 16 population of thirty-one thousand six hundred fifty-three (31,653)
- 17 according to the 1960 federal decennial census, having a land area
- 18 of nine hundred thirty-eight (938) square miles, and wherein U.S.
- 19 Highway 49 and Mississippi Highway 16 intersect, may compensate
- 20 the county patrol officers in an amount not to exceed One Thousand
- 21 Dollars (\$1,000.00) per month for any such county; in no case
- 22 shall any one (1) patrol officer receive compensation in excess of
- 23 Five Hundred Dollars (\$500.00) per month.
- 24 (b) The board of supervisors of any county bordering on
- 25 the Louisiana line and Mississippi River may fix the compensation
- 26 of the county patrol officers at an amount not to exceed Four
- 27 Hundred Dollars (\$400.00) per month per patrol officer.

- 28 (c) The board of supervisors of any county bordering on
- 29 the Mississippi River wherein is located a national park and
- 30 cemetery, wherein U.S. Highways 80 and 61 intersect, and having a
- 31 population in excess of forty-two thousand (42,000) according to
- 32 the 1960 federal decennial census, may compensate the county
- 33 patrol officers in an amount not to exceed One Thousand Five
- 34 Hundred Dollars (\$1,500.00) per month for any such county but in
- 35 no case in excess of Five Hundred Dollars (\$500.00) per month per
- 36 officer.
- 37 (d) The board of supervisors of any Class 4 county
- 38 bordering on the state of Alabama wherein U.S. Highway 98 and
- 39 Mississippi Highway 63 intersect, having a land area of four
- 40 hundred eighty-one (481) square miles, may, in its discretion,
- 41 compensate each of its county patrol officers in an amount not in
- 42 excess of Six Hundred Fifty Dollars (\$650.00) per month.
- (e) The board of supervisors of any county in which
- 44 U.S. Highway 45 and Mississippi Highway 16 intersect may, in its
- 45 discretion, compensate its county patrol officers in an amount not
- 46 to exceed Twenty-two Thousand Dollars (\$22,000.00) annually per
- 47 patrol officer.
- 48 (f) The board of supervisors of any county in which the
- 49 Natchez Trace Parkway and Mississippi Highway 35 intersect and
- 50 which has a population according to the 1990 federal decennial
- 51 census in excess of eighteen thousand four hundred (18,400), in
- 52 its discretion, may compensate its county patrol officers in an
- amount not to exceed Two Thousand Dollars (\$2,000.00) per month
- 54 per patrol officer.
- 55 (g) The board of supervisors of any county in which
- 56 U.S. Highway 51 and Mississippi Highway 28 intersect, in its
- 57 discretion, may compensate its county patrol officers in an amount
- 58 not to exceed Two Thousand Five Hundred Dollars (\$2,500.00) per
- 59 month per patrol officer.
