SENATE BILL NO. 3134  
(As Sent to Governor)

1 AN ACT MAKING AN APPROPRIATION FOR EXPENSES OF THE EXECUTIVE  
2 DEPARTMENT, BEING THE GOVERNOR'S OFFICE AND STAFF, AND FOR  
3 EXPENSES INCIDENTAL TO THE PROPER OPERATION OF THE GOVERNOR'S  
4 MANSION AND RESIDENCE OF THE GOVERNOR, FOR FISCAL YEAR 2003.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

6 SECTION 1. The following sum, or so much thereof as may be  
7 necessary, is hereby appropriated out of any money in the State  
8 General Fund not otherwise appropriated, for expenses of the  
9 Executive Department, being the Governor's office and staff, for  
10 the fiscal year beginning July 1, 2002, and ending June 30, 2003,  
11 ..... \$ 2,117,424.00.

12 SECTION 2. The following sum, or so much thereof as may be  
13 necessary, is hereby appropriated out of any money in the State  
14 Treasury to the credit of the Governor's Office for the purpose of  
15 defraying the expenses incurred by the Executive Department, being  
16 the Governor's office and staff, for the fiscal year beginning  
17 July 1, 2002, and ending June 30, 2003.....\$ 122,232.00.

18 SECTION 3. With the funds appropriated under the provisions  
19 of Sections 1 and 2, the following positions are authorized:

25 Any escalations shall be made in accordance with the terms,  
26 conditions, and procedures established by law.

27 No general funds authorized to be expended herein shall be  
28 used to replace federal funds and/or other special funds which are



29 being used for salaries authorized under the provisions of this  
30 act and which are withdrawn and no longer available.

31 **SECTION 4.** Of the funds appropriated under the provisions of  
32 Section 2, Twenty-five Thousand Three Hundred Sixty-four Dollars  
33 (\$25,364.00) shall be derived from the Budget Contingency Fund  
34 created in Section 27-103-301, Mississippi Code of 1972.

35 **SECTION 5.** The following sum, or so much thereof as may be  
36 necessary, is hereby appropriated out of any money in the State  
37 General Fund not otherwise appropriated, for expenses incidental  
38 to the proper operation of the Governor's Mansion and residence of  
39 the Governor for the fiscal year beginning July 1, 2002, and  
40 ending June 30, 2003..... \$ 468,085.00.

41 **SECTION 6.** The following sum, or so much thereof as may be  
42 necessary, is hereby appropriated out of any money in the Budget  
43 Contingency Fund, created in Section 27-103-301, Mississippi Code  
44 of 1972, for expenses incidental to the proper operation of the  
45 Governor's Mansion and residence of the Governor for the fiscal  
46 year beginning July 1, 2002 and ending June 30, 2003.....  
47 ..... \$ 5,677.00.

48 **SECTION 7.** With the funds appropriated under the provisions  
49 of Sections 5 and 6, the following positions are authorized:

55 Any escalations shall be made in accordance with the terms,  
56 conditions, and procedures established by law.

57 No general funds authorized to be expended herein shall be  
58 used to replace federal funds and/or other special funds which are  
59 being used for salaries authorized under the provisions of this  
60 act and which are withdrawn and no longer available.



61           **SECTION 8.** The money herein appropriated shall be paid by  
62 the State Treasurer out of any money in the State Treasury to the  
63 credit of the proper fund or funds as set forth in this act, upon  
64 warrants issued by the State Fiscal Officer; and the State Fiscal  
65 Officer shall issue his warrants upon requisitions signed by the  
66 proper person, officer or officers, in the manner provided by law.

67           **SECTION 9.** This act shall take effect and be in force from  
68 and after July 1, 2002.
