Amend by striking all after the enacting clause and inserting in lieu thereof the following:

SECTION 1. Section 37-6-13, Mississippi Code of 1972, is 5 amended as follows: 6 7 (1) Each person serving as a member of the school board of any school district shall receive per diem in the amount of Sixty-seven Dollars (\$67.00) for no more than thirty-six (36) 9 meetings of the school board during any one (1) fiscal year or, in 10 his or her discretion, irrevocably may choose to receive as 11 compensation for his or her services an annual salary in the 12 13 amount of Two Thousand Four Hundred Dollars (\$2,400.00), which choice shall remain in force for all successive terms or periods 14 of service of that member. The receipt of the compensation shall 15 not entitle any member of a school board to receive or be eligible 16 for any state employee group insurance, retirement or other fringe 17 benefits. Each member shall be reimbursed for the necessary 18 expenses and mileage in attending meetings of the school board. 19 In addition to the foregoing, all members may be reimbursed for 20 21 mileage and actual expenses incurred in the further performance of their duties, including attendance at any mandatory school board 22 training session or at regional and national education meetings, 23 when such mileage and other expenses are authorized by the board 2.4

- 25 prior to the date on which they occur. Detailed vouchers shall be
- 26 submitted for reimbursement for all expenses authorized by this
- 27 section. Such reimbursement shall be in accordance with Section

- 29 Such expenses shall be paid on order of the school board by
- 30 pay certificates issued by the superintendent of the school
- 31 district involved against the funds available for payment of the

- 33 (2) (a) If a member of a school board misses twenty percent
- 34 (20%) or more of the meetings of the school board during a
- 35 <u>calendar year</u>, except for absences caused by required military
- 36 duty, the member must reimburse the school district that portion
- 37 of the total salary paid to the member that year which is
- 38 proportionate to the number of meetings missed by the member in
- 39 relation to the total number of school board meetings held during
- 40 that year. For purposes of this subsection, consideration may be
- 41 given only to meetings of which public notice is required.
- (b) Before February 1 of each year, the president of
- 43 <u>each local school board shall submit a report to the State Board</u>
- 44 of Education containing the names of any members of the school

- 47 **SECTION 2.** The Attorney General of the State of Mississippi
