AN ACT TO AMEND SECTION 23-15-753, MISSISSIPPI CODE OF 1972, TO INCREASE THE PENALTY FOR VOTE FRAUD IN VOTING BY ABSENTEE 1

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6

7 SECTION 1. Section 23-15-753, Mississippi Code of 1972, is

amended as follows: 8

23-15-753. (1) Any person who willfully, unlawfully and 9

feloniously procures, seeks to procure, or seeks to influence the 10

vote of any person voting by absentee ballot, by the payment of 11

money, the promise of payment of money, or by the delivery of any 12

other item of value or promise to give the voter any item of 13

14 value, or by promising or giving the voter any favor or reward in

an effort to influence his vote, or any person who aids, abets, 15

assists, encourages, helps, or causes any person voting an 16

absentee ballot to violate any provision of law pertaining to 17

absentee voting, or any person who sells his vote for money, 18

19 favor, or reward, has been paid or promised money, a reward, a

favor or favors, or any other item of value, or any person who 20

shall willfully swear falsely to any affidavit provided for in 21

22 Sections 23-15-621 through 23-15-735, shall be guilty of the crime

of "vote fraud" and, upon conviction, shall be sentenced to pay a 23

fine of Fifty Thousand Dollars (\$50,000.00) and sentenced to the 24

custody of the Department of Corrections for not less than five 25

(5) years nor more than ten (10) years. 26

27 It shall be unlawful for any person who pays or

compensates another person for assisting voters in marking their 28

- 29 absentee ballots to base the pay or compensation on the number of
- 30 absentee voters assisted or the number of absentee ballots cast by
- 31 persons who have received the assistance. Any person who violates
- 32 this section, upon conviction shall, be fined not less than One
- 33 Thousand Dollars (\$1,000.00) nor more than Five Thousand Dollars
- 34 (\$5,000.00), or imprisoned in the Penitentiary not less than one
- 35 (1) year nor more than five (5) years, or both.
- 36 SECTION 2. Section 23-15-889, Mississippi Code of 1972, is
- 37 amended as follows:
- 38 23-15-889. It shall be unlawful for any person to sell or
- 39 offer to sell his vote and it shall be likewise unlawful for any
- 40 person to offer money or anything of substantial value to anyone
- 41 for his vote. Anyone violating the provisions of this section
- 42 shall be guilty of a felony and upon conviction shall be fined
- 43 Fifty Thousand Dollars (\$50,000.00) and shall be sentenced to the
- 44 custody of the Department of Corrections for not less than five
- 45 (5) years nor more than ten (10) years.
- 46 **SECTION 3.** The Attorney General of the State of Mississippi
- 47 shall submit this act, immediately upon approval by the Governor,
- 48 or upon approval by the Legislature subsequent to a veto, to the
- 49 Attorney General of the United States or to the United States
- 50 District Court for the District of Columbia in accordance with the
- 51 provisions of the Voting Rights Act of 1965, as amended and
- 52 extended.
- 53 **SECTION 4.** This act shall take effect and be in force from
- 54 and after the date it is effectuated under Section 5 of the Voting
- 55 Rights Act of 1965, as amended and extended.
