HOUSE BILL NO. 564

1 AN ACT TO ABOLISH PARTISAN PRIMARIES; TO PROVIDE THE TIME FOR
2 HOLDING GENERAL AND PREFERENTIAL ELECTIONS; TO PROVIDE THAT WHEN
3 ONLY ONE PERSON HAS QUALIFIED AS A CANDIDATE FOR AN OFFICE, THAT
4 SUCH PERSON'S NAME SHALL BE PLACED ON THE GENERAL ELECTION BALLOT;
5 TO PROVIDE THAT WHEN MORE THAN ONE PERSON HAS QUALIFIED AS A
6 CANDIDATE FOR AN OFFICE, THAT A PREFERENTIAL ELECTION SHALL BE
7 HELD THREE WEEKS PRIOR TO THE GENERAL ELECTION AND THE CANDIDATE
8 WHO RECEIVES A MAJORITY OF THE VOTES CAST FOR SUCH OFFICE SHALL
9 HAVE HIS NAME AND HIS NAME ONLY PLACED ON THE GENERAL ELECTION
10 BALLOT; TO PROVIDE THAT WHEN NO CANDIDATE RECEIVES A MAJORITY OF
11 THE VOTES CAST IN THE PREFERENTIAL ELECTION FOR AN OFFICE, THAT
12 THE TWO CANDIDATES WHO RECEIVE THE HIGHEST NUMBER OF VOTES IN THE
13 PREFERENTIAL ELECTION SHALL HAVE THEIR NAMES PLACED ON THE GENERAL
14 ELECTION BALLOT AS CANDIDATES FOR SUCH OFFICE; TO PROVIDE THE
15 PROCEDURE TO FOLLOW IN CASE OF TIES; TO PROVIDE THE MANNER FOR
16 QUALIFYING AS A CANDIDATE FOR PUBLIC OFFICE; TO PROVIDE FOR THE
17 PRINTING OF NECESSARY BALLOTS; TO AMEND SECTIONS 21-7-7, 21-8-7,
18 21-15-1, 23-15-21, 23-15-31, 23-15-129, 23-15-153, 23-15-173,

35 OF THE STATE EXECUTIVE COMMITTEE AND COUNTY EXECUTIVE COMMITTEES
36 IN PRIMARY ELECTIONS, PROVIDE FOR THE QUALIFICATION OF CANDIDATES
37 FOR PARTY PRIMARY ELECTIONS, AND PROVIDE FOR THE CONDUCT OF PARTY
38 PRIMARY ELECTIONS; TO REPEAL SECTIONS 23-15-359, 23-15-361 AND
39 23-15-363, MISSISSIPPI CODE OF 1972, WHICH PROVIDE FOR THE
40 CONTENTS OF GENERAL ELECTION BALLOTS; TO REPEAL SECTIONS 23-15-597
41 AND 23-15-599, MISSISSIPPI CODE OF 1972, WHICH PROVIDE FOR THE
42 CANVASS OF RETURNS AND ANNOUNCEMENT OF VOTE BY THE COUNTY
43 EXECUTIVE COMMITTEES IN PRIMARY ELECTIONS AND REQUIRE THE STATE
44 EXECUTIVE COMMITTEE TO TRANSMIT TO THE SECRETARY OF STATE A
45 TABULATED STATEMENT OF THE PARTY VOTE FOR CERTAIN OFFICES; TO
46 REPEAL SECTION 23-15-841, MISSISSIPPI CODE OF 1972, WHICH PROVIDES
47 FOR PRIMARY ELECTIONS FOR NOMINATION OF CANDIDATES TO FILL
48 VACANCIES IN COUNTY AND COUNTY DISTRICT OFFICES; TO REPEAL
49 SECTIONS 23-15-921 THROUGH 23-15-941, MISSISSIPPI CODE OF 1972,
50 WHICH PROVIDE PROCEDURES FOR CONTESTS OF PRIMARY ELECTIONS; TO
51 REPEAL SECTION 23-15-1031, MISSISSIPPI CODE OF 1972, WHICH
52 PROVIDES FOR THE DATE OF PRIMARY ELECTIONS FOR CONGRESSMEN AND



53 UNITED STATES SENATORS; TO REPEAL SECTION 23-15-1063, MISSISSIPPI
54 CODE OF 1972, WHICH PROHIBITS UNREGISTERED POLITICAL PARTIES FROM
55 CONDUCTING PRIMARY ELECTIONS; TO REPEAL SECTION 23-15-1083,
56 MISSISSIPPI CODE OF 1972, WHICH REQUIRES THAT CERTAIN
57 CONGRESSIONAL PRIMARIES BE HELD ON THE SAME DAY AS THE
58 PRESIDENTIAL PREFERENCE PRIMARY; AND FOR RELATED PURPOSES.

59 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

60 **SECTION 1.** (1) For purposes of this act, the following
61 words shall have the meaning ascribed herein unless the context
62 shall otherwise require:

63 (a) "Preferential election" shall mean an election held
64 for the purpose of determining those candidates whose names will
65 be placed on the general or regular election ballot. Any person
66 who meets the qualifications to hold the office he seeks may be a
67 candidate in the preferential election without regard to party
68 affiliation or lack of party affiliation.

69 (b) "General election" or "regular election" shall mean
70 an election held for the purpose of determining which candidate
71 shall be elected to office.

72 (c) "Political party" shall mean a party defined as a
73 political party by the provisions of Sections 23-15-1059 and
74 23-15-1061, Mississippi Code of 1972.

75 (2) All qualified electors of the State of Mississippi may
76 participate, without regard to party affiliation or lack of party
77 affiliation, in any appropriate preferential, general or regular
78 election.

79 **SECTION 2.** The general election in 2003 and every general
80 election thereafter shall be held on the first Tuesday after the
81 first Monday of November of the appropriate year. When more than
82 one (1) person has qualified or been certified as a candidate for
83 any office, a preferential election for such office shall be held
84 three (3) weeks prior to such general or regular election.

85 **SECTION 3.** Any person who has qualified in the manner
86 provided by law as a candidate for election under Sections 1
87 through 11 of this act shall have the right to withdraw his name
88 as a candidate by giving notice of his withdrawal in writing to



89 the secretary of the appropriate election commission at any time
90 prior to the printing of the official ballots, and in the event of
91 his withdrawal the name of such candidate shall not be printed on
92 the ballot.

93 **SECTION 4.** When only one (1) person shall have qualified or
94 been certified as a candidate for any office, such person's name
95 shall be placed only on the general or regular election ballot and
96 shall not be placed on the ballot for a preferential election.

97 **SECTION 5.** When more than one (1) person has qualified or
98 been certified as a candidate for any office, a preferential
99 election for such office shall be held three (3) weeks prior to
100 such general or regular election, and any candidate who receives a
101 majority of the votes cast in such preferential election shall
102 have his name, and his name only, placed on the ballot in the
103 general or regular election. Except as provided in Section 6 of
104 this act, if no person shall receive a majority of the votes cast
105 at such preferential election, then the two (2) persons receiving
106 the highest number of votes in the preferential election shall
107 have their names placed on the ballot in the general or regular
108 election as candidates for such office.

109 **SECTION 6.** (1) When there is a tie in the preferential
110 election between the candidates receiving the highest vote, then
111 only those candidates shall be placed on the ballot as candidates
112 in the general election.

113 (2) When there is a tie in the preferential election between
114 the candidates receiving the next highest vote and there is not a
115 tie for the highest vote, candidates receiving the next highest
116 vote and the one receiving the highest vote, no one having
117 received a majority, shall have their names placed on the ballot
118 as candidates in the general or regular election.

119 (3) In the event that (a) there are more than two (2)
120 candidates in the preferential election, and (b) no candidate in
121 such election receives a majority of the votes cast at such



122 preferential election, and (c) there is not a tie in such
123 preferential election that would require the procedure prescribed
124 in subsection (2) of this section to be followed, and (d) one (1)
125 of the two (2) candidates who receives the highest number of votes
126 in such preferential election withdraws or is otherwise unable to
127 participate in the general or regular election, then the remaining
128 candidate of the two (2) who receives the highest vote in the
129 preferential election and the candidate who receives the third
130 highest vote in such election shall be placed on the ballot as
131 candidates in the general or regular election.

132 **SECTION 7.** All candidates receiving the highest number of
133 votes for any office in the general or regular election shall
134 thereby be declared elected to such office, subject to the
135 requirements of Sections 140, 141 and 143, Mississippi
136 Constitution of 1890.

137 **SECTION 8.** (1) All candidates upon entering the race for
138 election to any office, except municipal officers, shall, not
139 later than 5:00 p.m. sixty (60) days prior to any general or
140 regular election, file their intent to be a candidate and pay to
141 the secretary of the proper executive committee of their political
142 party or the appropriate election commission for each election the
143 following amounts:

144 (a) Candidates for Governor and United States Senator,
145 the sum of Three Hundred Dollars (\$300.00);

146 (b) Candidates for United States Representatives,
147 Lieutenant Governor, Attorney General, Secretary of State, State
148 Treasurer, Auditor of Public Accounts, Commissioner of Insurance,
149 Commissioner of Agriculture and Commerce, State Highway
150 Commissioner and State Public Service Commissioner, the sum of Two
151 Hundred Dollars (\$200.00);

152 (c) Candidates for district attorney, the sum of One
153 Hundred Dollars (\$100.00);



154 (d) Candidates for State Senator and State
155 Representative whose district is composed of more than one (1)
156 county, or parts of more than one (1) county, the sum of Fifteen
157 Dollars (\$15.00);

158 (e) Candidates for State Senator or State
159 Representative whose district is composed of one (1) county or
160 less, and candidates for sheriff, chancery clerk, circuit clerk,
161 tax assessor, tax collector, county attorney, county
162 superintendent of education and board of supervisors, the sum of
163 Fifteen Dollars (\$15.00); and

164 (f) Candidates for county surveyor, county coroner,
165 justice court judge and constable, the sum of Ten Dollars
166 (\$10.00).

167 (2) No person shall be denied a place upon the ballot for
168 any office for which he desires to be a candidate because of his
169 inability to pay the assessment above set out.

170 **SECTION 9.** (1) Candidates for offices set out in Section 8
171 of this act under paragraphs (a), (b), (c) and (d) shall file
172 their intent to be a candidate with the secretary of the state
173 executive committee of the political party with which the
174 candidate is affiliated or with the secretary of the state
175 election commission if not affiliated with a political party.

176 (2) Candidates for offices set out in Section 8 of this act
177 under paragraphs (e) and (f) shall file their intent to be a
178 candidate with the secretary of the county executive committee of
179 the political party with which the candidate is affiliated, or
180 with the county election commission if not affiliated with a
181 political party.

182 Not later than fifty-five (55) days prior to the general
183 election, the respective executive committee shall certify to the
184 appropriate election commission all candidates who have filed,
185 within the time prescribed herein, with such committee their
186 intent to be a candidate.



187 **SECTION 10.** (1) Necessary ballots for use in elections
188 shall be printed as provided for in Section 23-15-351, Mississippi
189 Code of 1972. The ballots shall contain the names of all
190 candidates who have filed their intention to be a candidate in the
191 manner and within the time prescribed herein. Such names shall be
192 listed alphabetically on the ballot without regard to party
193 affiliation, if any, with indication of the political party, if
194 any, with which such candidate qualified placed in parentheses
195 following the name of the candidate.

196 (2) The county election commissioners may also have printed
197 upon the ballot any local issue election matter that is authorized
198 to be held on the same date as the general election pursuant to
199 Section 23-15-375, Mississippi Code of 1972; provided, however,
200 that the ballot form of such local issue must be filed with the
201 election commissioners by the appropriate governing authority not
202 less than sixty (60) days previous to the election.

203 **SECTION 11.** (1) All candidates upon entering the race for
204 election to any municipal office shall, not later than 5:00 p.m.
205 sixty (60) days prior to any municipal general or regular
206 election, file their intent to be a candidate and pay to the
207 secretary of the municipal executive committee of their political
208 party or to the municipal election commission for each election
209 the amount of Ten Dollars (\$10.00).

210 (2) Candidates for municipal office shall file their intent
211 to be a candidate with the secretary of the municipal executive
212 committee of the political party with which the candidate is
213 affiliated, or with the secretary of the municipal election
214 commission if not affiliated with a political party.

215 (3) Such election shall be held on the date provided for in
216 Section 23-15-173, Mississippi Code of 1972; and in the event a
217 preferential election shall be necessary, such preferential
218 election shall be held three (3) weeks prior thereto. At such
219 election, or elections, the municipal election commissioners shall



220 perform the same duties as are specified by law and performed by
221 the county election commissioners with regard to state and county
222 general and preferential elections. Except as otherwise provided
223 by law, all municipal elections shall be held and conducted as is
224 provided by law for state and county elections.

225 (4) Provided, however, that in municipalities operating
226 under a special or private charter which fixes a time for holding
227 elections other than the time fixed herein, the preferential
228 election shall be three (3) weeks prior to the general election as
229 fixed by the charter.

230 (5) No person shall be denied a place upon the ballot for
231 any office for which he desires to be a candidate because of his
232 inability to pay the assessment above set out.

233 (6) Not later than fifty-five (55) days prior to the general
234 election, the respective municipal executive committees shall
235 certify to the municipal election commission all candidates who
236 have filed, within the time prescribed herein, with such executive
237 committees their intent to be a candidate.

238 **SECTION 12.** Sections 1 through 11 of this act shall apply to
239 all elections to public office except elections for judicial
240 office as defined in Section 23-15-975, Mississippi Code of 1972,
241 and special elections.

242 **SECTION 13.** Nothing in Sections 1 through 11 of this act
243 shall prohibit special elections to fill vacancies in either house
244 of the Legislature from being held as provided in Section
245 23-5-201, Mississippi Code of 1972. In all elections conducted
246 under the provisions of Section 23-15-851, Mississippi Code of
247 1972, the commissioners shall have printed on the ballot the name
248 of any candidate who shall have been requested to be a candidate
249 for the office by a petition filed with said commissioners not
250 less than ten (10) working days prior to the election and signed
251 by not less than fifty (50) qualified electors.



252 **SECTION 14.** The state executive committee of any political
253 party is hereby authorized to make and promulgate reasonable rules
254 and regulations for the affairs of said political party and may
255 authorize the county executive committee of said party to have a
256 new registration of the members of that party, if the county
257 executive committee thinks it is for the best welfare of the party
258 to do so.

259 **SECTION 15.** It shall be the duty of the state executive
260 committee of each political party to furnish to the election
261 commissioners of each county the names of all state and state
262 district candidates who have qualified as provided in Sections 8
263 and 9 of this act.

264 **SECTION 16.** The chairmen of the state and county election
265 commissioners, respectively, shall transmit to the Secretary of
266 State a tabulated statement of the vote cast in each county in
267 each state and district election, which statement shall be filed
268 by the Secretary of State and preserved among the records of his
269 office.

270 **SECTION 17.** Candidates for the Office of Public Service
271 Commissioner and for State Highway Commissioner and for other
272 officers to be elected from each Supreme Court district, and
273 representatives in Congress and for district attorneys and for
274 other officers to be elected by districts, shall be voted for by
275 all the counties within their respective districts, and all said
276 district candidates except senatorial candidates in districts
277 composed of one (1) county shall be under the supervision and
278 control of the state election commissioners, which commissioners
279 shall discharge, in respect to such state district elections, all
280 the powers and duties imposed upon them in connection with
281 elections of candidates for other state offices.

282 **SECTION 18.** Section 21-7-7, Mississippi Code of 1972, is
283 amended as follows:



284 21-7-7. The governing body of any such municipality shall be
285 a council, known and designated as such, consisting of seven (7)
286 members. One (1) of the members shall be the mayor, having the
287 qualifications as prescribed by Section 21-3-9, who shall have
288 full rights, powers and privileges of other councilmen. The mayor
289 shall be nominated and elected at large; the remaining councilmen
290 shall be nominated and elected one (1) from each ward into which
291 the city shall be divided. However, if the city be divided into
292 less than six (6) wards, the remaining councilmen shall be
293 nominated and elected at large. The councilmen, including the
294 mayor, shall be elected for a term of four (4) years to serve
295 until their successors are elected and qualified in accordance
296 with the provisions of Section 11, House Bill No. _____, 2003
297 Regular Session, said term commencing on the first Monday of
298 January after the municipal election first following the adoption
299 of the form of government as provided by this chapter.

300 The compensation for the members of the council shall, for
301 the first four (4) years of operation, under this chapter, be
302 fixed by the board of mayor and aldermen holding office prior to
303 the change in form of government. Thereafter the amount of
304 compensation for each such member may be increased or decreased by
305 the council, by council action taken prior to the election of
306 members thereof for the ensuing term, such action to become
307 effective with the ensuing terms.

308 **SECTION 19.** Section 21-8-7, Mississippi Code of 1972, is
309 amended as follows:

310 21-8-7. (1) Each municipality operating under the
311 mayor-council form of government shall be governed by an elected
312 council and an elected mayor. Other officers and employees shall
313 be duly appointed pursuant to this chapter, general law or
314 ordinance.

315 (2) Except as otherwise provided in subsection (4) of this
316 section, the mayor and councilmen shall be elected by the voters



317 of the municipality at a general or regular municipal election
318 held on the first Tuesday after the first Monday in June as
319 provided in Section 11, House Bill No. _____, 2003 Regular Session,
320 and shall serve for a term of four (4) years beginning on the
321 first Monday of July next following his election.

322 (3) The terms of the initial mayor and councilmen shall
323 commence at the expiration of the terms of office of the elected
324 officials of the municipality serving at the time of adoption of
325 the mayor-council form.

326 (4) (a) The council shall consist of five (5), seven (7) or
327 nine (9) members. In the event there are five (5) councilmen, the
328 municipality shall be divided into either five (5) or four (4)
329 wards. In the event there are seven (7) councilmen, the
330 municipality shall be divided into either seven (7), six (6) or
331 five (5) wards. In the event there are nine (9) councilmen, the
332 municipality shall be divided into seven (7) or nine (9) wards.
333 If the municipality is divided into fewer wards than it has
334 councilmen, the other councilman or councilmen shall be elected
335 from the municipality at large. The total number of councilmen
336 and the number of councilmen elected from wards shall be
337 established by the petition or petitions presented pursuant to
338 Section 21-8-3. One (1) councilman shall be elected from each
339 ward by the voters of that ward. Councilmen elected to represent
340 wards must be residents of their wards at the time of
341 qualification for election, and any councilman who removes his
342 residence from the municipality or from the ward from which he was
343 elected shall vacate his office. However, any candidate for
344 councilman who is properly qualified as a candidate under
345 applicable law shall be deemed to be qualified as a candidate in
346 whatever ward he resides if his ward has changed after the council
347 has redistricted the municipality as provided in subparagraph
348 (c)(ii) of this subsection (4), and if the wards have been so
349 changed, any person may qualify as a candidate for councilman,



350 using his existing residence or by changing his residence, not
351 less than fifteen (15) days prior to the preferential election or
352 special election, as the case may be, notwithstanding any other
353 residency or qualification requirements to the contrary.

354 (b) The council or board existing at the time of the
355 adoption of the mayor-council form of government shall designate
356 the geographical boundaries of the wards within one hundred twenty
357 (120) days after the election in which the mayor-council form of
358 government is selected. In designating the geographical
359 boundaries of the wards, each ward shall contain, as nearly as
360 possible, the population factor obtained by dividing the
361 municipality's population as shown by the most recent decennial
362 census by the number of wards into which the municipality is to be
363 divided.

364 (c) (i) It shall be the mandatory duty of the council
365 to redistrict the municipality by ordinance, which ordinance may
366 not be vetoed by the mayor, within six (6) months after the
367 official publication by the United States of the population of the
368 municipality as enumerated in each decennial census, and within
369 six (6) months after the effective date of any expansion of
370 municipal boundaries; however, if the publication of the most
371 recent decennial census or effective date of an expansion of the
372 municipal boundaries occurs six (6) months or more prior to the
373 preferential election in a municipality, then the council shall
374 redistrict the municipality by ordinance not less than sixty (60)
375 days prior to such preferential election.

376 (ii) If the publication of the most recent
377 decennial census occurs less than six (6) months prior to the
378 preferential election in a municipality, the election shall be
379 held with regard to currently defined wards; and reapportioned
380 wards based on the census shall not serve as the basis for
381 representation until the next regularly scheduled election in
382 which council members shall be elected.



383 (d) If annexation of additional territory into the
384 municipal corporate limits of the municipality shall occur less
385 than six (6) months prior to the preferential election in a
386 municipality, the council shall, by ordinance adopted within three
387 (3) days of the effective date of such annexation, assign such
388 annexed territory to an adjacent ward or wards so as to maintain
389 as nearly as possible substantial equality of population between
390 wards; any subsequent redistricting of the municipality by
391 ordinance as required by this chapter shall not serve as the basis
392 for representation until the next regularly scheduled election for
393 municipal councilmen.

394 (5) Vacancies occurring in the council shall be filled as
395 provided in Section 23-15-857.

396 (6) The mayor shall maintain an office at the city hall.
397 The councilmen shall not maintain individual offices at the city
398 hall; provided, however, that in municipalities with populations
399 of one hundred ninety thousand (190,000) and above, councilmen may
400 have individual offices in the city hall. Clerical work of
401 councilmen in the performance of the duties of their office shall
402 be performed by municipal employees or at municipal expense, and
403 councilmen shall be reimbursed for the reasonable expenses
404 incurred in the performance of the duties of their office.

405 **SECTION 20.** Section 21-15-1, Mississippi Code of 1972, is
406 amended as follows:

407 21-15-1. All officers elected at the general or regular
408 municipal election provided for in Section 11, House Bill No. _____,
409 2003 Regular Session, shall qualify and enter upon the discharge
410 of their duties on the first Monday of July after such general
411 election, and shall hold their offices for a term of four (4)
412 years and until their successors are duly elected and qualified.

413 **SECTION 21.** Section 23-15-21, Mississippi Code of 1972, is
414 amended as follows:



415 23-15-21. It shall be unlawful for any person who is not a
416 citizen of the United States or the State of Mississippi to
417 register or to vote in any * * * special, preferential or general
418 election in the state.

419 **SECTION 22.** Section 23-15-31, Mississippi Code of 1972, is
420 amended as follows:

421 23-15-31. All of the provisions of this subarticle shall be
422 applicable, insofar as possible, to municipal, preferential,
423 general and special elections; and wherever therein any duty is
424 imposed or any power or authority is conferred upon the county
425 registrar or county election commissioners * * * with reference to
426 a state and county election, such duty shall likewise be imposed
427 and such power and authority shall likewise be conferred upon the
428 municipal registrar or municipal election commission * * * with
429 reference to any municipal election.

430 **SECTION 23.** Section 23-15-129, Mississippi Code of 1972, is
431 amended as follows:

432 23-15-129. The commissioners of election and the registrars
433 of the respective counties are hereby directed to make an
434 administrative division of the pollbook for each county
435 immediately following any reapportionment of the Mississippi
436 Legislature or any realignment of supervisors districts, if
437 necessary. Such an administrative division shall form
438 subprecincts whenever necessary within each voting precinct so
439 that all persons within a subprecinct shall vote on the same
440 candidates for each public office. Separate pollbooks for each
441 subprecinct shall be made. The polling place for all subprecincts
442 within any given voting precinct shall be the same as the polling
443 place for the voting precinct. Additional managers may be
444 appointed for subprecincts in the discretion of the commissioners
445 of election * * *.

446 **SECTION 24.** Section 23-15-153, Mississippi Code of 1972, is
447 amended as follows:



448 23-15-153. (1) At the following times the commissioners of
449 election shall meet at the office of the registrar and carefully
450 revise the registration books and the pollbooks of the several
451 voting precincts, and shall erase from those books the names of
452 all persons erroneously on the books, or who have died, removed or
453 become disqualified as electors from any cause; and shall register
454 the names of all persons who have duly applied to be registered
455 and have been illegally denied registration:

456 (a) On the Tuesday after the second Monday in January
457 1987 and every following year;

458 (b) On the first Tuesday in the month immediately
459 preceding the preferential election for congressmen in the years
460 when congressmen are elected;

461 (c) On the first Monday in the month immediately
462 preceding the preferential election for state, state district,
463 legislative, county and county district offices in the years in
464 which those offices are elected; and

465 (d) On the second Monday of September preceding
466 the * * * regular special election day in years in which a general
467 election is not conducted.

468 Except for the names of those persons who are duly qualified
469 to vote in the election, no name shall be permitted to remain on
470 the registration books and pollbooks; however, no name shall be
471 erased from the registration books or pollbooks based on a change
472 in the residence of an elector except in accordance with
473 procedures provided for by the National Voter Registration Act of
474 1993 that are in effect at the time of such erasure. Except as
475 otherwise provided by Section 23-15-573, no person shall vote at
476 any election whose name is not on the pollbook.

477 (2) Except as provided in subsection (3) of this section,
478 and subject to the following annual limitations, the commissioners
479 of election shall be entitled to receive a per diem in the amount
480 of Seventy Dollars (\$70.00), to be paid from the county general



481 fund, for every day or period of no less than five (5) hours
482 accumulated over two (2) or more days actually employed in the
483 performance of their duties in the conduct of an election or
484 actually employed in the performance of their duties for the
485 necessary time spent in the revision of the registration books and
486 pollbooks as required in subsection (1) of this section:

487 (a) In counties having less than fifteen thousand
488 (15,000) residents according to the latest federal decennial
489 census, not more than fifty (50) days per year, with no more than
490 fifteen (15) additional days allowed for the conduct of each
491 election in excess of one (1) occurring in any calendar year;

492 (b) In counties having fifteen thousand (15,000)
493 residents according to the latest federal decennial census but
494 less than thirty thousand (30,000) residents according to the
495 latest federal decennial census, not more than seventy-five (75)
496 days per year, with no more than twenty-five (25) additional days
497 allowed for the conduct of each election in excess of one (1)
498 occurring in any calendar year;

499 (c) In counties having thirty thousand (30,000)
500 residents according to the latest federal decennial census but
501 less than seventy thousand (70,000) residents according to the
502 latest federal decennial census, not more than one hundred (100)
503 days per year, with no more than thirty-five (35) additional days
504 allowed for the conduct of each election in excess of one (1)
505 occurring in any calendar year;

506 (d) In counties having seventy thousand (70,000)
507 residents according to the latest federal decennial census but
508 less than ninety thousand (90,000) residents according to the
509 latest federal decennial census, not more than one hundred
510 twenty-five (125) days per year, with no more than forty-five (45)
511 additional days allowed for the conduct of each election in excess
512 of one (1) occurring in any calendar year;



513 (e) In counties having ninety thousand (90,000)
514 residents according to the latest federal decennial census but
515 less than one hundred seventy thousand (170,000) residents
516 according to the latest federal decennial census, not more than
517 one hundred fifty (150) days per year, with no more than
518 fifty-five (55) additional days allowed for the conduct of each
519 election in excess of one (1) occurring in any calendar year;

520 (f) In counties having one hundred seventy thousand
521 (170,000) residents according to the latest federal decennial
522 census but less than two hundred thousand (200,000) residents
523 according to the latest federal decennial census, not more than
524 one hundred seventy-five (175) days per year, with no more than
525 sixty-five (65) additional days allowed for the conduct of each
526 election in excess of one (1) occurring in any calendar year;

527 (g) In counties having two hundred thousand (200,000)
528 residents according to the latest federal decennial census but
529 less than two hundred twenty-five thousand (225,000) residents
530 according to the latest federal decennial census, not more than
531 one hundred ninety (190) days per year, with no more than
532 seventy-five (75) additional days allowed for the conduct of each
533 election in excess of one (1) occurring in any calendar year;

534 (h) In counties having two hundred twenty-five thousand
535 (225,000) residents according to the latest federal decennial
536 census but less than two hundred fifty thousand (250,000)
537 residents according to the latest federal decennial census, not
538 more than two hundred fifteen (215) days per year, with no more
539 than eighty-five (85) additional days allowed for the conduct of
540 each election in excess of one (1) occurring in any calendar year;

541 (i) In counties having two hundred fifty thousand
542 (250,000) residents according to the latest federal decennial
543 census but less than two hundred seventy-five thousand (275,000)
544 residents according to the latest federal decennial census, not
545 more than two hundred thirty (230) days per year, with no more



546 than ninety-five (95) additional days allowed for the conduct of
547 each election in excess of one (1) occurring in any calendar year;

548 (j) In counties having two hundred seventy-five
549 thousand (275,000) residents according to the latest federal
550 decennial census or more, not more than two hundred forty (240)
551 days per year, with no more than one hundred five (105) additional
552 days allowed for the conduct of each election in excess of one (1)
553 occurring in any calendar year.

554 (3) The commissioners of election shall be entitled to
555 receive a per diem in the amount of Seventy Dollars (\$70.00), to
556 be paid from the county general fund, not to exceed ten (10) days
557 for every day or period of no less than five (5) hours accumulated
558 over two (2) or more days actually employed in the performance of
559 their duties for the necessary time spent in the revision of the
560 registration books and pollbooks prior to any special election.
561 For purposes of this subsection, the regular special election day
562 shall not be considered a special election. The annual
563 limitations set forth in subsection (2) of this section shall not
564 apply to this subsection.

565 (4) The commissioners of election shall be entitled to
566 receive only one (1) per diem payment for those days when the
567 commissioners of election discharge more than one (1) duty or
568 responsibility on the same day.

569 (5) The county commissioners of election may provide copies
570 of the registration books revised pursuant to this section to the
571 municipal registrar of each municipality located within the
572 county.

573 (6) Every commissioner of election shall sign personally a
574 certification setting forth the number of hours actually worked in
575 the performance of the commissioner's official duties and for
576 which the commissioner seeks compensation. The certification must
577 be on a form as prescribed in this subsection. The commissioner's



578 signature is, as a matter of law, made under the commissioner's
579 oath of office and under penalties of perjury.

580 The certification form shall be as follows:

605 When properly completed and signed, the certification must be
606 filed with the clerk of the county board of supervisors before any
607 payment may be made. The certification will be a public record
608 available for inspection and reproduction immediately upon the
609 oral or written request of any person.



610 Any person may contest the accuracy of the certification in
611 any respect by notifying the chairman of the commission, any
612 member of the board of supervisors or the clerk of the board of
613 supervisors of such contest at any time before or after payment is
614 made. If the contest is made before payment is made, no payment
615 shall be made as to the contested certificate until the contest is
616 finally disposed of. The person filing the contest shall be
617 entitled to a full hearing, and the clerk of the board of
618 supervisors shall issue subpoenas upon request of the contestor
619 compelling the attendance of witnesses and production of documents
620 and things. The contestor shall have the right to appeal de nova
621 to the circuit court of the involved county, which appeal must be
622 perfected within thirty (30) days from a final decision of the
623 commission, the clerk of the board of supervisors or the board of
624 supervisors, as the case may be.

625 Any contestor who successfully contests any certification
626 will be awarded all expenses incident to his contest, together
627 with reasonable attorney's fees, which will be awarded upon
628 petition to the chancery court of the involved county upon final
629 disposition of the contest before the election commission, board
630 of supervisors, clerk of the board of supervisors, or, in case of
631 an appeal, final disposition by the court. The commissioner
632 against whom the contest is decided shall be liable for the
633 payment of the expenses and attorney's fees, and the county shall
634 be jointly and severally liable for same.

635 (7) Notwithstanding the provisions of this section to the
636 contrary, from June 20, 2001, until the conclusion of calendar
637 year 2004, the number of days for which the commissioners of
638 election of a county are entitled to receive compensation shall
639 not be less than the number of days of compensation they were
640 entitled to receive during the 2000 calendar year, excluding those
641 days for which election commissioners were either entitled to or



642 did receive compensation for the conduct of any special elections
643 in calendar year 2000.

644 **SECTION 25.** Section 23-15-173, Mississippi Code of 1972, is
645 amended as follows:

646 23-15-173. * * * A general municipal election shall be held
647 in each city, town or village on the first Tuesday after the first
648 Monday of June 1985, and every four (4) years thereafter, for the
649 election of all municipal officers elected by the people.

650 * * *

651 **SECTION 26.** Section 23-15-197, Mississippi Code of 1972, is
652 amended as follows:

653 23-15-197. (1) Times for holding * * * general elections
654 for congressional offices shall be as prescribed in Sections * * *
655 23-15-1033 and 23-15-1041.

656 (2) Times for holding elections for the office of judge of
657 the Supreme Court shall be as prescribed in Section 23-15-991 and
658 Sections 23-15-974 through 23-15-985.

659 (3) Times for holding elections for the office of circuit
660 court judge and the office of chancery court judge shall be as
661 prescribed in Sections 23-15-974 through 23-15-985, and Section
662 23-15-1015.

663 (4) Times for holding elections for the office of county
664 election commissioners shall be as prescribed in Section
665 23-15-213.

666 **SECTION 27.** Section 23-15-313, Mississippi Code of 1972, is
667 amended as follows:

668 23-15-313. If there be any political party, or parties, in
669 any municipality which shall not have a party executive committee
670 for such municipality, such political party, or parties, shall
671 select temporary executive committees to serve until executive
672 committees shall be regularly elected, said selection to be in the
673 following manner, to-wit: The chairman of the county executive
674 committee of the party desiring to select a municipal executive



675 committee shall, upon petition of five (5) or more members of that
676 political faith, call a mass meeting of the electors of their
677 political faith, residing in the municipality, to meet at some
678 convenient place within said municipality, at a time to be
679 designated in the call, and at such mass convention the members of
680 that political faith shall select an executive committee which
681 shall serve until the next * * * election. The public shall be
682 given notice of such mass meeting as provided in the next
683 succeeding section.

684 **SECTION 28.** Section 23-15-367, Mississippi Code of 1972, is
685 amended as follows:

686 23-15-367. (1) Except as otherwise provided by * * *
687 subsection (2) of this section, * * * the size, print and quality
688 of paper of the official ballot is left to the discretion of the
689 officer charged with printing the official ballot * * *.

690 (2) The titles for the various offices shall be listed in
691 the following order:

- 692 (a) Candidates for national office;
- 693 (b) Candidates for statewide office;
- 694 (c) Candidates for state district office;
- 695 (d) Candidates for legislative office;
- 696 (e) Candidates for countywide office;
- 697 (f) Candidates for county district office.

698 The order in which the titles for the various offices are
699 listed within each of the categories listed in this subsection is
700 left to the discretion of the officer charged with printing the
701 official ballot.

702 (3) It is the duty of the Secretary of State, with the
703 approval of the Governor, to furnish the election commission of
704 each county a sample of the official ballot, not less than fifty
705 (50) days prior to the election, the general form of which shall
706 be followed as nearly as practicable.



707 **SECTION 29.** Section 23-15-375, Mississippi Code of 1972, is
708 amended as follows:

709 23-15-375. Local issue elections may be held on the same
710 date as any regular or general election. A local issue election
711 held on the same date as the regular or general election shall be
712 conducted in the same manner as the regular or general election
713 using the same poll workers and the same equipment. A local issue
714 may be placed on the regular or general election ballot pursuant
715 to the provisions of Section 10 of House Bill No. _____, 2003
716 Regular Session. The provisions of this section and Section 10 of
717 House Bill No. _____, 2003 Regular Session, with regard to local
718 issue elections shall not be construed to affect any statutory
719 requirements specifying the notice procedure and the necessary
720 percentage of qualified electors voting in such an election which
721 is needed for adoption of the local issue. Whether or not a local
722 issue is adopted or defeated at a local issue election held on the
723 same day as a regular or general election shall be determined in
724 accordance with relevant statutory requirements regarding the
725 necessary percentage of qualified electors who voted in such local
726 issue election, and only those persons voting for or against such
727 issue shall be counted in making that determination. As used in
728 this section "local issue elections" include elections regarding
729 the issuance of bonds, local option elections, elections regarding
730 the levy of additional ad valorem taxes and other similar
731 elections authorized by law that are called to consider issues
732 that affect a single local governmental entity. As used in this
733 section "local issue" means any issue that may be voted on in a
734 local issue election.

735 **SECTION 30.** Section 23-15-403, Mississippi Code of 1972, is
736 amended as follows:

737 23-15-403. The board of supervisors of any county in the
738 State of Mississippi and the governing authorities of any
739 municipality in the State of Mississippi are hereby authorized and



740 empowered, in their discretion, to purchase or rent any voting
741 machine or machines which shall be so constructed as to fulfill
742 the following requirements: It shall secure to the voter secrecy
743 in the act of voting; it shall provide facilities for voting for
744 all candidates of as many political parties or organizations as
745 may make nominations, and for or against as many questions as
746 submitted; it shall * * * permit the voter to vote for * * * as
747 many persons for an office as he is lawfully entitled to vote for,
748 but not more; it shall prevent the voter from voting for the same
749 person more than once for the same office; it shall permit the
750 voter to vote for or against any question he may have the right to
751 vote on, but no other; * * * it shall correctly register or record
752 and accurately count all votes cast for any and all persons and
753 for or against any and all questions; it shall be provided with a
754 "protective counter" or "protective device" whereby any operation
755 of the machine before or after the election will be detected; it
756 shall be provided with a counter which shall show at all times
757 during an election how many persons have voted; it shall be
758 provided with a mechanical model, illustrating the manner of
759 voting on the machine, suitable for the instruction of voters; it
760 may also be provided with one (1) device for each party for voting
761 for all the presidential electors of that party by one (1)
762 operation, and a ballot therefor containing only the words
763 "Presidential Electors For" preceded by the name of that party and
764 followed by the names of the candidates thereof for the offices of
765 President and Vice President, and a registering device therefor
766 which shall register the vote cast for said electors when thus
767 voted collectively; provided, however, that means shall be
768 furnished whereby the voter can cast a vote for individual
769 electors when permitted to do so by law.

770 **SECTION 31.** Section 23-15-411, Mississippi Code of 1972, is
771 amended as follows:



772 23-15-411. The officer who furnishes the official ballots
773 for any polling place where a voting machine is to be used shall
774 also provide two (2) sample ballots or instruction ballots, which
775 sample or instruction ballots shall be arranged in the form of a
776 diagram showing such portion of the front of the voting machine as
777 it will appear after the official ballots are arranged thereon or
778 therein for voting on election day. Such sample ballots shall be
779 open to the inspection of all voters on election day in all
780 preferential and general or regular elections where voting
781 machines are used.

782 **SECTION 32.** Section 23-15-463, Mississippi Code of 1972, is
783 amended as follows:

784 23-15-463. The board of supervisors of any county in the
785 State of Mississippi and the governing authorities of any
786 municipality in the State of Mississippi are hereby authorized and
787 empowered, in their discretion, to purchase or rent voting devices
788 and automatic tabulating equipment used in an electronic voting
789 system which meets the requirements of Section 23-15-465, and may
790 use such system in all or a part of the precincts within its
791 boundaries or in combination with paper ballots in any
792 election * * *. It may enlarge, consolidate or alter the
793 boundaries of precincts where an electronic voting system is used.
794 The provisions of Sections 23-15-461 through 23-15-485 shall be
795 controlling with respect to elections where an electronic voting
796 system is used, and shall be liberally construed so as to carry
797 out the purpose of this chapter. The provisions of the election
798 law relating to the conduct of elections with paper ballots,
799 insofar as they are applicable and not inconsistent with the
800 efficient conduct of elections with electronic voting systems,
801 shall apply. Absentee ballots shall be voted as now provided by
802 law.

803 **SECTION 33.** Section 23-15-465, Mississippi Code of 1972, is
804 amended as follows:



805 23-15-465. No electronic voting system consisting of a
806 marking or voting device in combination with automatic tabulating
807 equipment shall be acquired or used in accordance with Sections
808 23-15-461 through 23-15-485 unless it shall:

809 (a) Provide for voting in secrecy when used with voting
810 booths;

811 (b) Permit each voter to vote at any election for all
812 persons and offices for whom and for which he is lawfully entitled
813 to vote; to vote for as many persons for an office as he is
814 entitled to vote for; to vote for or against any question upon
815 which he is entitled to vote; and the automatic tabulating
816 equipment shall reject choices recorded on his ballot card or
817 paper ballot if the number of choices exceeds the number which he
818 is entitled to vote for the office or on the measure;

819 (c) Permit each voter at presidential elections by one
820 (1) mark or punch to vote for the candidates of that party for
821 President, Vice President and their presidential electors, or to
822 vote individually for the electors of his choice when permitted by
823 law;

824 (d) Permit each voter * * * to vote for the candidates
825 of one or more parties and for independent candidates;

826 * * *

827 (e) Permit each voter to vote for persons whose names
828 are not on the printed ballot or ballot labels;

829 (f) Prevent the voter from voting for the same person
830 more than once for the same office;

831 (g) Be suitably designed for the purpose used, of
832 durable construction, and may be used safely, efficiently and
833 accurately in the conduct of elections and counting ballots;

834 (h) Be provided with means for sealing the voting or
835 marking device against any further voting after the close of the
836 polls and the last voter has voted;



837 (i) When properly operated, record correctly and count
838 accurately every vote cast;

839 (j) Be provided with a mechanical model for instructing
840 voters, and be so constructed that a voter may readily learn the
841 method of operating it;

842 (k) Be safely transportable, and include a light to
843 enable voters to read the ballot labels and instructions.

844 **SECTION 34.** Section 23-15-507, Mississippi Code of 1972, is
845 amended as follows:

846 23-15-507. No optical mark reading system shall be acquired
847 or used in accordance with this chapter unless it shall:

848 (a) Permit each voter to vote at any election for all
849 persons and no others for whom and for which they are lawfully
850 entitled to vote; to vote for as many persons for an office as
851 they are entitled to vote for; to vote for or against any
852 questions upon which they are entitled to vote;

853 (b) The OMR tabulating equipment shall be capable of
854 rejecting choices recorded on the ballot if the number of choices
855 exceeds the number which the voter is entitled to vote for the
856 office or on the measure;

857 (c) Permit each voter at presidential elections by one
858 (1) mark to vote for the candidates of that party for President,
859 Vice President and their presidential electors, or to vote
860 individually for the electors of their choice when permitted by
861 law;

862 (d) Permit each voter * * * to vote for the candidates
863 of one or more parties and for independent candidates;

864 * * *

865 (e) Permit each voter to vote for persons whose names
866 are not on the printed ballot;

867 (f) Be suitably designed for the purpose used, of
868 durable construction, and may be used safely, efficiently and



869 accurately in the conduct of elections and the counting of
870 ballots;

871 (g) Be provided with means for sealing the ballots
872 after the close of the polls and the last voter has voted;

873 (h) When properly operated, record correctly and count
874 accurately all votes cast; and

875 (i) Provide the voter with a set of instructions that
876 will be so displayed that a voter may readily learn the method of
877 voting.

878 **SECTION 35.** Section 23-15-511, Mississippi Code of 1972, is
879 amended as follows:

880 23-15-511. The ballots shall, as far as practicable, be in
881 the same order of arrangement as provided for paper ballots that
882 are to be counted manually, except that such information may be
883 printed in vertical or horizontal rows. Nothing in this chapter
884 shall be construed as prohibiting the information being presented
885 to the voters from being printed on both sides of a single ballot.
886 In those years when a special election shall occur on the same day
887 as the general election, the names of candidates in any special
888 election and the general election shall be placed on the same
889 ballot by the commissioners of elections or officials in charge of
890 the election, but the general election candidates shall be clearly
891 distinguished from the special election candidates * * *.

892 Ballots shall be printed in plain clear type in black ink and
893 upon clear white materials of such size and arrangement as to be
894 compatible with the OMR tabulating equipment. Absentee ballots
895 shall be prepared and printed in the same form and shall be on the
896 same size and texture as the regular official ballots, except that
897 they shall be printed on tinted paper; or the ink used to print
898 the ballots shall be of a color different from that of the ink
899 used to print the regular official ballots. Arrows may be printed
900 on the ballot to indicate the place to mark the ballot, which may
901 be to the right or left of the names of candidates and



902 propositions. The titles of offices may be arranged in vertical
903 columns on the ballot and shall be printed above or at the side of
904 the names of candidates so as to indicate clearly the candidates
905 for each office and the number to be elected. In case there are
906 more candidates for an office than can be printed in one (1)
907 column, the ballot shall be clearly marked that the list of
908 candidates is continued on the following column. The names of
909 candidates for each office shall be printed in vertical columns,
910 grouped by the offices which they seek. * * * The party
911 designation, if any, of each candidate * * * shall be printed
912 following his name, as provided for in Section 10, House Bill No.
913 , 2003 Regular Session.

914 Two (2) sample ballots, which shall be facsimile ballots of
915 the official ballot and instructions to the voters, shall be
916 provided for each precinct and shall be posted in each polling
917 place on election day.

918 A separate ballot security envelope or suitable equivalent in
919 which the voter can place his ballot after voting shall be
920 provided to conceal the choices the voter has made. Absentee
921 voters will receive a similar ballot security envelope provided by
922 the county in which the absentee voter will insert their voted
923 ballot, which then can be inserted into a return envelope to be
924 mailed back to the election official. Absentee ballots will not
925 be required to be folded when a ballot security envelope is
926 provided.

927 **SECTION 36.** Section 23-15-559, Mississippi Code of 1972, is
928 amended as follows:

929 23-15-559. The provisions of Section * * * 23-15-173 fixing
930 the time for the holding of * * * general elections shall not
931 apply to any municipality operating under a special or private
932 charter where the governing board or authority thereof, on or
933 before June 25, 1952, shall have adopted and spread upon its
934 minutes a resolution or ordinance declining to accept such



935 provisions, in which event * * * general elections shall be held
936 at the time fixed by the charter of such municipality.

937 The provisions of Section 23-15-859 shall be applicable to
938 all municipalities of this state, whether operating under a code
939 charter, special charter or the commission form of government,
940 except in cases of conflicts between the provisions of such
941 section and the provisions of the special charter of a
942 municipality or the law governing the commission form of
943 government, in which cases of conflict the provisions of the
944 special charter or the statutes relative to the commission form of
945 government shall apply.

946 **SECTION 37.** Section 23-15-561, Mississippi Code of 1972, is
947 amended as follows:

948 23-15-561. (1) It shall be unlawful during any * * *
949 election for any candidate for any elective office or any
950 representative of such candidate or any other person to publicly
951 or privately put up or in any way offer any prize, cash award or
952 other item of value to be raffled, drawn for, played for or
953 contested for in order to encourage persons to vote or to refrain
954 from voting in any election.

955 (2) Any person who shall violate the provisions of
956 subsection (1) of this section shall, upon conviction thereof, be
957 punished by a fine in an amount not to exceed Five Thousand
958 Dollars (\$5,000.00).

959 (3) Any candidate who shall violate the provisions of
960 subsection (1) of this section shall, upon conviction thereof, in
961 addition to the fine prescribed above, be punished by:

962 (a) Disqualification as a candidate in the race for the
963 elective office; or

964 (b) Removal from the elective office, if the offender
965 has been elected thereto.

966 **SECTION 38.** Section 23-15-573, Mississippi Code of 1972, is
967 amended as follows:



968 23-15-573. Any person whose name does not appear upon the
969 pollbooks shall be permitted to vote in an election; but if any
970 person offering to vote in any election whose name does not appear
971 upon the pollbook shall make affidavit before one (1) of the
972 managers of election in writing that he is entitled to vote, or
973 that he has been illegally denied registration, his vote may be
974 prepared by him and handed to the proper election officer who
975 shall enclose the same in an envelope with the written affidavit
976 of the voter, seal the envelope and mark plainly upon it the name
977 of the person offering to vote. The affidavit must include the
978 complete name, all required addresses and telephone numbers, and
979 the signature of the affiant, and must include the signature of
980 one (1) of the election managers. A separate register shall be
981 maintained for affidavit ballots, and the affiant shall sign the
982 register upon completing an affidavit under this section. In
983 canvassing the returns of the election, * * * the election
984 commissioners, * * * shall examine the records and allow the
985 ballot to be counted, or not counted, as it appears to be legal.

1033 **SECTION 39.** Section 23-15-593, Mississippi Code of 1972, is
1034 amended as follows:

1035 23-15-593. When the ballot box is opened and examined by
1036 the * * * county election commissioners * * * and it is found that
1037 there have been failures in material particulars to comply with
1038 the requirements of Section 23-15-591 and Section 23-15-895 to
1039 such an extent that it is impossible to arrive at the will of the
1040 voters at such precinct, the entire box may be thrown out unless
1041 it be made to appear with reasonable certainty that the
1042 irregularities were not deliberately permitted or engaged in by
1043 the managers at that box, or by one (1) of them responsible for
1044 the wrong or wrongs, for the purpose of electing or defeating a
1045 certain candidate or candidates by manipulating the election or
1046 the returns thereof at that box in such manner as to have it
1047 thrown out; in which latter case * * * the county election
1048 commission * * * shall conduct such hearing and make such
1049 determination in respect to said box as may appear lawfully just,
1050 subject to a judicial review of said matter as elsewhere provided
1051 by this chapter. Or the * * * election commission, or the court
1052 upon review, may order another election to be held at that box
1053 appointing new managers to hold the same.

1054 **SECTION 40.** Section 23-15-595, Mississippi Code of 1972, is
1055 amended as follows:

1056 23-15-595. The box containing the ballots and other records
1057 required by this chapter shall, as soon as practical after the
1058 ballots have been counted, be delivered by one (1) of the precinct
1059 managers to the clerk of the circuit court of the county and said
1060 clerk shall, in the presence of the manager making delivery of the
1061 box, place upon the lock of such box a metal seal similar to the
1062 seal commonly used in sealing the doors of railroad freight cars.
1063 Such seals shall be numbered consecutively to the number of ballot
1064 boxes used in the election in the county, and the clerk shall keep
1065 in a place separate from such boxes a record of the number of the



1066 seal of each separate box in the county. The board of supervisors
1067 of the county shall pay the cost of providing such seals. Upon
1068 demand of a county election commissioner the boxes and their
1069 contents shall be delivered to the county election commission, and
1070 after such commission has finished the work of tabulating returns
1071 and counting ballots as required by law the said commission shall
1072 return all papers and ballots to the box of the precinct where
1073 such election was held, and it shall make redelivery of such boxes
1074 and their contents to the circuit clerk who shall reseal said
1075 boxes. Upon every occasion said boxes shall be reopened and each
1076 resealing shall be done as provided in this chapter.

1077 **SECTION 41.** Section 23-15-601, Mississippi Code of 1972, is
1078 amended as follows:

1079 23-15-601. (1) When the result of the election shall have
1080 been ascertained by the managers they, or one (1) of their number,
1081 or some fit person designated by them, shall, by noon of the * * *
1082 day following the election, deliver to the commissioners of
1083 election, at the courthouse, a statement of the whole number of
1084 votes given for each person and for what office; and the
1085 commissioners of election shall on the first or second day after
1086 the preferential election and after the general election, canvass
1087 the returns, ascertain and declare the result, and announce the
1088 names of the candidates who have received a majority of the votes
1089 cast for representative in the Legislature of districts composed
1090 of one (1) county or less, or other county office, board of
1091 supervisors, justice court judge and constable, and shall also
1092 announce the names of those candidates for the above mentioned
1093 offices that are to be submitted to the general election.

1094 The vote for state and state district offices shall be
1095 tabulated by precincts and certified to and returned to the state
1096 election commissioners, such returns to be mailed by registered
1097 letter or any safe mode of transportation within thirty-six (36)
1098 hours after the returns are canvassed and the results ascertained.



1099 The state election commissioners shall meet a week from the day
1100 following the preferential election held for state and district
1101 offices, and shall proceed to canvass the returns and to declare
1102 the results and announce the names of the candidates for the
1103 different offices who have received a majority of the votes cast
1104 and the names of those candidates whose names are to be submitted
1105 to the general election. The state election commissioners shall
1106 also meet a week from the day on which the general election is
1107 held and receive and canvass the returns for state and district
1108 offices voted on in such general election. An exact and full
1109 duplicate of all tabulations by precincts, as certified under this
1110 section, shall be filed with the circuit clerk of the county who
1111 shall safely preserve the same in his office.

1112 (2) The commissioners of election shall transmit to the
1113 Secretary of State, on such forms and by such methods as may be
1114 required by rules and regulations promulgated by the Secretary of
1115 State, a statement of the total number of votes cast in the county
1116 for each candidate for each office and the total number of votes
1117 cast for such candidates in each precinct in the district in which
1118 the candidate ran.

1119 **SECTION 42.** Section 23-15-605, Mississippi Code of 1972, is
1120 amended as follows:

1121 23-15-605. The Secretary of State, immediately after
1122 receiving the returns of a general election, not longer than
1123 thirty (30) days after the election, shall sum up the whole number
1124 of votes given for each candidate other than for state offices,
1125 ascertain the person or persons having the largest number of votes
1126 for each office, and declare such person or persons to be duly
1127 elected; and thereupon all persons chosen to any office at the
1128 election shall be commissioned by the Governor; but if it appears
1129 that two (2) or more candidates for any district office where the
1130 district is composed of two (2) or more counties, standing highest
1131 on the list and not elected, have an equal number of votes, the



1132 election shall be forthwith decided between the candidates having
1133 an equal number of votes by lot, fairly and publicly drawn, under
1134 the direction of the Governor and Secretary of State.

1135 **SECTION 43.** Section 23-15-673, Mississippi Code of 1972, is
1136 amended as follows:

1137 23-15-673. (1) For the purposes of this subarticle, the
1138 term "absent voter" shall mean and include the following:

1139 (a) Any enlisted or commissioned members, male or
1140 female, of the United States Army, or any of its respective
1141 components or various divisions thereof; any enlisted or
1142 commissioned members, male or female, of the United States Navy,
1143 or any of its respective components or various divisions thereof;
1144 any enlisted or commissioned members, male or female, of the
1145 United States Air Force, or any of its respective components or
1146 various divisions thereof; any enlisted or commissioned members,
1147 male or female, of the United States Marines, or any of its
1148 respective components or various divisions thereof; or any persons
1149 in any division of the armed services of the United States, who
1150 are citizens of Mississippi;

1151 (b) Any member of the Merchant Marine and the American
1152 Red Cross who is a citizen of Mississippi;

1153 (c) Any disabled war veteran who is a patient in any
1154 hospital and who is a citizen of Mississippi;

1155 (d) Any civilian attached to and serving outside of the
1156 United States with any branch of the Armed Forces or with the
1157 Merchant Marine or American Red Cross, and who is a citizen of
1158 Mississippi;

1159 (e) Any citizen of Mississippi temporarily residing
1160 outside the territorial limits of the United States and the
1161 District of Columbia;

1162 (f) Any citizen of Mississippi enrolled as a student at
1163 a United States Military Academy.



1164 (2) The spouse and dependents of any absent voter as set out
1165 in paragraphs (a), (b), (c) and (d) of subsection (1) of this
1166 section shall also be included in the meaning of absent voter and
1167 may vote an absentee ballot as provided in this subarticle if also
1168 absent from the county of their residence on the date of the
1169 election and otherwise qualified to vote in Mississippi.

1170 (3) For the purpose of this subarticle, the term "election"
1171 shall mean and include the following sets of elections: special
1172 and runoff special elections, preferential and general
1173 elections, * * * or general elections without preferential
1174 elections, whichever * * * is applicable.

1175 **SECTION 44.** Section 23-15-713, Mississippi Code of 1972, is
1176 amended as follows:

1177 23-15-713. For the purpose of this subarticle, any duly
1178 qualified elector may vote as provided in this subarticle if
1179 he * * * falls within the following categories:

1180 (a) Any qualified elector who is a bona fide student,
1181 teacher or administrator at any college, university, junior
1182 college, high, junior high, or elementary grade school whose
1183 studies or employment at such institution necessitates his absence
1184 from the county of his voting residence on the date of any * * *
1185 election, or the spouse and dependents of said student, teacher or
1186 administrator if such spouse or dependent(s) maintain a common
1187 domicile, outside of the county of his voting residence, with such
1188 student, teacher or administrator.

1189 (b) Any qualified elector who is required to be away
1190 from his place of residence on any election day due to his
1191 employment as an employee of a member of the Mississippi
1192 congressional delegation and the spouse and dependents of such
1193 person if he or she shall be residing with such absentee voter
1194 away from the county of the spouse's voting residence.

1195 (c) Any qualified elector who is away from his county
1196 of residence on election day for any reason.



1197 (d) Any person who has a temporary or permanent
1198 physical disability and who, because of such disability, is unable
1199 to vote in person without substantial hardship to himself or
1200 others, or whose attendance at the voting place could reasonably
1201 cause danger to himself or others.

1202 (e) The parent, spouse or dependent of a person with a
1203 temporary or permanent physical disability who is hospitalized
1204 outside of his county of residence or more than fifty (50) miles
1205 distant from his residence, if the parent, spouse or dependent
1206 will be with such person on election day.

1207 (f) Any person who is sixty-five (65) years of age or
1208 older.

1209 (g) Any member of the Mississippi congressional
1210 delegation absent from Mississippi on election day, and the spouse
1211 and dependents of such member of the congressional delegation.

1212 (h) Any qualified elector who will be unable to vote in
1213 person because he is required to be at work on election day during
1214 the times at which the polls will be open.

1215 **SECTION 45.** Section 23-15-755, Mississippi Code of 1972, is
1216 amended as follows:

1217 23-15-755. All of the provisions of Sections 23-15-621
1218 through 23-15-735 shall be applicable, insofar as possible, to
1219 municipal, * * * preferential, general and special elections, and
1220 wherever herein any duty is imposed or any power or authority is
1221 conferred upon the county registrar or county election
1222 commissioners, * * * with reference to a state and county
1223 election, such duty shall likewise be imposed and such power and
1224 authority shall likewise be conferred upon the municipal registrar
1225 or municipal election commission * * * with reference to any
1226 municipal election. * * *

1227 **SECTION 46.** Section 23-15-771, Mississippi Code of 1972, is
1228 amended as follows:



1229 23-15-771. At the state convention, a slate of electors
1230 composed of the number of electors allotted to this state, which
1231 said electors announce a clearly expressed design and purpose to
1232 support the candidates for President and Vice President of the
1233 national political party with which the said party of this state
1234 has had an affiliation and identity of purpose heretofore, shall
1235 be designated and selected for a place upon the * * * election
1236 ballot to be held as herein provided.

1237 **SECTION 47.** Section 23-15-801, Mississippi Code of 1972, is
1238 amended as follows:

1239 23-15-801. (a) "Election" shall mean a preferential,
1240 general or special * * * election.

1241 (b) "Candidate" shall mean an individual who seeks * * *
1242 election to any elective office other than a federal elective
1243 office. For purposes of this article, an individual shall be
1244 deemed to seek * * * election:

1245 (i) If such individual has received contributions
1246 aggregating in excess of Two Hundred Dollars (\$200.00) or has made
1247 expenditures aggregating in excess of Two Hundred Dollars
1248 (\$200.00) or for a candidate for the Legislature or any statewide
1249 or state district office, by the qualifying deadlines specified in
1250 Sections 23-15-299 and 23-15-977, whichever occurs first; or

1251 (ii) If such individual has given his or her consent to
1252 another person to receive contributions or make expenditures on
1253 behalf of such individual and if such person has received such
1254 contributions aggregating in excess of Two Hundred Dollars
1255 (\$200.00) during a calendar year, or has made such expenditures
1256 aggregating in excess of Two Hundred Dollars (\$200.00) during a
1257 calendar year.

1258 (c) "Political committee" shall mean any committee, party,
1259 club, association, political action committee, campaign committee
1260 or other groups of persons or affiliated organizations which
1261 receives contributions aggregating in excess of Two Hundred



1262 Dollars (\$200.00) during a calendar year or which makes
1263 expenditures aggregating in excess of Two Hundred Dollars
1264 (\$200.00) during a calendar year for the purpose of influencing or
1265 attempting to influence the action of voters for or against
1266 the * * * election of one or more candidates, or balloted measures
1267 and shall, in addition, include each political party registered
1268 with the Secretary of State.

1269 (d) "Affiliated organization" shall mean any organization
1270 which is not a political committee, but which directly or
1271 indirectly establishes, administers or financially supports a
1272 political committee.

1273 (e) (i) "Contribution" shall include any gift,
1274 subscription, loan, advance or deposit of money or anything of
1275 value made by any person or political committee for the purpose of
1276 influencing any election for elective office or balloted measure;

1277 (ii) "Contribution" shall not include the value of
1278 services provided without compensation by any individual who
1279 volunteers on behalf of a candidate or political committee; or the
1280 cost of any food or beverage for use in any candidate's campaign
1281 or for use by or on behalf of any political committee of a
1282 political party;

1283 (iii) "Contribution to a political party" includes any
1284 gift, subscription, loan, advance or deposit of money or anything
1285 of value made by any person, political committee, or other
1286 organization to a political party and to any committee,
1287 subcommittee, campaign committee, political committee and other
1288 groups of persons and affiliated organizations of the political
1289 party.

1290 (iv) "Contribution to a political party" shall not
1291 include the value of services provided without compensation by any
1292 individual who volunteers on behalf of a political party or a
1293 candidate of a political party.



1294 (f) (i) "Expenditure" shall include any purchase, payment,
1295 distribution, loan, advance, deposit, gift of money or anything of
1296 value, made by any person or political committee for the purpose
1297 of influencing any balloted measure or election for elective
1298 office; and a written contract, promise, or agreement to make an
1299 expenditure;

1300 (ii) "Expenditure" shall not include any news story,
1301 commentary or editorial distributed through the facilities of any
1302 broadcasting station, newspaper, magazine, or other periodical
1303 publication, unless such facilities are owned or controlled by any
1304 political party, political committee, or candidate; or nonpartisan
1305 activity designed to encourage individuals to vote or to register
1306 to vote;

1307 (iii) "Expenditure by a political party" includes 1.
1308 any purchase, payment, distribution, loan, advance, deposit, gift
1309 of money or anything of value, made by any political party and by
1310 any contractor, subcontractor, agent, and consultant to the
1311 political party; and 2. a written contract, promise, or agreement
1312 to make such an expenditure.

1313 (g) The term "identification" shall mean:

1314 (i) In the case of any individual, the name, the
1315 mailing address, and the occupation of such individual, as well as
1316 the name of his or her employer; and

1317 (ii) In the case of any other person, the full name and
1318 address of such person.

1319 (h) The term "political party" shall mean an association,
1320 committee or organization which nominates a candidate for election
1321 to any elective office whose name appears on the election ballot
1322 as the candidate of such association, committee or organization.

1323 (i) The term "person" shall mean any individual, family,
1324 firm, corporation, partnership, association or other legal entity.

1325 (j) The term "independent expenditure" shall mean an
1326 expenditure by a person expressly advocating the election or



1327 defeat of a clearly identified candidate which is made without
1328 cooperation or consultation with any candidate or any authorized
1329 committee or agent of such candidate, and which is not made in
1330 concert with or at the request or suggestion of any candidate or
1331 any authorized committee or agent of such candidate.

1332 (k) The term "clearly identified" shall mean that:

1333 (i) The name of the candidate involved appears; or

1334 (ii) A photograph or drawing of the candidate appears;

1335 or

1336 (iii) The identity of the candidate is apparent by

1337 unambiguous reference.

1338 **SECTION 48.** Section 23-15-807, Mississippi Code of 1972, is
1339 amended as follows:

1340 23-15-807. (a) Each candidate or political committee shall
1341 file reports of contributions and disbursements in accordance with
1342 the provisions of this section. All candidates or political
1343 committees required to report may terminate its obligation to
1344 report only upon submitting a final report that it will no longer
1345 receive any contributions or make any disbursement and that such
1346 candidate or committee has no outstanding debts or obligations.
1347 The candidate, treasurer or chief executive officer shall sign
1348 each such report.

1349 (b) Candidates who are seeking election * * * and political
1350 committees that make expenditures for the purpose of influencing
1351 or attempting to influence the action of voters for or against
1352 the * * * election of one or more candidates or balloted measures
1353 at such election, shall file the following reports:

1354 (i) In any calendar year during which there is a
1355 regularly scheduled election, a preelection report, which shall be
1356 filed no later than the seventh day before any election in which
1357 such candidate or political committee has accepted contributions
1358 or made expenditures and which shall be complete as of the tenth
1359 day before such election;



1360 (ii) In 1987 and every fourth year thereafter, periodic
1361 reports, which shall be filed no later than the tenth day after
1362 April 30, May 31, June 30, September 30 and December 31, and which
1363 shall be complete as of the last day of each period; and

1364 (iii) In any calendar years except 1987 and except
1365 every fourth year thereafter, a report covering the calendar year
1366 which shall be filed no later than January 31 of the following
1367 calendar year.

1368 (c) All candidates for judicial office as defined in Section
1369 23-15-975, or their political committees, shall file in the year
1370 in which they are to be elected, periodic reports which shall be
1371 filed no later than the tenth day after April 30, May 31, June 30,
1372 September 30 and December 31.

1373 (d) Contents of reports. Each report under this article
1374 shall disclose:

1375 (i) For the reporting period and the calendar year, the
1376 total amount of all contributions and the total amount of all
1377 expenditures of the candidate or reporting committee which shall
1378 include those required to be identified pursuant to item (ii) of
1379 this paragraph as well as the total of all other contributions and
1380 expenditures during the calendar year. Such reports shall be
1381 cumulative during the calendar year to which they relate;

1382 (ii) The identification of:

1383 1. Each person or political committee who makes a
1384 contribution to the reporting candidate or political committee
1385 during the reporting period, whose contribution or contributions
1386 within the calendar year have an aggregate amount or value in
1387 excess of Two Hundred Dollars (\$200.00) when made to a political
1388 committee or to a candidate for an office other than statewide
1389 office or office elected by Supreme Court district, or in excess
1390 of Five Hundred Dollars (\$500.00) when made to a candidate for
1391 statewide office or office elected by Supreme Court district,
1392 together with the date and amount of any such contribution;



1393 2. Each person or organization, candidate or
1394 political committee who receives an expenditure, payment or other
1395 transfer from the reporting candidate, political committee or its
1396 agent, employee, designee, contractor, consultant or other person
1397 or persons acting in its behalf during the reporting period when
1398 the expenditure, payment or other transfer to such person,
1399 organization, candidate or political committee within the calendar
1400 year have an aggregate value or amount in excess of Two Hundred
1401 Dollars (\$200.00) when received from a political committee or
1402 candidate for an office other than statewide office or office
1403 elected by Supreme Court district, or in excess of Five Hundred
1404 Dollars (\$500.00) when received from a candidate for statewide
1405 office or office elected by the Supreme Court district, together
1406 with the date and amount of such expenditure;

1407 (iii) The total amount of cash on hand of each
1408 reporting candidate and reporting political committee;

1409 (iv) In addition to the contents of reports specified
1410 in items (i), (ii) and (iii) of this paragraph, each political
1411 party shall disclose:

1412 1. Each person or political committee who makes a
1413 contribution to a political party during the reporting period and
1414 whose contribution or contributions to a political party within
1415 the calendar year have an aggregate amount or value in excess of
1416 Two Hundred Dollars (\$200.00), together with the date and amount
1417 of the contribution;

1418 2. Each person or organization who receives an
1419 expenditure by a political party or expenditures by a political
1420 party during the reporting period when the expenditure or
1421 expenditures to the person or organization within the calendar
1422 year have an aggregate value or amount in excess of Two Hundred
1423 Dollars (\$200.00), together with the date and amount of the
1424 expenditure.



1425 (e) The appropriate office specified in Section 23-15-805
1426 must be in actual receipt of the reports specified in this article
1427 by 5:00 p.m. on the dates specified in paragraph (b) of this
1428 section. If the date specified in paragraph (b) of this section
1429 shall fall on a weekend or legal holiday then the report shall be
1430 due in the appropriate office at 5:00 p.m. on the first working
1431 day before the date specified in paragraph (b) of this section.
1432 The reporting candidate or reporting political committee shall
1433 ensure that the reports are delivered to the appropriate office by
1434 the filing deadline. The Secretary of State may approve specific
1435 means of electronic transmission of completed campaign finance
1436 disclosure reports, which may include, but not be limited to,
1437 transmission by electronic facsimile (FAX) devices.

1438 (f) (i) If any contribution of more than Two Hundred
1439 Dollars (\$200.00) is received by a candidate or candidate's
1440 political committee after the tenth day, but more than forty-eight
1441 (48) hours before 12:01 a.m. of the day of the election, the
1442 candidate or political committee shall notify the appropriate
1443 office designated in Section 23-15-805, within forty-eight (48)
1444 hours of receipt of the contribution. The notification shall
1445 include:

- 1446 1. The name of the receiving candidate;
- 1447 2. The name of the receiving candidate's political
1448 committee, if any;
- 1449 3. The office sought by the candidate;
- 1450 4. The identification of the contributor;
- 1451 5. The date of receipt;
- 1452 6. The amount of the contribution;
- 1453 7. If the contribution is in-kind, a description
1454 of the in-kind contribution; and
- 1455 8. The signature of the candidate or the treasurer
1456 or director of the candidate's political committee.



1457 (ii) The notification shall be in writing, and may be
1458 transmitted by overnight mail, courier service, or other reliable
1459 means, including electronic facsimile (FAX), but the candidate or
1460 candidate's committee shall ensure that the notification shall in
1461 fact be received in the appropriate office designated in Section
1462 23-15-805 within forty-eight (48) hours of the contribution.

1463 **SECTION 49.** Section 23-15-811, Mississippi Code of 1972, is
1464 amended as follows:

1465 23-15-811. (a) Any candidate or any other person who shall
1466 willfully and deliberately and substantially violate the
1467 provisions and prohibitions of this article shall be guilty of a
1468 misdemeanor and upon conviction thereof shall be punished by a
1469 fine in a sum not to exceed Three Thousand Dollars (\$3,000.00) or
1470 imprisoned for not longer than six (6) months or by both fine and
1471 imprisonment.

1472 (b) In addition to the penalties provided in paragraph (a)
1473 of this section, any candidate or political committee which is
1474 required to file a statement or report which fails to file such
1475 statement or report on the date in which it is due may be
1476 compelled to file such statement or report by an action in the
1477 nature of a mandamus.

1478 (c) No candidate shall be certified * * * as elected to
1479 office unless and until he files all reports required by this
1480 article due as of the date of certification.

1481 (d) No candidate who is elected to office shall receive any
1482 salary or other remuneration for the office unless and until he
1483 files all reports required by this article due as of the date such
1484 salary or remuneration is payable.

1485 (e) In the event that a candidate fails to timely file any
1486 report required pursuant to this article but subsequently files a
1487 report or reports containing all of the information required to be
1488 reported by him as of the date on which the sanctions of
1489 paragraphs (c) and (d) of this section would be applied to him,



1490 such candidate shall not be subject to the sanctions of said
1491 paragraphs (c) and (d).

1492 **SECTION 50.** Section 23-15-833, Mississippi Code of 1972, is
1493 amended as follows:

1494 23-15-833. Except as otherwise provided by law, the first
1495 Tuesday after the first Monday in November of each year shall be
1496 designated the regular special election day, and on that day an
1497 election shall be held to fill any vacancy in county, county
1498 district and district attorney elective offices.

1499 All special elections, or elections to fill vacancies, shall
1500 in all respects be held, conducted and returned in the same manner
1501 as general elections, except that where no candidate receives a
1502 majority of the votes cast in such election, then a runoff
1503 election shall be held two (2) weeks after such election and the
1504 two (2) candidates who receive the highest popular votes for such
1505 office shall have their names submitted as such candidates to the
1506 said runoff and the candidate who leads in such runoff election
1507 shall be elected to the office. When there is a tie in the first
1508 election of those receiving the next highest vote, these two (2)
1509 and the one receiving the highest vote, none having received a
1510 majority, shall go into the runoff election and whoever leads in
1511 such runoff election shall be entitled to the office.

1512 In those years when the regular special election day shall
1513 occur on the same day as the general election, the names of
1514 candidates in any special election and the general election shall
1515 be placed on the same ballot, but shall be clearly distinguished
1516 as general election candidates or special election candidates.

1517 * * *

1518 **SECTION 51.** Section 23-15-859, Mississippi Code of 1972, is
1519 amended as follows:

1520 23-15-859. Whenever under any statute a special election is
1521 required or authorized to be held in any municipality, and the
1522 statute authorizing or requiring such election does not specify



1523 the time within which such election shall be called, or the notice
1524 which shall be given thereof, the governing authorities of the
1525 municipality shall, by resolution, fix a date upon which such
1526 election shall be held. Such date shall not be less than
1527 twenty-one (21) nor more than thirty (30) days after the date upon
1528 which such resolution is adopted, and not less than three (3)
1529 weeks' notice of such election shall be given by the clerk by a
1530 notice published in a newspaper published in the municipality once
1531 each week for three (3) weeks next preceding the date of such
1532 election and by posting a copy of such notice at three (3) public
1533 places in such municipality. Nothing herein, however, shall be
1534 applicable to elections on the question of the issuance of the
1535 bonds of a municipality or to preferential or general * * *
1536 elections for the election of municipal officers.

1537 **SECTION 52.** Section 23-15-873, Mississippi Code of 1972, is
1538 amended as follows:

1539 23-15-873. No person, whether an officer or not, shall, in
1540 order to promote his own candidacy, or that of any other person,
1541 to be a candidate for public office in this state, directly or
1542 indirectly, himself or through another person, promise to appoint,
1543 or promise to secure or assist in securing the appointment * * *
1544 or election of another person to any public position or
1545 employment, or to secure or assist in securing any public contract
1546 or the employment of any person under any public contractor, or to
1547 secure or assist in securing the expenditure of any public funds
1548 in the personal behalf of any particular person or group of
1549 persons, except that the candidate may publicly announce what is
1550 his choice or purpose in relation to an election in which he may
1551 be called on to take part if elected. It shall be unlawful for
1552 any person to directly or indirectly solicit or receive any
1553 promise by this section prohibited. But this does not apply to a
1554 sheriff, chancery clerk, circuit clerk or any other person of the
1555 state or county when it comes to their office force.



1556 **SECTION 53.** Section 23-15-881, Mississippi Code of 1972, is
1557 amended as follows:

1558 23-15-881. It shall be unlawful for the Mississippi
1559 Transportation Commission or any member of the Mississippi
1560 Transportation Commission, or the board of supervisors of any
1561 county or any member of the board of supervisors of such county,
1562 to employ, during the months of * * * August, September, October
1563 and November of any year in which a general * * * election is held
1564 for the * * * election of members of the Mississippi
1565 Transportation Commission and members of the boards of
1566 supervisors, a greater number of persons to work and maintain the
1567 state highways in any highway district, or the public roads in any
1568 supervisors district of the county, as the case may be, than the
1569 average number of persons employed for similar purposes in such
1570 highway district or supervisors district, as the case may be,
1571 during the months of * * * August, September, October and November
1572 of the three (3) years immediately preceding the year in which
1573 such general * * * election is held. It shall be unlawful for the
1574 Mississippi Transportation Commission, or the board of supervisors
1575 of any county, to expend out of the state highway funds, or the
1576 road funds of the county or any supervisors district thereof, as
1577 the case may be, in the payment of wages or other compensation for
1578 labor performed in working and maintaining the highways of any
1579 highway district, or the public roads of any supervisors district
1580 of the county, as the case may be, during the months of * * *
1581 August, September, October and November of such election year, a
1582 total amount in excess of the average total amount expended for
1583 such labor, in such highway district or supervisors district, as
1584 the case may be, during the corresponding four-month period of the
1585 three (3) years immediately preceding.

1586 It shall be the duty of the Mississippi Transportation
1587 Commission and the board of supervisors of each county,
1588 respectively, to keep sufficient records of the numbers of



1589 employees and expenditures made for labor on the state highways of
1590 each highway district, and the public roads of each supervisors
1591 district, for the months of * * * August, September, October and
1592 November of each year to show the number of persons employed for
1593 such work in each highway district and each supervisors district,
1594 as the case may be, during said four-month period, and the total
1595 amount expended in the payment of salaries and other compensation
1596 to such employees, so that it may be ascertained, from an
1597 examination of such records, whether or not the provisions of this
1598 chapter have been violated.

1599 It is provided, however, because of the abnormal conditions
1600 existing in certain counties of the state due to recent floods in
1601 which roads and bridges have been materially damaged or washed
1602 away and destroyed, if the board of supervisors in any county
1603 passes a resolution as provided in Section 19-9-11, Mississippi
1604 Code of 1972, for the emergency issuance of road and bridge bonds,
1605 the provisions of this section shall not be applicable to or in
1606 force concerning the board of supervisors during the calendar year
1607 1955.

1608 **SECTION 54.** Section 23-15-885, Mississippi Code of 1972, is
1609 amended as follows:

1610 23-15-885. The restrictions imposed in Sections 23-15-881
1611 and 23-15-883 shall likewise apply to the mayor and board of
1612 aldermen, or other governing authority, of each municipality, in
1613 the employment of labor for working and maintaining the streets of
1614 the municipality during the four-month period next preceding the
1615 date of holding the general * * * election in such municipality
1616 for the election of municipal officers.

1617 **SECTION 55.** Section 23-15-891, Mississippi Code of 1972, is
1618 amended as follows:

1619 23-15-891. No common carrier, telegraph company or telephone
1620 company shall give to any candidate, or to any member of any
1621 political committee, or to any person to be used to aid or promote



1622 the success or defeat of any candidate for election for any public
1623 office, free transportation or telegraph or telephone service, as
1624 the case may be, or any reduction thereof that is not made alike
1625 to all other persons. All persons required by the provisions of
1626 this chapter to make and file statements shall make oath that they
1627 have not received or made use of, directly or indirectly, in
1628 connection with any candidacy for election to any public office,
1629 free transportation or telegraph or telephone service.

1630 **SECTION 56.** Section 23-15-899, Mississippi Code of 1972, is
1631 amended as follows:

1632 23-15-899. Every placard, bill, poster, pamphlet or other
1633 printed matter having reference to any election, or to any
1634 candidate, that has not been submitted to and approved and
1635 subscribed by a candidate or his campaign manager or assistant
1636 manager pursuant to the provisions of Section 23-15-897, shall
1637 bear upon the face thereof the name and the address of the author
1638 and of the printer and publisher thereof, and failure to so
1639 provide shall be a misdemeanor, and it shall be a misdemeanor for
1640 any person to mutilate or remove, previously to the date of the
1641 election, any placard, poster or picture which has been lawfully
1642 placed or posted.

1643 **SECTION 57.** Section 23-15-911, Mississippi Code of 1972, is
1644 amended as follows:

1645 23-15-911. (1) When the returns for a box and the contents
1646 of the ballot box and the conduct of the election thereat have
1647 been canvassed and reviewed by the county election
1648 commission * * *, all the contents of the box required to be
1649 placed and sealed in the ballot box by the managers shall be
1650 replaced therein by the election commission * * *, and the box
1651 shall be forthwith resealed and delivered to the circuit clerk,
1652 who shall safely keep and secure the same against any tampering
1653 therewith. At any time within twelve (12) days after the canvass
1654 and examination of the box and its contents by the election



1655 commission * * *, any candidate or his representative authorized
1656 in writing by him shall have the right of full examination of said
1657 box and its contents upon three (3) days' notice of his
1658 application therefor served upon the opposing candidate or
1659 candidates, or upon any member of their family over the age of
1660 eighteen (18) years, which examination shall be conducted in the
1661 presence of the circuit clerk or his deputy who shall be charged
1662 with the duty to see that none of the contents of the box are
1663 removed from the presence of the clerk or in any way tampered
1664 with. Upon the completion of said examination the box shall be
1665 resealed with all its contents as theretofore. And if any contest
1666 or complaint before the court shall arise over said box, it shall
1667 be kept intact and sealed until the court hearing and another
1668 ballot box, if necessary, shall be furnished for the precinct
1669 involved.

1670 (2) The provisions of this section allowing the examination
1671 of ballot boxes shall apply in the case of an election contest
1672 regarding the seat of a member of the State Legislature. In such
1673 a case, the results of the examination shall be reported by the
1674 applicable circuit clerk to the Clerk of the House of
1675 Representatives or the Secretary of the Senate, as the case may
1676 be.

1677 **SECTION 58.** Section 23-15-973, Mississippi Code of 1972, is
1678 amended as follows:

1679 23-15-973. It shall be the duty of the judges of the circuit
1680 court to give a reasonable time and opportunity to the candidates
1681 for the office of judge of the Supreme Court, judges of the Court
1682 of Appeals, circuit judge and chancellor to address the people
1683 during court terms. In order to give further and every possible
1684 emphasis to the fact that the said judicial offices are not
1685 political but are to be held without favor and with absolute
1686 impartiality as to all persons, and because of the jurisdiction
1687 conferred upon the courts by this chapter, the judges thereof



1688 should be as far removed as possible from any political
1689 affiliations or obligations. It shall be unlawful for any
1690 candidate for any of the offices mentioned in this section to
1691 align himself with any candidate or candidates for any other
1692 office or with any political faction or any political party at any
1693 time during any * * * election campaign. Likewise, it shall be
1694 unlawful for any candidate for any other office * * * wherein any
1695 candidate for any of the judicial offices in this section
1696 mentioned, is or are to be elected, to align himself with any one
1697 or more of the candidates for said offices or to take any part
1698 whatever in any election for any one or more of said judicial
1699 offices, except to cast his individual vote. If any candidate for
1700 any office, whether elected with or without opposition, at any
1701 election wherein a candidate for any one of the judicial offices
1702 herein mentioned is to be elected, shall deliberately, knowingly
1703 and willfully violate the provisions of this section * * *, his
1704 election shall be void.

1705 **SECTION 59.** Section 23-15-1065, Mississippi Code of 1972, is
1706 amended as follows:

1707 23-15-1065. No person shall claim or represent himself in
1708 any manner to be a member of any state, district or county
1709 executive committee of any political party in this state, or claim
1710 to be the national committeeman or national committeewoman or any
1711 other officer or representative of such political party without
1712 having been lawfully elected or chosen as such in the manner
1713 provided by the laws of this state, or by such political party in
1714 the manner provided by the laws of this state * * *.

1715 Any person who violates the provisions of this section, in
1716 addition to other measures or penalties provided by law, may be
1717 enjoined therefrom upon application to the courts by any person or
1718 persons, or any political party, official or representative of
1719 such political party aggrieved thereby.



1720 **SECTION 60.** Section 23-15-1085, Mississippi Code of 1972, is
1721 amended as follows:

1722 23-15-1085. The chairman of a party's state executive
1723 committee shall notify the Secretary of State if the party intends
1724 to hold a presidential preference primary. The Secretary of State
1725 shall be notified prior to December 1 of the year preceding the
1726 year in which a presidential preference primary may be held
1727 pursuant to Section 23-15-1081. * * *

1728 **SECTION 61.** Section 23-15-1087, Mississippi Code of 1972, is
1729 amended as follows:

1730 23-15-1087. Except as otherwise provided in this chapter,
1731 the laws regulating * * * elections shall, insofar as practical,
1732 apply to and govern presidential preference primary elections.

1733 **SECTION 62.** Section 23-15-127, Mississippi Code of 1972,
1734 which provides for the preparation, use and revision of primary
1735 election pollbooks, is hereby repealed.

1736 **SECTION 63.** Section 23-15-171, Mississippi Code of 1972,
1737 which provides for the dates of municipal primary elections, is
1738 hereby repealed.

1739 **SECTION 64.** Section 23-15-191, Mississippi Code of 1972,
1740 which provides for the date of state, district and county primary
1741 elections, is hereby repealed.

1742 **SECTION 65.** Sections 23-15-263, 23-15-265, 23-15-267,
1743 23-15-291, 23-15-293, 23-15-295, 23-15-297, 23-15-299, 23-15-301,
1744 23-15-303, 23-15-305, 23-15-307, 23-15-309, 23-15-311, 23-15-317,
1745 23-15-319, 23-15-331, 23-15-333 and 23-15-335, Mississippi Code of
1746 1972, which provide for the duties of the state executive
1747 committee and county executive committees in primary elections,
1748 provide for the qualification of candidates for party primary
1749 elections, and provide for the conduct of party primary elections,
1750 are hereby repealed.



1751 **SECTION 66.** Sections 23-15-359, 23-15-361 and 23-15-363,
1752 Mississippi Code of 1972, which provide for the contents of
1753 general election ballots, are hereby repealed.

1754 **SECTION 67.** Sections 23-15-597 and 23-15-599, Mississippi
1755 Code of 1972, which provide for the canvass of returns and
1756 announcement of vote by the county executive committees in primary
1757 elections, and require the state executive committee to transmit
1758 to the Secretary of State a tabulated statement of the party vote
1759 for certain offices, are hereby repealed.

1760 **SECTION 68.** Section 23-15-841, Mississippi Code of 1972,
1761 which provides for primary elections for nominations of candidates
1762 to fill vacancies in county and county district offices, is hereby
1763 repealed.

1764 **SECTION 69.** Sections 23-15-921, 23-15-923, 23-15-925,
1765 23-15-927, 23-15-929, 23-15-931, 23-15-933, 23-15-935, 23-15-937,
1766 23-15-939 and 23-15-941, Mississippi Code of 1972, which provide
1767 procedures for contests of primary elections, are hereby repealed.

1768 **SECTION 70.** Section 23-15-1031, Mississippi Code of 1972,
1769 which provides for the date of primary elections for Congressmen
1770 and United States Senators, is hereby repealed.

1771 **SECTION 71.** Section 23-15-1063, Mississippi Code of 1972,
1772 which prohibits unregistered political parties from conducting
1773 primary elections, is hereby repealed.

1774 **SECTION 72.** Section 23-15-1083, Mississippi Code of 1972,
1775 which requires that certain congressional primaries be held on the
1776 same day as the presidential preference primary, is hereby
1777 repealed.

1778 **SECTION 73.** The Attorney General of the State of Mississippi
1779 shall submit this act, immediately upon approval by the Governor,
1780 or upon approval by the Legislature subsequent to a veto, to the
1781 Attorney General of the United States or to the United States
1782 District Court for the District of Columbia in accordance with the



1783 provisions of the Voting Rights Act of 1965, as amended and
1784 extended.

1785 **SECTION 74.** This act shall take effect and be in force from
1786 and after the date it is effectuated under Section 5 of the Voting
1787 Rights Act of 1965, as amended and extended.
