HOUSE BILL NO. 705

AN ACT TO AMEND SECTION 63-11-30, MISSISSIPPI CODE OF 1972, 1 TO PROVIDE THAT CASES APPEALED TO THE COUNTY COURT OR TO THE 2 CIRCUIT COURT FROM JUSTICE COURT FOR VIOLATIONS OF THE IMPLIED CONSENT LAW SHALL HAVE PRIORITY ON THE DOCKET OF THE COUNTY COURT 3 4 OR CIRCUIT COURT OVER ALL OTHER CASES; AND FOR RELATED PURPOSES. 5 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. Section 63-11-30, Mississippi Code of 1972, is amended as follows: 8 63-11-30. (1) It is unlawful for any person to drive or 9 otherwise operate a vehicle within this state who (a) is under the 10 influence of intoxicating liquor; (b) is under the influence of 11 any other substance which has impaired such person's ability to 12 operate a motor vehicle; (c) has an alcohol concentration of eight 13 14 one-hundredths percent (.08%) or more for persons who are above the legal age to purchase alcoholic beverages under state law, or 15 two one-hundredths percent (.02%) or more for persons who are 16 below the legal age to purchase alcoholic beverages under state 17 law, in the person's blood based upon grams of alcohol per one 18 hundred (100) milliliters of blood or grams of alcohol per two 19 hundred ten (210) liters of breath as shown by a chemical analysis 20 of such person's breath, blood or urine administered as authorized 21 22 by this chapter; (d) is under the influence of any drug or controlled substance, the possession of which is unlawful under 23 the Mississippi Controlled Substances Law; or (e) has an alcohol 24

concentration of four one-hundredths percent (.04%) or more in the

person's blood, based upon grams of alcohol per one hundred (100)

milliliters of blood or grams of alcohol per two hundred ten (210)

liters of breath as shown by a chemical analysis of such person's

29 blood, breath or urine, administered as authorized by this chapter 30 for persons operating a commercial motor vehicle.

31 Except as otherwise provided in subsection (3), 32 upon conviction of any person for the first offense of violating 33 subsection (1) of this section where chemical tests provided for 34 under Section 63-11-5 were given, or where chemical test results are not available, such person shall be fined not less than Two 35 Hundred Fifty Dollars (\$250.00) nor more than One Thousand Dollars 36 (\$1,000.00), or imprisoned for not more than forty-eight (48) 37 hours in jail or both; and the court shall order such person to 38 attend and complete an alcohol safety education program as 39 provided in Section 63-11-32. The court may substitute attendance 40 at a victim impact panel instead of forty-eight (48) hours in 41 In addition, the Department of Public Safety, the 42 Commissioner of Public Safety or his duly authorized agent shall, 43 after conviction and upon receipt of the court abstract, suspend 44 the driver's license and driving privileges of such person for a 45 period of not less than ninety (90) days and until such person 46 attends and successfully completes an alcohol safety education 47 program as herein provided; provided, however, in no event shall 48 such period of suspension exceed one (1) year. Commercial driving 49 50 privileges shall be suspended as provided in Section 63-1-83. 51

The circuit court having jurisdiction in the county in which the conviction was had or the circuit court of the person's county of residence may reduce the suspension of driving privileges under Section 63-11-30(2)(a) if the denial of which would constitute a hardship on the offender, except that no court may issue such an order reducing the suspension of driving privileges under this subsection until thirty (30) days have elapsed from the effective date of the suspension. Hardships shall only apply to first offenses under Section 63-11-30(1), and shall not apply to second, third or subsequent convictions of any person violating subsection

hardship shall not be available to any person who refused to 62 63 submit to a chemical test upon the request of a law enforcement officer as provided in Section 63-11-5. A certified copy of such order shall be delivered to 84 the Commissioner of Public Safety by the clerk of the court within 85 five (5) days of the entry of the order. The certified copy of 86 such order shall contain information which will identify the 87 88 petitioner, including, but not limited to, the name, mailing address, street address, social security number and driver's 89 license number of the petitioner. 90 At any time following at least thirty (30) days of suspension 91 for a first offense violation of this section, the court may grant 92 93 the person hardship driving privileges upon written petition of

For any second or subsequent conviction of any person under

If such person successfully completes such treatment, such person shall be eligible for reinstatement of his driving privileges after a period of three (3) years after such person's driver's license is suspended.
- 181 (f) The Department of Public Safety shall promulgate rules and regulations for the use of interlock ignition devices as 182 provided in Section 63-11-31 and consistent with the provisions 183 184 Such rules and regulations shall provide for the calibration of such devices and shall provide that the cost of the 185 186 use of such systems shall be borne by the offender. (b) Upon conviction of any person under the age of twenty-one (21) years for the first offense of violating subsection (1) of this section where chemical tests provided for under Section 63-11-5 were given, or where chemical test results are not available, such person shall have his driver's license suspended for ninety (90) days and shall be fined Two Hundred Fifty Dollars (\$250.00); and the court shall order such person to attend and complete an alcohol safety education program as provided in Section 63-11-32. The court may also require attendance at a victim impact panel.

- 265 (d) For any third or subsequent conviction of any 266 person under the age of twenty-one (21) years violating subsection (1) of this section, the offenses being committed within a period 267 of five (5) years, such person shall be fined not more than One 268 Thousand Dollars (\$1,000.00) and shall have his driver's license 269 270 suspended until he reaches the age of twenty-one (21) or for two 271 (2) years, whichever is longer.
- Any person under the age of twenty-one (21) years 272 (e) convicted of a second violation of subsection (1) of this section, 273 may have the period that his driver's license is suspended reduced 274 if such person receives an in-depth diagnostic assessment, and as 275 a result of such assessment is determined to be in need of 276 277 treatment of his alcohol and/or drug abuse problem and 278 successfully completes treatment of his alcohol and/or drug abuse problem at a program site certified by the Department of Mental 279 280 Health. Such person shall be eligible for reinstatement of his driving privileges upon the successful completion of such 281 treatment after a period of six (6) months after such person's 282 283 driver's license is suspended. Each person who receives a diagnostic assessment shall pay a fee representing the cost of 284 285 such assessment. Each person who participates in a treatment program shall pay a fee representing the cost of such treatment. 286

293	first offense of this subsection by a person under the age of

295	be eligible for nonadjudication only once. The Department of
296	Public Safety shall maintain a confidential registry of all cases

The Commissioner of Public Safety or his authorized agent 315 316 shall suspend the driver's license or permit to drive or deny the 317 issuance of a license or permit to such person as provided for first, second and third or subsequent offenders in subsection (2) 318 of this section. Such suspension shall be in addition to any 319 suspension imposed pursuant to subsection (1) of Section 63-11-23. 320 321 The minimum suspension imposed under this subsection shall not be reduced and no prosecutor is authorized to offer a reduction of 322 such suspension as part of a plea bargain.

- Every person who operates any motor vehicle in violation 324 of the provisions of subsection (1) of this section and who in a 325 negligent manner causes the death of another or mutilates, 326 327 disfigures, permanently disables or destroys the tongue, eye, lip, 328 nose or any other limb, organ or member of another shall, upon 329 conviction, be guilty of a felony and shall be committed to the custody of the State Department of Corrections for a period of 330 time of not less than five (5) years and not to exceed twenty-five 331 332 (25) years.
