HOUSE BILL NO. 926

- AN ACT TO AMEND SECTION 45-6-5, MISSISSIPPI CODE OF 1972, TO 1 REVISE THE MEMBERSHIP OF THE BOARD ON LAW ENFORCEMENT OFFICER 2 3
- STANDARDS AND TRAINING; AND FOR RELATED PURPOSES.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4
- SECTION 1. Section 45-6-5, Mississippi Code of 1972, is 5
- amended as follows: 6
- 45-6-5. (1) There is hereby created the Board on Law 7
- Enforcement Officer Standards and Training, which shall consist of 8
- eleven (11) members. 9
- The Governor shall appoint four (4) members of the board 10
- from the following specified categories: 11
- (a) Two (2) members, each to be a chief of police of a 12
- 13 municipality in this state, with one (1) of such municipalities
- having a population of less than one thousand two hundred (1,200) 14
- according to the latest federal decennial census. 15
- (b) One (1) member shall be a sheriff in this state. 16
- (c) One (1) member shall be a district attorney in this 17
- 18 state.
- 19
- The initial appointments to the board shall be made by the 20
- 21 Governor no later than twenty (20) days after the effective date
- of this chapter, as follows: the chief of police and the 22
- representative of higher education each shall be appointed for a 23
- term of two (2) years; and the sheriff and the district attorney 24
- each shall be appointed for a term of three (3) years. Upon the 25
- 26 expiration of the terms of the initial appointees to the board,
- each subsequent appointment shall be made for a term of three (3) 27

- 28 years, beginning on the date of the expiration of the previous
- 29 term. A vacancy in any appointed position on the board prior to
- 30 the expiration of a term shall be filled by appointment of the
- 31 Governor only for the balance of the unexpired term.
- 32 (3) The remaining seven (7) members of the board shall be
- 33 the following:
- 34 (a) The Attorney General.
- 35 (b) The Director of the Mississippi Highway Safety
- 36 Patrol.
- 37 (c) The President of the Mississippi Municipal
- 38 Association or his designee.
- 39 (d) The President of the Mississippi Association of
- 40 Supervisors or his designee.
- 41 (e) A nonsupervisory, rank and file, law enforcement
- 42 officer appointed by the Lieutenant Governor.
- 43 (f) A nonsupervisory, rank and file, law enforcement
- 44 officer appointed by the Speaker of the House of Representatives.
- 45 (g) The President of the Mississippi Campus Law
- 46 Enforcement Officers Association or his designee.
- The Attorney General, the Director of the Mississippi Highway
- 48 Safety Patrol and the respective presidents of the foregoing
- 49 associations shall serve only for their respective terms of
- 50 office.
- 51 (4) Members of the board shall serve without compensation,
- 52 but shall be entitled to receive reimbursement for any actual and
- 53 reasonable expenses incurred as a necessary incident to such
- 54 service, including mileage, as provided in Section 25-3-41.
- 55 (5) There shall be a chairman and a vice chairman of the
- 56 board, elected by and from the membership of the board. The board
- 57 shall adopt rules and regulations governing times and places for
- 58 meetings and governing the manner of conducting its business, but
- 59 the board shall meet at least every three (3) months.

- 60 (6) The Governor shall call an organizational meeting of the 61 board not later than thirty (30) days after the effective date of 62 this chapter.
- (7) The board shall report annually to the Governor and the Legislature on its activities, and may make such other reports as
- 65 it deems desirable.
- 66 (8) The training officers of all police academies in the
- 67 state whose curricula are approved by the board shall be advisors
- 68 to the board. They shall be entitled to all privileges of the
- 69 board members, including travel expenses and subsistence, but
- 70 shall not be eligible to vote at board meetings.
- 71 **SECTION 2.** This act shall take effect and be in force from
- 72 and after July 1, 2003.
