HOUSE BILL NO. 1070

1 AN ACT TO AMEND SECTIONS 25-3-33 AND 71-5-107, MISSISSIPPI  
2 CODE OF 1972, TO AUTHORIZE THE MISSISSIPPI REAL ESTATE COMMISSION  
3 TO INCREASE THE SALARY OF THE DIRECTOR; AND FOR RELATED PURPOSES.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 **SECTION 1.** Section 25-3-33, Mississippi Code of 1972, is  
6 amended as follows:

135       **SECTION 2.** Section 71-5-107, Mississippi Code of 1972, is  
136 amended as follows:

137       71-5-107. The commission shall administer this chapter  
138 through a full-time salaried executive director, to be appointed  
139 by the commission. He shall act as secretary of the commission,  
140 and shall be responsible for the administration of this chapter  
141 under authority delegated to him by the commission. The  
142 commission shall establish the annual salary of the executive  
143 director.

144       **SECTION 3.** This act shall take effect and be in force from  
145 and after July 1, 2003.
