- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6
- 7 SECTION 1. (1) In consideration for the conveyance of
- property authorized in Section 2 of this act, the Delta 8
- 9 Correctional Facility Authority, acting through its Board of
- Commissioners, is authorized to transfer and convey to the Board 10
- of Supervisors of Leflore County, Mississippi, all right, title 11
- and interest in and to certain real property and any improvements 12
- thereon located in Leflore County, Mississippi, subject to any 13
- 14 encumbrances, liens, covenants, conditions or restrictions of
- record pertaining thereto, such parcel of property consisting of 15
- approximately three and six-tenths (3.6) acres in what is commonly 16
- known as the Delta Correctional Facility Authority property in 17
- Leflore County, Mississippi. 18
- The Mississippi Department of Corrections is authorized 19
- to release the property described in subsection (1) of this 20
- 21 section from:
- 22 The lease agreement entered into between the
- Delta Correctional Facility Authority and the Mississippi 23
- Department of Corrections on June 1, 1995; and 24
- (ii) Any additional documents executed in 25
- connection with the lease of said property under the Lease 26
- 27 Agreement as provided for in connection with the financing of the
- 28 Delta Correctional Facility.

- 29 (3) The conveyance authorized in this section may be subject
- 30 to additional terms and conditions agreed upon by the Delta
- 31 Correctional Facility Authority and the Mississippi Department of
- 32 Corrections.
- 33 **SECTION 2.** (1) In consideration for the conveyance of
- 34 property authorized in Section 1 of this act, the Board of
- 35 Supervisors of Leflore County, Mississippi, is authorized to
- 36 transfer and convey to the Mississippi Department of Corrections,
- 37 all right, title and interest in certain real property and any
- 38 improvement thereon located in Leflore County, Mississippi.
- 39 (2) The conveyance authorized in this section may be subject
- 40 to additional terms and conditions agreed upon by the Board of
- 41 Supervisors of Leflore County, Mississippi, and the Mississippi
- 42 Department of Corrections.
- 43 **SECTION 3.** In lieu of a transfer and conveyance of the real
- 44 property and improvements set forth in Section 1 of this act, the
- 45 Delta Correctional Facility Authority, the Mississippi Department
- 46 of Corrections and Leflore County, Mississippi, are authorized to
- 47 enter into and/or approve any sublease of that certain real
- 48 property and any improvements thereon to Leflore County,
- 49 Mississippi, in consideration of the conveyance authorized in
- 50 Section 2 of this act, or upon such terms and conditions as may be
- 51 agreed upon by the Department of Corrections, Leflore County,
- 52 Mississippi, and the Delta Correctional Facility Authority. Any
- 53 sublease authorized under this section may include a purchase
- 54 option for nominal consideration for Leflore County, Mississippi
- 55 (or other consideration agreed to by Leflore County, Mississippi),
- 56 which may be exercised under terms and conditions agreed upon by
- 57 the parties to the sublease.
- 58 **SECTION 4.** This act shall take effect and be in force from
- 59 and after its passage.
