HOUSE CONCURRENT RESOLUTION NO. 142

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
 2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION,
 3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO DIRECT
 4 THE GOVERNOR THROUGH THE DEPARTMENT OF FINANCE AND ADMINISTRATION
 5 TO TRANSFER CERTAIN SPECIAL FUNDS TO THE BUDGET CONTINGENCY FUND;
 6 TO DIRECT THE TREASURER TO TRANSFER CERTAIN FUNDS TO THE BUDGET
 7 CONTINGENCY FUND; TO CREATE A SPECIAL FUND IN THE STATE TREASURY
 8 TO BE KNOWN AS THE SPECIAL FUNDS TRANSFER FUND, WHICH SHALL BE
 9 COMPRISED OF THE MONIES REQUIRED TO BE DEPOSITED INTO THE FUND
 10 UNDER SECTION 27-65-75(18), MISSISSIPPI CODE OF 1972; AND FOR
 11 RELATED PURPOSES."

12 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
 13 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the Joint
 14 Rules of the House and the Senate, including all the deadlines and
 15 other provisions imposed by Joint Rule No. 40, are suspended for
 16 the purpose of requesting the drafting, and the introduction,
 17 consideration and passage, of a bill entitled "AN ACT TO DIRECT
 18 THE GOVERNOR THROUGH THE DEPARTMENT OF FINANCE AND ADMINISTRATION
 19 TO TRANSFER CERTAIN SPECIAL FUNDS TO THE BUDGET CONTINGENCY FUND;
 20 TO DIRECT THE TREASURER TO TRANSFER CERTAIN FUNDS TO THE BUDGET
 21 CONTINGENCY FUND; TO CREATE A SPECIAL FUND IN THE STATE TREASURY
 22 TO BE KNOWN AS THE SPECIAL FUNDS TRANSFER FUND, WHICH SHALL BE
