SENATE BILL NO. 2369

1 AN ACT TO AMEND SECTION 25-3-33, MISSISSIPPI CODE OF 1972, TO  
2 REMOVE THE EXECUTIVE DIRECTOR OF THE EMPLOYMENT SECURITY  
3 COMMISSION FROM THE OMNIBUS PAY STATUTE; TO AMEND SECTION  
4 71-5-107, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE EMPLOYMENT  
5 SECURITY COMMISSION TO ESTABLISH THE SALARY OF THE EXECUTIVE  
6 DIRECTOR BASED ON THE RECOMMENDATION OF THE STATE PERSONNEL BOARD;  
7 AND FOR RELATED PURPOSES.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

9 **SECTION 1.** Section 25-3-33, Mississippi Code of 1972, is  
10 amended as follows:

11 25-3-33. The annual salaries of the following appointive

136       **SECTION 2.** Section 71-5-107, Mississippi Code of 1972, is  
137 amended as follows:

138       71-5-107. The commission shall administer this chapter  
139 through a full-time salaried executive director, to be appointed  
140 by the commission. He shall act as secretary of the commission,  
141 and shall be responsible for the administration of this chapter  
142 under authority delegated to him by the commission. The  
143 commission shall establish the annual salary of the executive  
144 director based on the recommendation of the State Personnel Board.

145       **SECTION 3.** This act shall take effect and be in force from  
146 and after July 1, 2003.
