SENATE RESOLUTION NO. 98

1 A RESOLUTION COMMENDING THE LEGACY OF PUBLIC SERVICE OF  
2 LONGTIME CORINTH CITY CLERK JAMES R. (JIM) BILLINGSLEY UPON THE  
3 OCCASION OF HIS RETIREMENT.

4 WHEREAS, James R. (Jim) Billingsley has been City Clerk of  
5 Corinth, Mississippi, since 1983, and when anyone had a question  
6 about municipal government in Corinth or in any Mississippi  
7 municipality, Jim Billingsley was the man to ask; and

8 WHEREAS, prior to beginning his career at Corinth City Hall  
9 in 1983, Billingsley worked with several other government agencies  
10 where he gained important experience in local, state and federal  
11 programs; and

12 WHEREAS, a native of Corinth, Mississippi, Jim Billingsley  
13 attended Corinth High School in 1957; enlisted in the Army, became  
14 an officer for the 6th Quartermaster ECP281 and served two years  
15 in Germany, receiving the Army Commendation Medal. While in  
16 Germany he met his wife, the former Christine Hofmann; they were  
17 married in 1963 and have two children, Mike and Melinda; and

18 WHEREAS, when he returned to Corinth, Jim joined the Corinth  
19 National Guard and served as Commander of the local unit, which  
20 was recognized as the most outstanding training unit in the state  
21 for several years. He reached the rank of Major in the Army  
22 Reserve before leaving military service and for his long dedicated  
23 military service Jim was recently named Veteran of the Month by  
24 Brigade Headquarters; and

25 WHEREAS, Jim received a BA Degree from Mississippi State  
26 University in 1962, and after a stint in the Advertising  
27 Department at the *Daily Corinthian* newspaper, he went to work for



28 the Corinth Urban Renewal Agency. He later became the first  
29 Executive Director of the Tennessee Valley Housing Authority. He  
30 went into private business for about three years, building and  
31 managing apartments until 1983 when he was hired as City Clerk;

33 WHEREAS, Billingsley served under four mayors, including the  
34 late John D. Mercier and E.S. Bishop. He also worked under Jack  
35 Holt and current Mayor Jerry Latch, who said, "In the eight years  
36 I worked with him, I learned that he was one of the most  
37 knowledgeable men in municipal government in the State of  
38 Mississippi"; and

39 WHEREAS, Billingsley served on the Mississippi Municipal  
40 Association, Board of Directors for eight years and served eight  
41 years as Parliamentarian for the Mississippi Municipal Clerks  
42 Association; other Mississippi municipal governments called him  
43 quite frequently for advice on municipal affairs; and

44 WHEREAS, Jim Billingsley said that every day was a new  
45 challenge, but his best memory was how the City of Corinth  
46 responded to the 1994 ice storm, with all city employees working  
47 together; and

48 WHEREAS, Jim Billingsley served with distinction and the City  
49 of Corinth and the State of Mississippi will miss his experience  
50 and leadership, and wish to express sincere appreciation to him  
51 for his record of dedicated public service:

52 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF  
53 MISSISSIPPI, That we do hereby commend the legacy of public  
54 service of longtime Corinth City Clerk James R. (Jim) Billingsley  
55 upon the occasion of his retirement after 20 years of service, for  
56 all that he has meant to the City of Corinth and his contributions  
57 to Mississippi municipal government, and extend to him the best  
58 wishes of the Senate.
