**AMENDMENT No. 1 PROPOSED TO**

**House Bill NO. 908**

**By Senator(s) Committee**

**Amend by striking all after the enacting clause and inserting  
in lieu thereof the following:**

11       **SECTION 1.** The following highway is deleted from the state  
12 highway system, removed from the jurisdiction of the Mississippi  
13 Transportation Commission and returned to the jurisdiction of the  
14 governing authorities of Yazoo City:

15       Central District - Yazoo County:

16       Mississippi 828 - U.S. 49E Spur - Begins on U.S. 49E and  
17 extends west to Yazoo City, Yazoo County.

18       **SECTION 2.** (1) The following segment of highway is  
19 designated as a state highway and placed under the jurisdiction of  
20 the Mississippi Transportation Commission for construction and  
21 maintenance; and such highway, together with the highways  
22 designated in Section 65-3-3, and all other laws adding links to  
23 the designated state highway system, are declared to be the state  
24 highway system of Mississippi:

25       Southern District - Jefferson Davis County:

26       That portion of Mississippi 42 within the corporate  
27 limits of the Town of Prentiss beginning at the end of  
28 state maintenance on Mississippi 42 at its intersection  
29 with an old abandoned railway and proceeding in a  
30 northeasterly direction along Columbia Avenue

31 (Mississippi 42) for approximately seven hundred (700)  
32 feet to the intersection of Columbia Avenue (Mississippi  
33 42) and Third Street.

34 (2) The Mississippi Transportation Commission shall take  
35 over and assume responsibility for construction and maintenance of  
36 the segment of highway described under subsection (1) of this  
37 section whenever the commission certifies that such segment of  
38 highway has been brought up to commission standards and all  
39 utilities, signs, structures and other encroachments on such  
40 highway and right-of-way, are removed or relocated.

41 **SECTION 3.** This act shall take effect and be in force from  
42 and after its passage.

**Further, amend by striking the title in its entirety and  
inserting in lieu thereof the following:**

1 AN ACT TO DELETE A CERTAIN SECTION OF MISSISSIPPI HIGHWAY 828  
2 IN YAZOO COUNTY FROM THE STATE HIGHWAY SYSTEM; TO REMOVE IT FROM  
3 THE JURISDICTION OF THE MISSISSIPPI TRANSPORTATION COMMISSION AND  
4 RETURN IT TO THE JURISDICTION OF THE GOVERNING AUTHORITIES OF  
5 YAZOO CITY; TO DESIGNATE A CERTAIN SEGMENT OF MISSISSIPPI HIGHWAY  
6 42 IN JEFFERSON DAVIS COUNTY AS A STATE HIGHWAY AND TO PLACE SUCH  
7 SEGMENT UNDER THE JURISDICTION OF THE MISSISSIPPI TRANSPORTATION  
8 COMMISSION FOR CONSTRUCTION AND MAINTENANCE; AND FOR RELATED  
9 PURPOSES.
