AMENDMENT No. 1 PROPOSED TO

House Bill NO. 926

By Senator(s) Committee

**Amend by striking all after the enacting clause and inserting
in lieu thereof the following:**

5 **SECTION 1.** Section 45-6-5, Mississippi Code of 1972, is
6 amended as follows:

7 45-6-5. (1) There is hereby created the Board on Law
8 Enforcement Officer Standards and Training, which shall consist of
9 twelve (12) members.

10 (2) The Governor shall appoint five (5) members of the board
11 from the following specified categories:

12 (a) Two (2) members, each to be a chief of police of a
13 municipality in this state, with one (1) of such municipalities
14 having a population of less than one thousand two hundred (1,200)
15 according to the latest federal decennial census.

16 (b) One (1) member shall be a sheriff in this state.

17 (c) One (1) member shall be a district attorney in this
18 state.

19 (d) One (1) member shall be a representative of higher
20 education.

21 The initial appointments to the board shall be made by the
22 Governor no later than twenty (20) days after the effective date
23 of this chapter, as follows: the chief of police and the
24 representative of higher education each shall be appointed for a

term of two (2) years; and the sheriff and the district attorney each shall be appointed for a term of three (3) years. Upon the expiration of the terms of the initial appointees to the board, each subsequent appointment shall be made for a term of three (3) years, beginning on the date of the expiration of the previous term. A vacancy in any appointed position on the board prior to the expiration of a term shall be filled by appointment of the Governor only for the balance of the unexpired term.

(3) The remaining seven (7) members of the board shall be the following:

(a) The Attorney General.

(b) The Director of the Mississippi Highway Safety Patrol.

(c) The President of the Mississippi Municipal Association, or his designee.

(d) The President of the Mississippi Association of Supervisors, or his designee.

(e) The President of the Mississippi Constable Association, or his designee.

(f) The President of the Mississippi Campus Law Enforcement Officers Association, or his designee.

(g) The President of the Mississippi Police Benevolent Association, or his designee.

The Attorney General, the Director of the Mississippi Highway Safety Patrol and the respective presidents of the foregoing associations shall serve only for their respective terms of office.

(4) Members of the board shall serve without compensation, but shall be entitled to receive reimbursement for any actual and reasonable expenses incurred as a necessary incident to such service, including mileage, as provided in Section 25-3-41.

(5) There shall be a chairman and a vice chairman of the board, elected by and from the membership of the board. The board shall adopt rules and regulations governing times and places for meetings and governing the manner of conducting its business, but

60 the board shall meet at least every three (3) months.

61 (6) The Governor shall call an organizational meeting of the
62 board not later than thirty (30) days after the effective date of
63 this chapter.

64 (7) The board shall report annually to the Governor and the
65 Legislature on its activities, and may make such other reports as
66 it deems desirable.

67 (8) The training officers of all police academies in the
68 state whose curricula are approved by the board shall be advisors
69 to the board. They shall be entitled to all privileges of the
70 board members, including travel expenses and subsistence, but
71 shall not be eligible to vote at board meetings.

72 **SECTION 2.** This act shall take effect and be in force from
73 and after July 1, 2003.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**
