- 9 SECTION 1. (1) The Mississippi Board of Trustees of State 10 Institutions of Higher Learning, in consultation with the administrators of each state institution of higher learning, shall 11 adopt guidelines and policies no later than December 1, 2004, as 12 may be necessary to provide all lawful information requested by 13 the Federal Bureau of Investigation, the Central Intelligence 14 15 Agency, the Immigration and Naturalization Service, the Office of Homeland Security and any other federal agency in connection with 16 17 an antiterrorism investigations. The guidelines and policies
- shall include requiring each state institution of higher learning 18
- to verify and report the status of all foreign students, as 19
- 20 required by the Immigration and Naturalization Service or any
- 21 other federal agency.
- 22 (2) The administrators of each state institution of higher
- 23 learning shall cooperate with and provide, in an immediate manner,
- 24 all lawful information requested by the Federal Bureau of
- Investigation, the Central Intelligence Agency, the Immigration 25
- and Naturalization Service, the Office of Homeland Security and 26
- any other federal agency in connection with antiterrorism 27
