HOUSE BILL NO. 1834

1 AN ACT TO AUTHORIZE THE GOVERNING AUTHORITIES OF THE CITY OF  
2 STARKVILLE, MISSISSIPPI, TO ISSUE AND SELL GENERAL OBLIGATION  
3 BONDS OF THE CITY FOR THE PURPOSE OF CONSTRUCTING MUNICIPAL  
4 BUILDINGS, PURCHASING BUILDINGS, PURCHASING LAND FOR THE  
5 CONSTRUCTION OF BUILDINGS AND REPAIR, IMPROVE AND EQUIP SUCH  
6 BUILDINGS, IN AN AMOUNT NOT TO EXCEED \$5,000,000.00; TO PROVIDE  
7 THAT SUCH BONDS SHALL MATURE ABSOLUTELY AT SUCH TIME OR TIMES NOT  
8 TO EXCEED 30 YEARS; AND FOR RELATED PURPOSES.

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

10 **SECTION 1.** The governing authorities of the City of  
11 Starkville, Mississippi, are authorized to issue and sell general  
12 obligation bonds of the city for the purpose of constructing  
13 municipal buildings, purchasing buildings, purchasing land for the  
14 construction of buildings and repair, improve and equip such  
15 buildings, in an amount not to exceed Five Million Dollars  
16 (\$5,000,000.00). Such bonds shall mature absolutely at such time  
17 or times not to exceed thirty (30) years.

18 **SECTION 2.** Except as otherwise provided in this act, all  
19 bonds issued as provided in this act shall be issued and the  
20 proceeds managed in accordance with the terms and provisions as  
21 contained in Section 21-33-301, Mississippi Code of 1972.

22 **SECTION 3.** This act, without reference to any other statute  
23 not referred to in this act, shall be deemed to be full and  
24 complete authority for the borrowing of money and the issuing of  
25 bonds as authorized by the governing authorities and shall be  
26 construed as an additional and alternate method therefor.

27 **SECTION 4.** Any bonds issued under the provisions of this act  
28 shall be validated in the manner provided by law.

29 **SECTION 5.** The governing authorities are authorized and  
30 empowered to adopt any and all lawful resolutions, orders or

31 ordinances and do and perform any and all acts and things  
32 necessary and requisite to carry out the purposes of this act.

33         **SECTION 6.** This act shall take effect and be in force from  
34 and after its passage.
