## HOUSE RESOLUTION NO. 118

1 A RESOLUTION COMMENDING LEON SHAIFER FOR HIS MANY YEARS OF  
2 OUTSTANDING AND DEDICATED SERVICES PROVIDED TO THE MISSISSIPPI  
3 EMERGENCY MANAGEMENT AGENCY.

4 WHEREAS, for the past 30 years, Mr. Leon Shaifer has provided  
5 a wealth of outstanding and committed services to both the state  
6 and local emergency management agencies and has been a dedicated  
7 and valued employee; and

8 WHEREAS, after attending the University of Mississippi, Mr.  
9 Shaifer began his career in emergency management as the part-time  
10 Director of the City of Clarksdale and Coahoma County's Emergency  
11 Management Agency on March 21, 1974; and

12 WHEREAS, during his tenure, Mr. Shaifer served as Director of  
13 the Coahoma County Civil Defense and has served the Mississippi  
14 Emergency Management Agency (MEMA) in many capacities since  
15 October 31, 1986; and

16 WHEREAS, currently fulfilling the position of Deputy Director  
17 of MEMA, Mr. Shaifer's dedication and devotion to emergency  
18 management allowed him to work through 22 Presidential Disaster  
19 Declarations, 36 Small Business Administration Disaster  
20 Declarations and numerous Gubernatorial Disaster Declarations for  
21 the state; and

22 WHEREAS, Mr. Shaifer, who has always responded to the  
23 citizens of the State of Mississippi in any time of crisis, earned  
24 the love and respect of his family, including his wife, Dee  
25 Shaifer, and their four daughters, nine grandchildren and one  
26 great-grandchild; and

27           WHEREAS, the House of Representatives wishes to recognize the  
28 excellence of Mr. Shaifer, whose services to the State of  
29 Mississippi have ensured the requisite assistance and safety of  
30 the state's citizens in times of crisis:
