SENATE BILL NO. 3104

1 AN ACT MAKING AN APPROPRIATION FOR THE PURPOSE OF DEFRAYING  
2 THE EXPENSES OF THE COMMISSION ON JUDICIAL PERFORMANCE OF THE  
3 STATE OF MISSISSIPPI FOR THE FISCAL YEAR 2005.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 **SECTION 1.** The following sum, or so much thereof as may be  
6 necessary, is hereby appropriated out of any money in the State  
7 General Fund not otherwise appropriated, for the purpose of  
8 defraying the expenses of the Commission on Judicial Performance  
9 of the State of Mississippi for the fiscal year beginning  
10 July 1, 2004, and ending June 30, 2005..... \$ 345,902.00.

11 **SECTION 2.** The following sum, or so much thereof as may be  
12 necessary, is hereby appropriated out of any money in the State  
13 Treasury to the credit of the Budget Contingency Fund created in  
14 Section 27-103-301, Mississippi Code of 1972, for the purpose of  
15 defraying the expenses of the Commission on Judicial Performance  
16 of the State of Mississippi for the fiscal year beginning July 1,  
17 2004, and ending June 30, 2005..... \$ 62,800.00.

18 **SECTION 3.** With the funds appropriated under the provisions  
19 of Sections 1 and 2, the following positions are authorized:

25 Any transfers or escalations shall be made in accordance with  
26 the terms, conditions, and procedures established by law.

27           No general funds authorized to be expended herein shall be  
28 used to replace federal funds and/or other special funds which are  
29 being used for salaries authorized under the provisions of this  
30 act and which are withdrawn and no longer available.

31           **SECTION 4.** The money herein appropriated shall be paid by  
32 the State Treasurer out of any money in the State Treasury to the  
33 credit of the proper fund or funds as set forth in this act, upon  
34 warrants issued by the State Fiscal Officer; and the State Fiscal  
35 Officer shall issue his warrants upon requisitions signed by the  
36 proper person, officer or officers, in the manner provided by law.

37           **SECTION 5.** This act shall take effect and be in force from  
38 and after July 1, 2004.
