## SENATE CONCURRENT RESOLUTION NO. 534

1 A CONCURRENT RESOLUTION COMMENDING THE LIFE AND LEGACY OF  
2 PUBLIC SERVICE OF AUDREY WOODCOCK KERN OF PASS CHRISTIAN,  
3 MISSISSIPPI, AND EXPRESSING THE SYMPATHY OF THE LEGISLATURE.

4 WHEREAS, Audrey Woodcock Kern of Pass Christian, Mississippi,  
5 died on January 14, 2004, and

6 WHEREAS, she was a native and lifelong resident of the  
7 Mississippi Gulf Coast. Mrs. Kern was born on October 28, 1926,  
8 in Pass Christian to Bravo and Clara Woodcock. She attended Pass  
9 Christian High School, where she was a member of the 1942 Girls  
10 Basketball State Championship Team; and

11 WHEREAS, Mrs. Kern was a "mover and a shaker" in Gulf Coast  
12 life. She was an owner/operator of numerous restaurants and  
13 nightclubs stretching from Pass Christian to Gulfport. Mrs. Kern  
14 was a lifelong member of the Mississippi Gulf Coast Jazz Society,  
15 where she served as the first female president. She enjoyed  
16 "second lining" beyond compare for all her years. She was elected  
17 and served as one of the first female Harrison County Election  
18 Commissioners and remained active in political life until her  
19 death. She was a member of DeLisle Baptist Church, was a charter  
20 member of the Pass Christian Chapter of the VFW Ladies Auxiliary,  
21 and was a past member of the La Femmes Ladies Carnival Association  
22 of Biloxi. Mrs. Kern was an active member of the St. Paul's  
23 Carnival Association since 1964, served as a Grand Duchess in  
24 1967, and was in the court several other years. An avid Mardi  
25 Gras participant all her life, Mrs. Kern was involved in  
26 fund-raising activities and was an enthusiastic float rider for  
27 many years; and

28           WHEREAS, she is survived by sons, Karl Kern, Jr., (Kim) of  
29 DeLisle and Chris Kern of Gulfport; daughters, Paula Prestwood  
30 (Morgan) of Laurel, Sammie Kern of Mobile, Alabama, and Robin  
31 Cuevas (Wendy) of DeLisle; six grandchildren, Lee Kern, Cabe and  
32 Cassie Prestwood, Evangeline Mandolin Mays and John and Jared  
33 Cuevas; a special niece, Dorothy Gay Ladner; countless dear and  
34 lifelong friends; and a host of other relatives:
