## HOUSE BILL NO. 1038

1	AN ACT TO AMEND SECTIONS 37-9-103 AND 37-9-105, MISSISSIPPI
2	CODE OF 1972, TO REDUCE THE PROBATIONARY PERIOD FOR CERTIFIED
3	PERSONNEL UNDER THE EDUCATION EMPLOYMENT PROCEDURES LAW, AND TO
4	PROVIDE THAT ASSISTANT TEACHERS SHALL BE SUBJECT TO THE SAME
5	PROCEDURES FOR NOTIFICATION OF NONREEMPLOYMENT OR NONRENEWAL OF
6	CONTRACT AS OTHER LICENSED TEACHERS; AND FOR RELATED PURPOSES.

- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- SECTION 1. Section 37-9-103, Mississippi Code of 1972, is 8
- 9 amended as follows:
- 10 37-9-103. As used in Sections 37-9-101 through 37-9-113, the
- 11 word "employee" shall include:
- (a) Any teacher, principal, superintendent or other 12
- 13 professional personnel employed by the local school district for a
- continuous period of one (1) year with that district and required 14
- to have a valid license issued by the State Department of 15
- Education as a prerequisite of employment; or 16
- \* \* \* 17
- 18 Any assistant teacher employed by the local school
- district for a continuous period of one (1) year with that 19
- 20 district and holding the credential required by the State
- Department of Education as a prerequisite of employment. 21
- 22 For purposes of Sections 37-9-101 through 37-9-113, the term
- "days" means calendar days. 23
- 24 SECTION 2. Section 37-9-105, Mississippi Code of 1972, is
- 25 amended as follows:
- 37-9-105. In the event that a recommendation is made by the 26
- 27 school district not to offer an employee a renewal contract for a
- successive year, written notice of the proposed nonreemployment 28

- 29 stating the reasons for the proposed nonreemployment shall be
- 30 given no later than the following:
- 31 (a) If the employee is a principal, the superintendent,
- 32 without further board action, shall give notice of nonreemployment
- 33 on or before March 1; or
- 34 (b) If the employee is a teacher, assistant teacher,
- 35 administrator or other professional educator covered under
- 36 Sections 37-9-101 through 37-9-113, the superintendent, without
- 37 further board action, shall give notice of nonreemployment on or
- 38 before April 15.
- 39 An interim conservator appointed pursuant to the provisions
- 40 of Section 37-17-6(14)(a) or a school board acting on the
- 41 recommendation of a school district financial advisor appointed
- 42 pursuant to the provisions of Section 37-9-18 shall not be
- 43 required to comply with the time limitations prescribed in this
- 44 section for recommending the reemployment of principals, teachers,
- 45 administrators or other professional educators.
- 46 **SECTION 3.** This act shall take effect and be in force from
- 47 and after its passage.
