HOUSE BILL NO. 1206

AN ACT TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE
LICENSE TAGS TO SUPPORT TEACHERS; TO PRESCRIBE AN ADDITIONAL FEE
FOR THE ISSUANCE OF SUCH LICENSE TAGS; TO PROVIDE THAT MONIES
COLLECTED FROM THE ADDITIONAL FEES SHALL BE DISTRIBUTED BY THE
MISSISSIPPI DEPARTMENT OF EDUCATION AMONG ALL THE SCHOOL DISTRICTS
IN THE STATE AND EXPENDED FOR TEACHERS' CLASSROOM SUPPLIES; AND
FOR RELATED PURPOSES.

- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** (1) Any owner of a motor vehicle, who is a
- 10 resident of this state, upon complying with the motor vehicle laws
- 11 relating to registration and licensing of motor vehicles, and upon
- 12 payment of the road and bridge privilege taxes, ad valorem taxes
- 13 and registration fees as prescribed by law for private carriers of
- 14 passengers, pickup trucks and other noncommercial motor vehicles,
- 15 and upon payment of an additional annual fee in the amount
- 16 provided in subsection (3) of this section, shall be issued a
- 17 special license tag for each motor vehicle registered in his name
- 18 identifying such person as a supporter of teachers. The
- 19 distinctive license tags so issued shall be of such color and
- 20 design as the State Tax Commission, with the advice of the
- 21 Mississippi Department of Education, may prescribe, shall have
- 22 imprinted thereon the words "SUPPORT TEACHERS" and shall consist
- 23 of such letters or numbers, or both, as may be necessary to
- 24 distinguish each license tag.
- 25 (2) Application for the distinctive license tags authorized
- 26 by this section shall be made to the county tax collector on forms
- 27 prescribed by the State Tax Commission. The application and the
- 28 additional fee imposed under subsection (3) of this section, less
- 29 Two Dollars (\$2.00) thereof to be retained by the tax collector,

- 30 shall be remitted to the State Tax Commission on a monthly basis
- 31 as prescribed by the commission. The portion of the additional
- 32 fee retained by the tax collector shall be deposited into the
- 33 county general fund.
- 34 (3) Beginning with any registration year commencing on or
- 35 after July 1, 2005, any person applying for a distinctive license
- 36 tag under this section shall pay an additional fee in the amount
- 37 of Thirty Dollars (\$30.00) for each distinctive license tag
- 38 applied for under this section, which shall be in addition to all
- 39 other taxes and fees. The additional fee paid shall be for a
- 40 period of time to run concurrent with the vehicle's established
- 41 license tag year. The additional fee is due and payable at the
- 42 time the original application is made for a distinctive license
- 43 tag under this section and thereafter annually at the time of
- 44 renewal registration as long as the owner retains the distinctive
- 45 license tag. If the owner does not wish to retain the distinctive
- 46 license tag, he must surrender it to the local county tax
- 47 collector.
- 48 (4) The State Tax Commission shall deposit all fees into the
- 49 State Treasury on the day collected. At the end of each month,
- 50 the State Tax Commission shall certify to the State Treasurer the
- 51 total fees collected under this section from the issuance of the
- 52 distinctive license tags issued under this section. The State
- 53 Treasurer shall distribute such collections as follows:
- 54 (a) Twenty-four Dollars (\$24.00) of each additional fee
- 55 collected on distinctive license tags issued pursuant to this
- 56 section shall be disbursed to the Mississippi Department of
- 57 Education and shall be equitably distributed by the department
- 58 among all of the school districts in the state for expenditure on
- 59 teachers' classroom supplies.
- (b) One Dollar (\$1.00) of each additional fee collected
- on distinctive license tags issued pursuant to this section shall

- 62 be deposited into the Mississippi Fire Fighters Memorial Burn
- 63 Center Fund created pursuant to Section 7-9-70.
- 64 (c) Two Dollars (\$2.00) of each additional fee
- 65 collected on distinctive license tags issued pursuant to this
- 66 section shall be deposited to the credit of the State Highway Fund
- 67 to be expended solely for the repair, maintenance, construction or
- 68 reconstruction of highways.
- (d) One Dollar (\$1.00) of each additional fee collected
- 70 on distinctive license tags issued pursuant to this section shall
- 71 be deposited to the credit of the special fund created in Section
- 72 27-19-44.2.
- 73 (5) A regular license tag must be properly displayed as
- 74 required by law until replaced by a distinctive license tag under
- 75 this section. The regular license tag must be surrendered to the
- 76 tax collector upon issuance of the distinctive license tag under
- 77 this section. The tax collector shall issue month and year decals
- 78 for each distinctive license tag issued under this section, which
- 79 will expire the same month and year as the regular license tag.
- 80 (6) In the case of loss or theft of a distinctive license
- 81 tag issued under this section, the owner may make application and
- 82 affidavit for a replacement distinctive license tag as provided by
- 83 Section 27-19-37. The fee for a replacement distinctive license
- 84 tag shall be Ten Dollars (\$10.00). The tax collector receiving
- 85 such application and affidavit shall be entitled to retain and
- 86 deposit into the county general fund five percent (5%) of the fee
- 87 for such replacement license tag and the remainder shall be
- 88 distributed proportionately in the same manner as funds from the
- 89 sale of regular distinctive license tags issued under this
- 90 section.
- 91 **SECTION 2.** This act shall take effect and be in force from
- 92 and after July 1, 2005.
