HOUSE BILL NO. 1634

1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE  
2 AND ADMINISTRATION TO REAUTHORIZE THE EXPENDITURE OF SPECIAL FUNDS  
3 PREVIOUSLY APPROPRIATED FOR CONSTRUCTION AND/OR REPAIR AND  
4 RENOVATION PROJECTS AT VARIOUS STATE AGENCIES AND INSTITUTIONS,  
5 FOR FISCAL YEAR 2006.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** The following sum, or so much thereof as may be  
8 necessary, is hereby reappropriated out of any money in the State  
9 Treasury to the credit of Fund No. 3931, to the Department of  
10 Finance and Administration, acting through the Bureau of Building,  
11 Grounds and Real Property Management, for the purpose of  
12 reauthorizing the expenditure of funds previously appropriated for  
13 construction and/or repair and renovation projects at various  
14 state agencies and institutions, as authorized in House Bill No.  
15 1755, Regular Session of 2004, for the fiscal year beginning July  
16 1, 2005, and ending June 30, 2006.....  
17 ..... \$ 18,807,472.00.

18 This reappropriation is made for the purpose of reauthorizing  
19 the expenditure of special funds for construction and/or repair  
20 and renovation projects at various state agencies and institutions  
21 that had been authorized by the Legislature in prior fiscal years.

22 Notwithstanding the amount reappropriated under the  
23 provisions of this section, in no event shall the amount expended  
24 exceed the unexpended balance as of June 30, 2005, or change the  
25 purpose for which the funds were originally authorized.

26 **SECTION 2.** The following sum, or so much thereof as may be  
27 necessary, is hereby reappropriated out of any money in the State  
28 Treasury to the credit of the Education Enhancement Fund No. 4900,

29 to the Department of Finance and Administration, acting through  
30 the Bureau of Building, Grounds and Real Property Management, for  
31 the purpose of reauthorizing the expenditure of funds previously  
32 appropriated for construction and/or repair and renovation  
33 projects at various state agencies and institutions, as authorized  
34 in House Bill No. 1755, Regular Session of 2004, for the fiscal  
35 year beginning July 1, 2005, and ending June 30, 2006  
36 ..... \$ 10,551.00.

37 This reappropriation is made for the purpose of reauthorizing  
38 the expenditure of special funds for construction and/or repair  
39 and renovation projects at various state agencies and institutions  
40 that had been authorized by the Legislature in prior fiscal years.

41 Notwithstanding the amount reappropriated under the  
42 provisions of this section, in no event shall the amount expended  
43 exceed the unexpended balance as of June 30, 2005, or change the  
44 purpose for which the funds were originally authorized.

45 **SECTION 3.** The Bureau of Building, Grounds and Real Property  
46 Management of the Office of General Services is hereby expressly  
47 authorized and empowered to receive, budget and expend any state,  
48 local or other source funds designated for supplemental funding of  
49 construction and/or repair and renovation projects.

50 **SECTION 4.** The money herein appropriated shall be paid by  
51 the State Treasurer out of any money in the State Treasury to the  
52 credit of the proper fund or funds as set forth in this act, upon  
53 warrants issued by the State Fiscal Officer; and the State Fiscal  
54 Officer shall issue his warrants upon requisitions signed by the  
55 proper person, officer or officers, in the manner provided by law.

56 **SECTION 5.** This act shall take effect and be in force from  
57 and after July 1, 2005.
