HOUSE BILL NO. 1653

1 AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE  
2 STATE TREASURY FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE  
3 STATE BOARD OF REGISTRATION FOR FORESTERS FOR THE FISCAL YEAR  
4 2006.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

6 SECTION 1. The following sum, or so much thereof as may be  
7 necessary, is hereby appropriated out of any money in the State  
8 Treasury to the credit of the State Board of Registered Foresters  
9 Fund, for the purpose of defraying the expenses of the State Board  
10 of Registration for Foresters for the fiscal year beginning  
11 July 1, 2005, and ending June 30, 2006..... \$ 29,730.00.

12 SECTION 2. Of the funds appropriated under the provisions of  
13 Section 1, not more than the amounts set forth below shall be  
14 expended for the respective major objects or purposes of  
15 expenditure:

27 SECTION 3. It is the intention of the Legislature that the  
28 State Board of Registration for Foresters shall maintain complete

29 accounting and personnel records related to the expenditure of all  
30 funds appropriated under this act and that such records shall be  
31 in the same format and level of detail as maintained for Fiscal  
32 Year 2005. It is further the intention of the Legislature that  
33 the agency's budget request for Fiscal Year 2007 shall be  
34 submitted to the Joint Legislative Budget Committee in a format  
35 and level of detail comparable to the format and level of detail  
36 provided during the Fiscal Year 2006 budget request process.

37       **SECTION 4.** The money herein appropriated shall be paid by  
38 the State Treasurer out of any money in the State Treasury to the  
39 credit of the proper fund or funds as set forth in this act, upon  
40 warrants issued by the State Fiscal Officer; and the State Fiscal  
41 Officer shall issue his warrants upon requisitions signed by the  
42 proper person, officer or officers, in the manner provided by law.

43       **SECTION 5.** This act shall take effect and be in force from  
44 and after July 1, 2005.
