- 2 COMMENDING THE LIFE OF SPECIALIST ROBERT SHANE PUGH OF MERIDIAN,
- 3 MISSISSIPPI, WHO WAS A COMBAT CASUALTY IN IRAQ ON MARCH 1, 2005,
- 4 AND EXPRESSING THE SYMPATHY OF THE LEGISLATURE.
- 5 WHEREAS, Specialist Robert Shane Pugh, 25, of Meridian,
- 6 Mississippi, was killed on Tuesday, March 1, 2005, when an
- 7 explosive device detonated near his vehicle while on combat duty
- 8 near Iskandariyah, Iraq; and
- 9 WHEREAS, carried by a military honor guard, he came home to
- 10 his community and family, and was buried with full military honors
- 11 on Thursday, March 10, 2005; and
- 12 WHEREAS, Specialist Pugh was a Medic deployed with the
- 13 Headquarters Company, 1st Battalion out of McComb, Mississippi,
- 14 which is attached to the 155th Infantry Brigade Combat Team, that
- 15 includes 3,500 soldiers from Mississippi and others from Vermont
- 16 and Arkansas. Shane was the fifth member of the unit to die in
- 17 Iraq; and
- 18 WHEREAS, Shane is the 25th soldier or sailor with Mississippi
- 19 ties to die in the war in Afganistan and Iraq, and the ninth
- 20 Mississippi National Guard soldier to give his life in Iraq; and
- 21 WHEREAS, during his funeral, Specialist Pugh was awarded the
- 22 Bronze Star and the Mississippi Medal of Valor posthumously by
- 23 Major General Harold Cross, Adjutant of Mississippi; and
- 24 WHEREAS, Pugh was in line to be promoted to Sergeant and will
- 25 be promoted posthumously; and
- 26 WHEREAS, Shane spent more than five years working as a
- 27 Phlebotomist at United Blood Services in Meridian, where he was

- 28 highly respected by the blood drive sponsors. His family and
- 29 friends remember him as a witty, charming young man; and
- 30 WHEREAS, his family received an outpouring of grief and
- 31 support from across the state, demonstrating the community's

- 34 WHEREAS, he is survived by his wife of less than one year,

- WHEREAS, to a country, a fallen soldier means a national
- 46 loss; to a community, a fallen soldier means a true hero; to a
- 47 parent, a fallen soldier means a son who won't be coming home.
