SENATE CONCURRENT RESOLUTION NO. 609

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE
 2 PURPOSE OF THE FURTHER CONSIDERATION AND PASSAGE OF SENATE BILL
 3 NO. 2731, 2005 REGULAR SESSION, ENTITLED "AN ACT TO CREATE A
 4 COMMISSION ON RESTRUCTURING THE MISSISSIPPI ADEQUATE EDUCATION
 5 PROGRAM (MAEP); TO AMEND SECTION 37-151-7, MISSISSIPPI CODE OF
 6 1972, TO REVISE THE FORMULA FOR COMPUTING AVERAGE DAILY ATTENDANCE
 7 OF STUDENTS FOR PURPOSES OF THE MISSISSIPPI ADEQUATE EDUCATION
 8 PROGRAM; TO PROVIDE THAT THE DEPARTMENT OF FINANCE AND
 9 ADMINISTRATION SHALL ANNUALLY DETERMINE THE BASE STUDENT COST
 10 UNDER THE FORMULA; TO PROVIDE THAT AT-RISK FUNDING IS ONLY
 11 AVAILABLE FOR STUDENTS IN GRADES K-8; TO AUTHORIZE CERTAIN COST
 12 SAVINGS TO THE FORMULA TO BE EXPENDED FOR HIGH GROWTH SCHOOL
 13 DISTRICTS; TO BRING FORWARD SECTION 37-19-7, MISSISSIPPI CODE OF
 14 1972, RELATING TO THE TEACHER SALARY SCALE UNDER THE ADEQUATE
 15 EDUCATION PROGRAM; AND FOR RELATED PURPOSES."

16 BE IT RESOLVED BY THE SENATE OF THE STATE OF MISSISSIPPI, THE
 17 HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That the following
 18 bill is hereby exempt from the timetable for consideration of
 19 bills provided by Joint Rule No. 40, and that consent is hereby
 20 given for further consideration of Senate Bill No. 2731, 2005
 21 Regular Session, entitled "AN ACT TO CREATE A COMMISSION ON
 22 RESTRUCTURING THE MISSISSIPPI ADEQUATE EDUCATION PROGRAM (MAEP);
 23 TO AMEND SECTION 37-151-7, MISSISSIPPI CODE OF 1972, TO REVISE THE
 24 FORMULA FOR COMPUTING AVERAGE DAILY ATTENDANCE OF STUDENTS FOR
 25 PURPOSES OF THE MISSISSIPPI ADEQUATE EDUCATION PROGRAM; TO PROVIDE
 26 THAT THE DEPARTMENT OF FINANCE AND ADMINISTRATION SHALL ANNUALLY
 27 DETERMINE THE BASE STUDENT COST UNDER THE FORMULA; TO PROVIDE THAT
 28 AT-RISK FUNDING IS ONLY AVAILABLE FOR STUDENTS IN GRADES K-8; TO
 29 AUTHORIZE CERTAIN COST SAVINGS TO THE FORMULA TO BE EXPENDED FOR
 30 HIGH GROWTH SCHOOL DISTRICTS; TO BRING FORWARD SECTION 37-19-7,
 31 MISSISSIPPI CODE OF 1972, RELATING TO THE TEACHER SALARY SCALE
 32 UNDER THE ADEQUATE EDUCATION PROGRAM; AND FOR RELATED PURPOSES."
