## SENATE RESOLUTION NO. 32

1 A RESOLUTION RECOGNIZING DR. ETHEL A. YOUNG-MINOR, ASSOCIATE  
2 PROFESSOR, UNIVERSITY OF MISSISSIPPI, FOR EDUCATIONAL LEADERSHIP AND  
3 CIVIC CONTRIBUTIONS.

4 WHEREAS, Dr. Ethel A. Young-Minor, Associate Professor of  
5 English and Afro-Studies, the University of Mississippi (Ole  
6 Miss), was nominated to the Board of Trustees of State  
7 Institutions of Higher Learning for commendation in recognition of  
8 Black History Month; and

9 WHEREAS, Dr. Minor received her Ph.D. in English from Bowling  
10 Green State University (1997); M.A. in English from Bowling Green  
11 State University (1992); and B.A. in English from University of  
12 Tennessee (1990); and

13 WHEREAS, Dr. Minor began her career as a Graduate Instructor  
14 at Bowling Green State University. She joined the staff of the  
15 University of Mississippi in 1996 as Associate Professor of  
16 English and Afro-Studies; and

17 WHEREAS, as an African-American female growing up in Memphis,  
18 Tennessee, Dr. Minor overcame experiences that trap so many to  
19 fail. Dr. Minor's academic research has a large academic  
20 audience, and is called upon constantly to give lectures, keynote  
21 addresses, seminars and conferences in the Oxford and surrounding  
22 areas. She is able to use her academics to create systematic  
23 social changes—the true characteristic of an academician; and

24 WHEREAS, aside from Dr. Minor's "normal service" which  
25 typically includes the responsibilities associated with Ole Miss'  
26 African-American Studies Program, coordinating efforts of the  
27 annual Black History Month program, chairing committees as an

28 Associate Professor in English and chairing committees of the  
29 Black Faculty and Staff organization, the university is uniquely  
30 benefited by Dr. Minor's presence on campus because of a  
31 perspective that she brings to the decision table that would  
32 otherwise not be represented or lost to a mistaken decision; and

33 WHEREAS, Dr. Minor is a constant speaker at various functions  
34 on campus and her "alternative voice" provides an enrichment in  
35 students' education experience that would otherwise be missed.

36 Her service extends to literature, to art, to science areas, and  
37 to the philosophical core of the university. She serves as a  
38 bridge between the university and a local minority community; and

39 WHEREAS, Dr. Minor's civic and community involvement includes  
40 organizer of Oxford Conference for the Book, an International  
41 Celebration of Writing and Celebration; organizer of Gospel in the  
42 Grove, a musical celebration including students from Arkansas,  
43 Mississippi and Tennessee from historically black and historically  
44 white colleges; District Women's Teacher for Tallahatchie-Oxford  
45 Missionary Baptist Church Association, organization of 18 black  
46 churches in Lafayette and Tallahatchie Counties; Associate  
47 Minister, Mt. Hope Missionary Baptist Church, Taylor, Mississippi,  
48 Organizer, Women's Empowerment Conference, Taylor, Mississippi;

50 WHEREAS, Dr. Minor's professional memberships and activities  
51 include: member of College Language Association, Modern Language  
52 Association, Zora Neale Hurston Society, Mid-Atlantic Writer's  
53 Association, Tallahatchie/Oxford Ministerial Alliance; and

54 WHEREAS, Dr. Minor has been recognized for her work by  
55 receiving the following honors and awards: College of Liberal  
56 Arts Teacher of the Year (2003); Mississippi Humanities Council  
57 Teacher of the Year (2003); Grammy-Nomination, Gospel Choir CD  
58 (2001); English Department Summer Research Grant (2001); Black  
59 History Committee Outstanding Service Award (2001); Apollo  
60 Faculty/Staff Legendary Achievement Award (2001); Alpha Kappa

61 Faculty/Staff Service Award (2000); Finalist for University of  
62 Mississippi 1998-1999 First Service Award; recognized for impact  
63 on student life at Ole Miss, 1996-1997, 1997-1998, 1998-1999:

65 MISSISSIPPI, That we take pride in recognizing Dr. Ethel  
66 Young-Minor, Associate Professor, University of Mississippi, in  
67 observance of Black History Month for her past performance, her  
68 current leadership and her future potential in addressing issues  
69 with respect to race relations and diversity which greatly impact  
70 the lives of students, faculty and staff at Ole Miss and civic  
71 leaders in the Oxford Community.

73 Dr. Minor in recognition of her commitment to excellence in  
74 education, be forwarded to the Chancellor of the University of  
75 Mississippi and be made available to the Capitol Press Corps.
