## SENATE RESOLUTION NO. 52

1 A RESOLUTION COMMENDING THE SOLDIERS OF THE 850TH  
2 TRANSPORTATION COMPANY IN RECOGNITION OF THEIR PERSONAL  
3 SACRIFICES, OUTSTANDING DEDICATION, COURAGE, VALOR AND PATRIOTISM

65 WHEREAS, since September 11, 2001, soldiers of the 850th  
66 Transportation Company, along with their comrades of the United  
67 States Army, United States Navy, United States Air Force and the  
68 Army and Air National Guard of Mississippi and surrounding states,  
69 have been called to active service in defense of our nation's  
70 freedom, and a renewed commitment to establish a free and  
71 self-sustaining democratic government out of the tumultuous ruins  
72 of tyranny and terror; and

73 WHEREAS, with some soldiers veteran to warfare as experienced  
74 in Desert Storm, the 850th was activated in November 2003 and went  
75 to Fort Stewart, Georgia, for training before being deployed to  
76 Iraq in early 2004; and

77 WHEREAS, as a transportation unit, soldiers of the 850th  
78 traveled up and down all of the highways where bombs had been  
79 detonated, delivering food, water, medical supplies and  
80 ammunition; and

81 WHEREAS, President George W. Bush, Commander in Chief of the  
82 United States Military and the United States Army Reserve Command,  
83 whose leadership and dedication is known throughout the military  
84 of the United States, continues to guide and command units of the  
85 Army Reservists in mobilizations and deployments and security at  
86 critical sites on foreign and domestic soils; and

87 WHEREAS, the Senate recognizes and commends the diligence of  
88 the soldiers of the 850th Transportation Company, who have placed  
89 themselves directly in harms way, for their devotion to this state  
90 and nation to secure and insure peace and to preserve and protect  
91 freedom for all:

92 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF  
93 MISSISSIPPI, That we do hereby commend the 850th Transportation  
94 Company on its outstanding leadership, selfless dedication and

95 patriotism exemplified through the acts of the soldiers and  
96 officers in effectively accomplishing their wartime mission.

98 the commanding officers of the 850th Transportation Company and to
