Amend by striking all after the enacting clause and inserting in lieu thereof the following:

62	Provided, further, in subsection (c) that the management of
63	such shows shall be in the hands of a county livestock
64	association, and such association shall guarantee a minimum amount
65	of Five Hundred Dollars (\$500.00) to be used in the paying of
66	prizes, premiums or awards, and after said county show has been
67	held and premiums paid, fifty percent (50%) of the amount, not
68	exceeding One Thousand Dollars (\$1,000.00), shall be paid upon
69	requisition to the Mississippi Fair Commission.
70	Provided, further, in subsection (c) that in any county which
71	has two (2) shows with proper facilities, and a contiguous county
72	has no such fair and desires to participate in a fair to be held
73	in an adjoining county, each of the two (2) fairs in one (1)
74	county may receive an equal proportion of the funds hereby
75	appropriated, provided, both shows shall not receive an aggregate
76	sum of more than One Thousand Dollars (\$1,000.00).
77	(d) For the purpose of offering awards and prizes to
78	competitors in the five (5) district livestock shows, for the
79	fiscal year beginning July 1, 2005, and ending June 30, 2006
80	\$ 71,344.00.
81	(e) For the purpose of offering awards and prizes to
82	competitors in the five (5) state dairy shows as provided in
83	Section 69-5-101 et seq., Mississippi Code of 1972, for the fiscal
84	year beginning July 1, 2005, and ending June 30, 2006
85	\$ 11,659.00.
86	Provided, further, that no part of the money herein
87	appropriated under the provisions of subsections (d) and (e) shall
88	be used for any other purpose than to pay premium awards at said
89	shows and state shows and expositions receiving legislative
90	appropriation shall not conflict in dates in order that livestock
91	exhibitors may make the circuit of shows. Provided, further, that
92	none of the above mentioned funds shall be paid to any district
93	shows unless shows are held prior to roundup.

Not less than seventy-five percent (75%) of the funds herein 94 95 appropriated under the provisions of subsections (d) and (e) shall 96 be used in awarding prizes or premiums to 4-H Club members and 97 Smith-Hughes School members and other boys and girls having 98 entries in said shows. All funds herein appropriated under the provisions of 99 100 subsections (d) and (e) for the five (5) district livestock shows 101 and the five (5) fall state dairy shows shall be distributed in 102 such manner that the livestock exhibitors will each draw equal premium awards for comparable grades and placings at each of the 103 104 said five (5) district spring shows and the five (5) fall state 105 shows. The management of each district spring show and each state 106 fall show shall submit to the Mississippi Fair Commission, within 107 fifteen (15) days after the close of each said show, a full report 108 on the number of exhibitors at each said show, with the grades and placings of the different classes of livestock exhibited. 109 110 The Executive Secretary of the Mississippi Fair Commission, 111 together with a committee of three (3) to be named by the President of the Mississippi Livestock Council from that 112 113 organization, shall summarize and prepare a unified list of awards 114 for like classes in all spring district livestock shows and fall 115 state dairy shows receiving state premium money, as authorized in 116 subsections (d) and (e). The Executive Secretary and Chairman of 117 the Mississippi Fair Commission shall approve and present a 118 requisition to the State Fiscal Officer for the payment of the amount of funds in subsections (d) and (e) due each show and said 119 120 State Fiscal Officer shall issue his warrant thereon, and it shall be paid by the State Treasurer. 121 122 Provided, however, as a condition of expenditure of the funds 123 appropriated in subsections (d) and (e), that the board of

directors of any district livestock show may, in its discretion,

choose to hold its show in the fall instead of the spring.

145	dairy cattle, hogs, sheep and poultry for the fiscal year
146	beginning July 1, 2005, and ending June 30, 2006
147	\$ 12,000.00
148	Of the amount appropriated in this section, Four Thousand
149	Seven Hundred Fifty-three Dollars (\$4,753.00) shall be made
150	available to the Biloxi Shrimp Festival.
151	SECTION 5. The money herein appropriated shall be paid by
152	the State Treasurer out of any money in the State Treasury to the
153	credit of the proper fund or funds as set forth in this act, upon
154	warrants issued by the State Fiscal Officer; and the State Fiscal
155	Officer shall issue his warrants upon requisitions signed by the
156	proper person, officer or officers in the manner provided by law.

157 **SECTION 6.** This act shall take effect and be in force from 158 and after July 1, 2005.
