HOUSE BILL NO. 99

1AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE
2PURPOSE OF DEFRAYING THE EXPENSES OF THE STATE BOARD OF BARBER
3EXAMINERS FOR THE FISCAL YEAR 2006.

4BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5SECTION 1. The following sum, or so much thereof as may be
6necessary, is hereby appropriated out of any money in the State
7Treasury to the credit of the State Board of Barber Examiners, for
8the purpose of defraying the expenses of the board for the fiscal
9year beginning July 1, 2005, and ending June 30, 2006.....
10..... \$ 213,456.00.

11SECTION 2. With the funds approved for expenditure under
12Section 1, the following positions are authorized:

13AUTHORIZED POSITIONS:

14Permanent: Full Time..... 2
15Part Time..... 4
16Time-Limited: Full Time..... 0
17Part Time..... 0

18With the funds herein appropriated, it is the intention of
19the Legislature that it shall be the agency's responsibility to
20make certain that funds required to be appropriated for "Personal
21Services" for Fiscal Year 2007 do not exceed Fiscal Year 2006
22funds appropriated for that purpose, unless programs or positions
23are added to the agency's Fiscal Year 2007 budget by the
24Mississippi Legislature. Based on data provided by the
25Legislative Budget Office, the State Personnel Board shall
26determine and publish the projected annual cost to fully fund all
27appropriated positions in compliance with the provisions of this

28 act. It shall be the responsibility of the agency head to insure
29 that no single personnel action increases this projected annual
30 cost and/or the Fiscal Year 2006 appropriation for "Personal
31 Services" when annualized, with the exception of escalated funds.
32 If, at the time the agency takes any action to change "Personal
33 Services," the State Personnel Board determines that the agency
34 has taken an action which would cause the agency to exceed this
35 projected annual cost or the Fiscal Year 2006 "Personal Services"
36 appropriated level, when annualized, then only those actions which
37 reduce the projected annual cost and/or the appropriation
38 requirement will be processed by the State Personnel Board until
39 such time as the requirements of this provision are met.

40 Any transfers or escalations shall be made in accordance with
41 the terms, conditions and procedures established by law or
42 allowable under the terms set forth within this act. The State
43 Personnel Board shall not escalate positions without written
44 approval from the Department of Finance and Administration. The
45 Department of Finance and Administration shall not provide written
46 approval to escalate any funds for salaries and/or positions
47 without proof of availability of new or additional funds above the
48 appropriated level.

49 No general funds authorized to be expended herein shall be
50 used to replace federal funds and/or other special funds which are
51 being used for salaries authorized under the provisions of this
52 act and which are withdrawn and no longer available.

53 The agency shall not take any action to promote or otherwise
54 award salary increases through reallocation, reclassification,
55 realignment, education benchmark, career ladder, or any other
56 means to increase salaries of employees or positions unless
57 specifically exempted by the following conditions: the award of
58 teacher pay increases, the advancement of a trainee/cadet to the
59 next level of a bona fide career ladder, the award of an
60 educational benchmark for the attainment of Certified Public

61 Accountant License or higher level professional certification as
62 determined by the State Personnel Board, the immediate replacement
63 of a departing employee with an individual from within state
64 service or a new hire at a salary level equivalent to that of the
65 departing employee, and the emergency appointment of nurses,
66 pharmacists or other health care professionals at a salary to be
67 determined by the State Personnel Board, unless otherwise
68 authorized in this act.

69 **SECTION 3.** It is the intention of the Legislature that the
70 State Board of Barber Examiners shall maintain complete accounting
71 and personnel records related to the expenditure of all funds
72 appropriated under this act and that such records shall be in the
73 same format and level of detail as maintained for Fiscal Year
74 2005. It is further the intention of the Legislature that the
75 agency's budget request for Fiscal Year 2007 shall be submitted to
76 the Joint Legislative Budget Committee in a format and level of
77 detail comparable to the format and level of detail provided
78 during the Fiscal Year 2006 budget request process.

79 **SECTION 4.** The money herein appropriated shall be paid by
80 the State Treasurer out of any money in the State Treasury to the
81 credit of the proper fund or funds as set forth in this act, upon
82 warrants issued by the State Fiscal Officer; and the State Fiscal
83 Officer shall issue his warrants upon requisitions signed by the
84 proper person, officer or officers, in the manner provided by law.

85 **SECTION 5.** This act shall take effect and be in force from
86 and after July 1, 2005.
