HOUSE RESOLUTION NO. 3

1 A RESOLUTION COMMENDING AND CONGRATULATING THE  
2 KIMBERLY-CLARK'S NONWOVENS MILL IN CORINTH, MISSISSIPPI, UPON  
3 EARNING STAR CERTIFICATION FROM THE OCCUPATIONAL SAFETY AND HEALTH  
4 ADMINISTRATION'S VOLUNTARY PROTECTION PROGRAM.
