- WHEREAS, Nick Ardillo, Jr., has announced his retirement from
- 5 his position as Executive Director of the Golden Triangle Regional
- 6 Airport effective March 1, 2006; and
- WHEREAS, he has served as Golden Triangle Regional Airport's
- 8 Executive Director since April 1, 1999; and
- 9 WHEREAS, his retirement culminates a career of more than 40
- 10 years of service in the public sector, including 26 years in the
- 11 U.S. Air Force, 7 years as the Deputy Chief of Staff for Governor
- 12 Kirk Fordice and almost 7 years at the Golden Triangle Regional
- 13 Airport Authority; and
- 14 WHEREAS, during his tenure at the airport, Nick Ardillo, Jr.,
- 15 developed several key programs that helped contribute to the
- 16 growth of the airport and nearby businesses; and
- 17 WHEREAS, he was the Project Director that brought American
- 18 Eurocopter, LLC, to the Golden Triangle, leading a regional effort
- 19 to recruit that prestigious company; and
- 20 WHEREAS, his efforts formed a partnership between the Golden
- 21 Triangle Regional Airport and the Columbus Air Force Base that
- 22 directly enhanced the Air Force mission and contributed to the
- 23 growth of that mission from the recent base closure process; and
- 24 WHEREAS, during his tenure at the airport, over \$20 Million
- 25 of improvements were made at the airport, including the
- 26 construction of an air traffic control tower to support operations
- 27 from Columbus Air Force Base; and

- 28 WHEREAS, he received his Bachelor of Science Degree in
- 29 History and Political Science from Auburn University in 1966, and
- 30 his Master of Science Degree in Systems Management from Troy State
- 31 University in 1977; and
- 32 WHEREAS, he has been very involved in various community
- 33 activities, serving on the Board of Directors of the United Way,
- 34 Chairman of the Columbus Air Force Base 2020 Committee, and a
- 35 member of the Columbus Air Force Base Community Council; and
- 36 WHEREAS, he served as President of the Mississippi Airports
- 37 Association and is currently serving as the Vice Chairman of the
- 38 Tennessee Tombigbee Waterway Development Authority; and
- 39 WHEREAS, following his retirement, he plans to remain in the
- 40 Golden Triangle area and continue his involvement in community
- 41 activities; and
- WHEREAS, it is with great pride that we recognize the
- 43 dedicated service and constructive leadership of Nick Ardillo,
- 44 Jr., who contributed so much to the Golden Triangle Regional
- 45 Airport and the surrounding community:
