## HOUSE CONCURRENT RESOLUTION NO. 63

1 A CONCURRENT RESOLUTION COMMENDING MR. CHARLES I. BRADLEY  
2 UPON HIS RETIREMENT FROM JIM HILL HIGH SCHOOL AS BAND DIRECTOR  
3 AFTER 30 YEARS OF TEACHING IN THE PUBLIC SCHOOL SYSTEM.

4 WHEREAS, Mr. Charles I. Bradley has faithfully served as a  
5 band director since 1977 and is retiring after 30 years of  
6 dedicated service; and

7 WHEREAS, a staunch believer in education, Mr. Bradley  
8 graduated from North Natchez High School in 1972 and then received  
9 a bachelor of arts degree in music in 1976 and a master in music  
10 education in 1977 from Jackson State University; and

11 WHEREAS, Mr. Bradley began his career of band directing at  
12 Indianola Middle School in 1972 where he worked for four years and  
13 helped students develop beginner skills on musical instruments;  
14 and

15 WHEREAS, in 1981, Mr. Bradley began serving as band director  
16 at Siwell Middle School and faithfully served in that capacity  
17 until 1992; and

18 WHEREAS, in 1992, Mr. Bradley began serving as band director  
19 for Jim Hill High School's "Band of Distinction," a position that  
20 he currently holds and where he helps students critique their  
21 knowledge and skills of their instruments and has helped the  
22 band's membership increase from 60 members to over 200 members;

24 WHEREAS, Mr. Bradley, while at Jim Hill, has led the band to  
25 receive great honors such as superior ratings in the Mississippi  
26 High School Band Competition in 2000, 2001, 2003 and 2005; and

27           WHEREAS, in addition to receiving superior ratings, Jim Hill  
28 High School Band, under the capable leadership of Mr. Bradley, has  
29 received many other superior awards at the following events:

30 Mississippi High School Athletic Association, 29th Annual Copiah  
31 Marching Band Festival, West Alabama Marching Band Festival and  
32 the Mississippi Regional State Marching Band Competition; and

33           WHEREAS, Mr. Bradley has also had the "Band of Distinction"  
34 participate in various community service projects such as the  
35 following: Martin Luther King, Jr., Parade in St. Petersburg,  
36 Florida; Jackson State University's Homecoming Parade; Jackson's  
37 Annual Christmas Parade; Hudspeth Regional Center's Annual  
38 Christmas Parade; Hattiesburg Black History Parade and the  
39 Veteran's Day Parade in Birmingham, Alabama; and

40           WHEREAS, as a testament to his dedication to teaching young  
41 people about music, Mr. Bradley received the Gold Apple Award in  
42 1988 and the Executive Training Program Award in 1989 from the  
43 Jackson Public School District; and

44           WHEREAS, in addition to serving as an award-winning band  
45 director, Mr. Bradley also serves as Pastor of Pleasant Grove  
46 Missionary Baptist Church, a position he has held since 1993; and

47           WHEREAS, it is the policy of this Legislature to recognize  
48 and commend the excellence of an individual such as Mr. Charles I.  
49 Bradley who has been a superb band director and an excellent and  
50 positive role model for his students and the community at large:

51           NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF  
52 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING  
53 THEREIN, That we do hereby commend and congratulate Mr. Charles I.  
54 Bradley upon his retirement as the faithful and dedicated band  
55 director of Jim Hill High School and extend heartiest wishes for  
56 continued success in all of his future endeavors.
