HOUSE CONCURRENT RESOLUTION NO. 70

23 University of Southern Mississippi; and

24 WHEREAS, Ms. Karla Smith serves as Chair of the Jefferson
25 Davis Campus Social Studies department; and

26 WHEREAS, Ms. Karla Smith is a sponsor of the Future Educators
27 of America; is a member of the Jefferson Davis Faculty

28 Association; and is a member of the Mississippi Gulf Coast
29 Community College Alumni Association; and

30 WHEREAS, Ms. Karla Smith served as a member of the Vice
31 President's Council; and

32 WHEREAS, Ms. Karla Smith serves as a Captain for the
33 Mississippi Gulf Coast Community College Foundation Promise
34 Campaign; and

35 WHEREAS, Ms. Karla Smith is a member of Delta Kappa Gamma
36 Society International education organization and serves as a local
37 chapter and state officer; is a member of the National Council for
38 the Social Studies, Mississippi Historical Society and Mississippi
39 Council for the Social Studies; and
