4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
5	SECTION 1. The following sum of money, or so much thereof as
6	may be necessary, is hereby appropriated out of any money in the
7	State Treasury to the credit of the State Department of Banking
8	and Consumer Finance, for the support of the State Department of
9	Banking and Consumer Finance, for the fiscal year beginning
10	July 1, 2007, and ending June 30, 2008
11	\$ 7,046,770.00.
12	SECTION 2. With the funds appropriated under the provisions
13	of Section 1, the following positions are authorized:

15	Permanent: Full Time 59
16	Part Time0
17	Time-Limited: Full Time 0

19	Funds are provided herein to adjust the Variable Compensation
20	Plan to ensure that all full-time employees receive a pay increase
21	equal to the realignment component of the Variable Compensation
22	Plan or One Thousand Dollars (\$1,000.00), or Three Percent (3%)
23	whichever is greater, to be awarded on July 1, 2007.
24	With the funds herein appropriated, it is the intention of
25	the Legislature that it shall be the agency's responsibility to
26	make certain that funds required to be appropriated for "Personal
27	Services" for Fiscal Year 2009 do not exceed Fiscal Year 2008

- 29 are added to the agency's Fiscal Year 2009 budget by the

- Any transfers or escalations shall be made in accordance with

- 51 Department of Finance and Administration shall not provide written

- No general funds authorized to be expended herein shall be

- The agency shall not take any action to promote or otherwise

- realignment, education benchmark, career ladder, or any other 61 62 means to increase salaries of employees or positions unless 63 specifically exempted by the following conditions: the award of teacher pay increases, the advancement of a trainee/cadet to the 64 65 next level of a bona fide career ladder, the award of an 66 educational benchmark for the attainment of Certified Public 67 Accountant License or higher level professional certification as determined by the State Personnel Board, the immediate replacement 68 69 of a departing employee with an individual from within state 70 service or a new hire at a salary level equivalent to that of the departing employee, and the emergency appointment of nurses, 71 72 pharmacists or other health care professionals at a salary to be 73 determined by the State Personnel Board, unless otherwise
- 75 SECTION 3. It is the intention of the Legislature that the 76 Banking and Consumer Finance shall maintain complete accounting 77 and personnel records related to the expenditure of all funds 78 appropriated under this act and that such records shall be in the 79 same format and level of detail as maintained for Fiscal Year 80 2007. It is further the intention of the Legislature that the agency's budget request for Fiscal Year 2009 shall be submitted to 81 82 the Joint Legislative Budget Committee in a format and level of 83 detail comparable to the format and level of detail provided during the Fiscal Year 2008 budget request process. 84
- 85 SECTION 4. It is the intention of the Legislature that the Department of Banking and Consumer Finance shall have the 86 87 authority to escalate its budget and expend funds from any source received from the Office of the Attorney General in an amount not 88 to exceed Twenty-five Thousand Dollars (\$25,000.00) in accordance 89 90 with rules and regulations of the Department of Finance and Administration in a manner consistent with the escalation of 91 92 federal funds.

93	SECTION 5. It is the intention of the Legislature that
94	whenever two (2) or more bids are received by this agency for the
95	purchase of commodities or equipment, and whenever all things
96	stated in such received bids are equal with respect to price,
97	quality and service, the Mississippi Industries for the Blind
98	shall be given preference. A similar preference shall be given to
99	the Mississippi Industries for the Blind whenever purchases are
100	made without competitive bids.
101	SECTION 6. The money herein appropriated shall be paid by
102	the State Treasurer out of any money in the State Treasury to the
