COMMITTEE AMENDMENT NO 1 PROPOSED TO**

**Senate Bill No. 2496**

**BY: Committee**

**Amend by striking all after the enacting clause and inserting  
in lieu thereof the following:**

10       **SECTION 1.** In addition to all other sums heretofore  
11 appropriated, the following sum, or so much thereof as may be  
12 necessary, is hereby appropriated out of any money in the State  
13 General Fund not otherwise appropriated, for the purpose of  
14 providing 51 (fifty-one) school health nurses for the Mississippi  
15 Department of Health for the fiscal year ending June 30, 2007...  
16 .....\$       1,275,000.00.

17       **SECTION 2.** In addition to all other sums herein  
18 appropriated, the following sum, or so much thereof as may be  
19 necessary, is appropriated out of any money in the State General  
20 Fund not otherwise appropriated, to defray the expenses of the  
21 Mississippi Department of Health, for the purpose of purchasing an  
22 anti-viral vaccine for the Pandemic Flu, for the period beginning  
23 upon passage of this act and through the fiscal year ending June  
24 30, 2008..... \$       4,930,201.00.

25       **SECTION 3.** In addition to all other sums herein  
26 appropriated, the following sum, or so much thereof as may be  
27 necessary, is appropriated out of any money in the State General  
28 Fund not otherwise appropriated, to defray the expenses of the

29 Mississippi Department of Mental Health, for the purpose of  
30 providing additional funding for the East Mississippi State  
31 Hospital, for the fiscal year ending June 30, 2007.....  
32 ..... \$ 3,000,000.00.

33 **SECTION 4.** In addition to all other sums herein  
34 appropriated, the following sum, or so much thereof as may be  
35 necessary, is appropriated out of any money in the State General  
36 Fund not otherwise appropriated, to defray the expenses of the  
37 Mississippi Department of Mental Health, for the purpose of  
38 funding Medicaid match at the community mental health centers, for  
39 the fiscal year ending June 30, 2007..... \$ 2,000,000.00.

40 **SECTION 5.** In addition to all other sums herein  
41 appropriated, the following sum, or so much thereof as may be  
42 necessary, is appropriated out of any money in the State General  
43 Fund not otherwise appropriated, to defray the expenses of the  
44 Mississippi Department of Mental Health, for the purpose of  
45 providing funding for a group home for the fiscal year ending June  
46 30, 2007..... \$ 2,000,000.00.

47 **SECTION 6.** In addition to all other sums herein  
48 appropriated, the following sum, or so much thereof as may be  
49 necessary, is appropriated out of any money in the State General  
50 Fund not otherwise appropriated, to defray the expenses of the  
51 Mississippi Tort Claims Board, for the purpose of purchasing  
52 property insurance on state property as required by the Stafford  
53 Act, Section 311, Paragraph 5154 and 44 CFR 206.252 and 206.253,  
54 and House Bill No. 4, Fifth Extraordinary Session of 2005, for the  
55 fiscal year ending June 30, 2007..... \$ 12,000,000.00.

56 **SECTION 7.** In addition to all other sums heretofore  
57 appropriated, the following sum, or so much thereof as may be  
58 necessary, is hereby appropriated out of any money in the State  
59 General Fund not otherwise appropriated, for the purpose of  
60 providing four law clerks, two judicial assistants and special

61 judges for Katrina related cases for the Mississippi Supreme Court  
62 for the fiscal year ending June 30, 2007 .....\$ 628,286.00.

63 **SECTION 8.** In addition to all other sums heretofore  
64 appropriated, the following sum, or so much thereof as may be  
65 necessary, is hereby appropriated out of any money in the State  
66 Treasury to the credit of the Mississippi Supreme Court which is  
67 comprised of special source funds collected by, or otherwise  
68 available to, the Court for the purpose of providing appropriation  
69 authority for the Administrative Office of Courts to fund local  
70 personnel salary increases for the fiscal year ending  
71 June 30, 2007.....\$ 200,000.00.

72 **SECTION 9.** The money herein appropriated shall be paid by  
73 the State Treasurer out of any money in the proper fund or funds  
74 as set forth in this act, upon warrants issued by the State Fiscal  
75 Officer; and the State Fiscal Officer shall issue his warrants  
76 upon requisitions signed by the proper person, officer or officers  
77 in the manner provided by law.

78 **SECTION 10.** This act shall take effect and be in force from  
79 and after its passage.

**Further, amend by striking the title in its entirety and  
inserting in lieu thereof the following:**

1 AN ACT MAKING AN ADDITIONAL APPROPRIATION OF STATE GENERAL  
2 FUNDS TO DEFRAY THE EXPENSES OF THE MISSISSIPPI DEPARTMENT OF  
3 HEALTH FOR FISCAL YEARS 2007 AND 2008, THE MISSISSIPPI DEPARTMENT  
4 OF MENTAL HEALTH FOR FISCAL YEAR 2007, THE MISSISSIPPI TORT CLAIMS  
5 BOARD FOR FISCAL YEAR 2007, THE MISSISSIPPI SUPREME COURT FOR  
6 FISCAL YEAR 2007, AND AN ADDITIONAL APPROPRIATION OF SPECIAL FUNDS  
7 TO DEFRAY THE EXPENSES OF THE MISSISSIPPI SUPREME COURT FOR FISCAL  
8 YEAR 2007.
