SENATE BILL NO. 2572

1 AN ACT TO ABOLISH CERTAIN INACTIVE BOARDS, COMMISSIONS,
2 COUNCILS, COMMITTEES, AUTHORITIES, TASK FORCES AND PANELS; TO
3 REPEAL SECTION 23-15-169.6, MISSISSIPPI CODE OF 1972, WHICH
4 ESTABLISHES THE TASK FORCE TO STUDY VOTING SYSTEMS THAT COMPLY
5 WITH THE HELP AMERICA VOTE ACT OF 2002; TO REPEAL SECTION
6 27-104-8, MISSISSIPPI CODE OF 1972, WHICH ESTABLISHES THE
7 COMMISSION ON PUBLIC PROCUREMENT CODES; TO REPEAL SECTION
8 31-29-27, MISSISSIPPI CODE OF 1972, WHICH ESTABLISHES THE
9 INSTITUTE FOR TECHNOLOGY DEVELOPMENT OVERSIGHT COMMITTEE; TO
10 REPEAL SECTION 41-30-39, MISSISSIPPI CODE OF 1972, WHICH
11 PRESCRIBES THE DUTIES OF THE ADVISORY COMMITTEE ON ALCOHOL ABUSE
12 AND ALCOHOLISM OF THE ADVISORY COUNCIL ON COMPREHENSIVE HEALTH
13 PLANNING OF THE OFFICE OF THE GOVERNOR; TO REPEAL SECTION
14 41-67-41, MISSISSIPPI CODE OF 1972, WHICH ESTABLISHES THE
15 WASTEWATER ADVISORY COUNCIL; TO REPEAL SECTION 41-95-9,
16 MISSISSIPPI CODE OF 1972, WHICH CREATES THE MISSISSIPPI HEALTH
17 FINANCE AUTHORITY; TO REPEAL SECTION 41-95-7, MISSISSIPPI CODE OF
18 1972, WHICH PRESCRIBES THE DUTIES AND RESPONSIBILITIES OF THE
19 MISSISSIPPI HEALTH FINANCE BOARD; TO REPEAL SECTIONS 41-105-1 AND
20 41-105-3, MISSISSIPPI CODE OF 1972, WHICH ESTABLISH AND PRESCRIBE
21 DUTIES FOR THE HEALTHCARE COORDINATING COUNCIL; TO REPEAL SECTION
22 43-33-75, MISSISSIPPI CODE OF 1972, WHICH ESTABLISHES THE HOUSING
23 TASK FORCE; TO REPEAL SECTION 45-23-7, MISSISSIPPI CODE OF 1972,
24 WHICH ESTABLISHES A TECHNICAL ADVISORY COMMITTEE OF BOILER AND
25 PRESSURE VESSEL SAFETY; TO REPEAL SECTION 49-31-41, MISSISSIPPI
26 CODE OF 1972, WHICH ESTABLISHES THE TASK FORCE ON RECYCLING; TO
27 REPEAL SECTION 57-1-3, MISSISSIPPI CODE OF 1972, WHICH ESTABLISHES
28 AN ADVISORY COUNCIL TO THE DEPARTMENT OF ECONOMIC DEVELOPMENT; TO
29 REPEAL SECTION 57-19-15, MISSISSIPPI CODE OF 1972, WHICH
30 ESTABLISHES THE FOOD TECHNOLOGY ADVISORY BOARD; TO REPEAL SECTION
31 61-4-7, MISSISSIPPI CODE OF 1972, WHICH ESTABLISHES THE
32 MISSISSIPPI WAYPORT AUTHORITY AND A MISSISSIPPI WAYPORT AUTHORITY
33 ADVISORY COUNCIL; TO REPEAL SECTION 69-1-61, MISSISSIPPI CODE OF
34 1972, WHICH ESTABLISHES THE COUNCIL OF STATE AGENCIES ON



35 AGRICULTURE; TO REPEAL SECTION 69-1-113, MISSISSIPPI CODE OF 1972,
36 WHICH ESTABLISHES THE AGRICULTURAL MARKETING ADVISORY TASK FORCE;
37 AND FOR RELATED PURPOSES.

38 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

39 **SECTION 1.** Section 23-15-169.6, Mississippi Code of 1972,
40 which establishes the task force to study voting systems that
41 comply with the Help America Vote Act of 2002, is hereby repealed.

42 **SECTION 2.** Section 27-104-8, Mississippi Code of 1972, which
43 establishes the Commission on Public Procurement Codes, is hereby
44 repealed.

45 **SECTION 3.** Section 31-29-27, Mississippi Code of 1972, which
46 establishes the Institute for Technology Development Oversight
47 Committee, is hereby repealed.

48 **SECTION 4.** Section 41-30-39, Mississippi Code of 1972, which
49 prescribes the duties of the Advisory Committee on Alcohol Abuse
50 and Alcoholism of the Advisory Council on Comprehensive Health
51 Planning of the Office of the Governor, is hereby repealed.

52 **SECTION 5.** Section 41-67-41, Mississippi Code of 1972, which
53 establishes the Wastewater Advisory Council, is hereby repealed.

54 **SECTION 6.** Section 41-95-5, which creates the Mississippi
55 Health Finance Authority, is hereby repealed.

56 **SECTION 7.** Section 41-95-7, which prescribes the duties and
57 responsibilities of the Mississippi Health Finance Board, is
58 hereby repealed.

59 **SECTION 8.** Sections 41-105-1 and 41-105-3, Mississippi Code
60 of 1972, which establish and prescribe duties for the Healthcare
61 Coordinating Council, are hereby repealed.



62 **SECTION 9.** Section 43-33-75, Mississippi Code of 1972, which
63 establishes the Housing Task Force, is hereby repealed.

64 **SECTION 10.** Section 45-23-7, Mississippi Code of 1972, which
65 establishes a Technical Advisory Committee of Boiler and Pressure
66 Vessel Safety, is hereby repealed.

67 **SECTION 11.** Section 49-31-41, Mississippi Code of 1972,
68 which establishes the task force on recycling, is hereby repealed.

69 **SECTION 12.** Section 57-1-3, Mississippi Code of 1972, which
70 establishes an Advisory Council to the Department of Economic
71 Development, is hereby repealed.

72 **SECTION 13.** Section 57-19-15, Mississippi Code of 1972,
73 which establishes the Food Technology Advisory Board, is hereby
74 repealed.

75 **SECTION 14.** Section 61-4-7, Mississippi Code of 1972, which
76 establishes the Mississippi Wayport Authority and a Mississippi
77 Wayport Authority Advisory Council, is hereby repealed.

78 **SECTION 15.** Section 69-1-61, Mississippi Code of 1972, which
79 establishes the Council of State Agencies on Agriculture, is
80 hereby repealed.

81 **SECTION 16.** Section 69-1-113, Mississippi Code of 1972,
82 which establishes the Agricultural Marketing Advisory Task Force,
83 is hereby repealed.

84 **SECTION 17.** This act shall take effect and be in force from
85 and after July 1, 2017.
