- 1 AN ACT TO AMEND SECTION 63-33-1, MISSISSIPPI CODE OF 1972, TO 2 REVISE THE PENALTY FOR TEXTING WHILE DRIVING WITHOUT USING A

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 SECTION 1. Section 63-33-1, Mississippi Code of 1972, is
- amended as follows:
- 63-33-1. (1) For purposes of this section, the following
- 10 terms shall have the meanings ascribed in this subsection, unless
- 11 the context clearly indicates otherwise:
- "Hand-held mobile telephone" means a mobile 12
- telephone or other portable electronic communication device with 13
- 14 which a user engages in a call or writes, sends or reads a text
- 15 message using at least one (1) hand. The term "hand-held mobile
- telephone" shall not include a voice-operated or hands-free 16
- 17 device;

- 18 (b) "Motor vehicle" means a vehicle driven or drawn by
- 19 mechanical power and manufactured primarily for use on public
- 20 highways;
- 21 (c) "Social networking site" means any web-based
- 22 service that allows individuals to construct a profile within a
- 23 founded system, articulate a list of other users with whom they
- 24 share a connection, and communicate with other users of the site;
- 25 (d) "Text message" includes a text-based message,
- 26 instant message, electronic message, and email, but shall not
- 27 include an emergency, traffic or weather alert or a message
- 28 related to the operation or navigation of the motor vehicle;
- 29 (e) "Voice-operated or hands-free device" means a
- 30 device that allows the user to write, send, or read a text message
- 31 without the use of either hand except to activate, deactivate, or
- 32 initiate a feature or function; and
- 33 (f) "Writing," "sending" and "reading," with respect to
- 34 a text message, means the manual entry, sending, or retrieval of a
- 35 text message, respectively, to communicate with any person or
- 36 device.
- 37 (2) An operator of a moving motor vehicle is prohibited from
- 38 writing, sending, or reading a text message and from accessing,
- 39 reading or posting to a social networking site using a hand-held
- 40 mobile telephone while driving said motor vehicle.
