SENATE BILL NO. 2948
(As Sent to Governor)

1 AN ACT MAKING AN APPROPRIATION TO DEFRAY THE EXPENSES OF THE
2 DEPARTMENT OF FINANCE AND ADMINISTRATION FOR FISCAL YEAR 2022.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

4 **SECTION 1.** The following sum, or so much thereof as may be
5 necessary, is hereby appropriated out of any money in the State
6 General Fund not otherwise appropriated, to defray the expenses of
7 the Department of Finance and Administration for the fiscal year
8 beginning July 1, 2021, and ending June 30, 2022.....
9 \$ 34,347,303.00.

10 **SECTION 2.** The following sum, or so much thereof as may be
11 necessary, is hereby appropriated out of any money in the State
12 Treasury to the credit of the Department of Finance and
13 Administration for the purpose of defraying the expenses incurred
14 in the operation of the various offices of the department for the
15 fiscal year beginning July 1, 2021, and ending June 30, 2022
16 \$ 138,620,987.00.

17 **SECTION 3.** Of the funds appropriated under the provisions of
18 this act, the following positions are authorized:

24 With the funds herein appropriated, it shall be the agency's
25 responsibility to make certain that funds required to be
26 appropriated for "Personal Services" for Fiscal Year 2023 do not
27 exceed Fiscal Year 2022 funds appropriated for that purpose unless
28 programs or positions are added to the agency's Fiscal Year 2022
29 budget by the Mississippi Legislature. Based on data provided by
30 the Legislative Budget Office, the State Personnel Board shall
31 determine and publish the projected annual cost to fully fund all
32 appropriated positions in compliance with the provisions of this
33 act. Absent a special situation or circumstance approved by the
34 State Personnel Board, or unless otherwise authorized by this act,
35 no state agency shall take any action to promote or otherwise
36 award salary increases through reallocation or realignment. If
37 the State Personnel Board determines a special situation or
38 circumstance exists and approves an action, then the agency and
39 the State Personnel Board shall provide a monthly report of each
40 action approved by the State Personnel Board to the Chairmen of
41 the Accountability, Efficiency and Transparency Committees of the
42 Senate and House of Representatives and the Chairmen of the
43 Appropriations Committees of the Senate and House of



44 Representatives. It shall be the responsibility of the agency
45 head to ensure that no single personnel action increases this
46 projected annual cost and/or the Fiscal Year 2022 appropriations
47 for "Personal Services" when annualized, with the exception of
48 escalated funds and the award of benchmarks. If, at the time the
49 agency takes any action to change "Personal Services," the State
50 Personnel Board determines that the agency has taken an action
51 which would cause the agency to exceed this projected annual cost
52 or the Fiscal Year 2022 "Personal Services" appropriated level,
53 when annualized, then only those actions which reduce the
54 projected annual cost and/or the appropriation requirement will be
55 processed by the State Personnel Board until such time as the
56 requirements of this provision are met.

70 None of the funds herein appropriated shall be used in
71 violation of Internal Revenue Service's Publication 15-A relating
72 to the reporting of income paid to contract employees, as
73 interpreted by the Office of the State Auditor.

74 Funds have been appropriated herein for the purpose of
75 implementation and funding Project SEC2 of the Colonel Guy Groff
76 State Variable Compensation Plan beginning January 1, 2022, and
77 ending June 30, 2022. It shall be the agency's responsibility to
78 make certain that each person, excluding executive directors,
79 agency heads, and elected judges, shall receive no more than a
80 three percent (3%) annual increase in salary which shall not
81 exceed the market rate established by the State Personnel Board
82 pursuant to the Colonel Guy Groff State Variable Compensation Plan
83 for each classification.

84 **SECTION 4.** In addition to all other sums herein
85 appropriated, the following sum, or so much thereof as may be
86 necessary, is hereby appropriated out of any money in the Tort
87 Claims Trust Fund not otherwise appropriated, for the purpose of
88 defraying the expenses of the Tort Claims Board in the
89 administration of the Tort Claims Act for the fiscal year
90 beginning July 1, 2021, and ending June 30, 2022.....

92 **SECTION 5.** Of the funds appropriated under the provisions of
93 this act, the following positions are authorized:

100 responsibility to make certain that funds required to be

164 of Women for the fiscal year beginning July 1, 2021, and ending
165 June 30, 2022\$ 39,995.00.



166 **SECTION 7.** In addition to all other sums herein
167 appropriated, the following sum, or so much thereof as may be
168 necessary, is hereby appropriated out of any money in the State
169 Treasury to the credit of the Mississippi Commission on the Status
170 of Women for the purpose of defraying the expenses of the
171 commission for the fiscal year beginning July 1, 2021, and ending
172 June 30, 2022\$ 7,265.00.

173 This appropriation is made for the purpose of providing funds
174 to defray the expense of the Mississippi Commission on the Status
175 of Women as established pursuant to Sections 43-59-1 through
176 43-59-14, Mississippi Code of 1972.

177 **SECTION 8.** Of the funds appropriated under the provisions of
178 Sections 6 and 7, the following positions are authorized:

184 With the funds herein appropriated, it shall be the agency's
185 responsibility to make certain that funds required to be
186 appropriated for "Personal Services" for Fiscal Year 2023 do not
187 exceed Fiscal Year 2022 funds appropriated for that purpose unless
188 programs or positions are added to the agency's Fiscal Year 2022
189 budget by the Mississippi Legislature. Based on data provided by
190 the Legislative Budget Office, the State Personnel Board shall



191 determine and publish the projected annual cost to fully fund all

228 being used for salaries authorized under the provisions of this

230 None of the funds herein appropriated shall be used in
231 violation of Internal Revenue Service's Publication 15-A relating
232 to the reporting of income paid to contract employees, as
233 interpreted by the Office of the State Auditor.

234 **SECTION 9.** It is the intention of the Legislature that the
235 Department of Finance and Administration shall maintain complete
236 accounting and personnel records related to the expenditure of all
237 funds appropriated under this act and that such records shall be
238 in the same format and level of detail as maintained for Fiscal
239 Year 2021. It is further the intention of the Legislature that



240 the agency's budget request for Fiscal Year 2023 shall be
241 submitted to the Joint Legislative Budget Committee in a format
242 and level of detail comparable to the format and level of detail
243 provided during the Fiscal Year 2022 budget request process.

244 **SECTION 10.** The department is authorized to expend available
245 funds on technology or equipment upgrades or replacements when it
246 will generate savings through efficiency or when the savings
247 generated from such upgrades or replacements exceed expenditures
248 thereof.

249 **SECTION 11.** It is the intention of the Legislature that
250 whenever two (2) or more bids are received by this agency for the
251 purchase of commodities or equipment, and whenever all things
252 stated in such received bids are equal with respect to price,
253 quality and service, the Mississippi Industries for the Blind
254 shall be given preference. A similar preference shall be given to
255 the Mississippi Industries for the Blind whenever purchases are
256 made without competitive bids.

257 **SECTION 12.** The Bureau of Building, Grounds and Real
258 Property Management of the Office of General Services is hereby
259 expressly authorized and empowered to receive, budget and expend
260 any state, local or other source funds designated for supplemental
261 funding of construction and/or repairs and renovation projects.
262 The Bureau of Building, Grounds and Real Property Management of
263 the Office of General Services shall not use any of the funds
264 authorized in this section to pay salaries. For the purposes of



265 this section, the Bureau of Building, Grounds and Real Property
266 Management of the Office of General Services does not have the
267 authority to escalate from the Capital Expense Fund or the Working
268 Cash-Stabilization Reserve Fund.

269 **SECTION 13.** Of the funds appropriated in Section 2, it is
270 the intention of the Legislature that an amount not to exceed Four
271 Million Five Hundred Thousand Dollars (\$4,500,000.00) is
272 authorized to be expended for the purpose of transferring funds to
273 the Bureau of Building, Grounds and Real Property Management for
274 the administration of projects for the repair and maintenance of
275 state-owned buildings.

276 **SECTION 14.** A report based on expenditures incurred during
277 the current and immediate past fiscal years shall be provided to
278 the Legislative Budget Office each regularly scheduled legislative
279 session. This report should reflect expenditures as a result of
280 the operation of the Robert E. Lee Building, the Woolfolk State
281 Office Building, the Gartin and Sillers Buildings, the Capitol
282 Buildings, the Central High School Building, the Robert G. Clark,
283 Jr. Building and other state buildings, and this report should
284 contain any steps taken to reduce operating costs.

285 **SECTION 15.** It is the intention of the Legislature that no
286 state-owned aircraft shall be utilized by any person except for
287 official business only.

288 **SECTION 16.** Of the funds appropriated in Section 2, an
289 amount not to exceed One Hundred Thousand Dollars (\$100,000.00) is



290 authorized to be expended to defray any shortfall in the Master
291 Lease Purchase Program as defined in Section 31-7-10, Mississippi
292 Code of 1972.

293 **SECTION 17.** In addition to all other sums herein
294 appropriated, the following sum, or so much thereof as may be
295 necessary, is appropriated out of any money in the State General
296 Fund for the purpose of defraying the expenses of State Property
297 Insurance for the fiscal year beginning July 1, 2021, and ending
298 June 30, 2022\$ 11,010,438.00.

299 **SECTION 18.** Of the funds herein appropriated, it is the
300 intention of the Legislature that two (2) of the allotted
301 Full-Time Permanent Positions in Section 3 of this bill may be
302 used for performing related administrative duties of the State
303 Property Insurance program.

304 **SECTION 19.** In addition to all other sums herein
305 appropriated, the following sum, or so much thereof as may be
306 necessary, is appropriated out of any money in the State General
307 Fund not otherwise appropriated, to the Department of Finance and
308 Administration for the purpose of providing a grant to the
309 Mississippi Home Corporation, for the fiscal year beginning
310 July 1, 2021, and ending June 30, 2022\$ 1,810,227.00.

311 **SECTION 20.** The funds appropriated herein shall be targeted
312 to individuals with disabilities or individuals with serious
313 mental illnesses who:



314 (1) Are being discharged from a state psychiatric hospital
315 after a stay of more than ninety (90) days; or, nursing facility,
316 or intermediate care facility for individuals with intellectual
317 disabilities after a stay of more than ninety (90) days; or

318 (2) Have been discharged from a state psychiatric hospital
319 within the last two (2) years; and

320 (a) Had multiple hospital visits in the last year due
321 to mental illness; or

322 (b) Are known to the mental health or state-housing
323 agency to have been arrested or incarcerated in the last year due
324 to conduct related to mental illness; or

325 (c) Are known to the mental health or state-housing
326 agency to have been homeless for one (1) full year or have had
327 four (4) or more episodes of homelessness in the last three (3)
328 years.

329 (3) Lack a fixed, regular, and adequate nighttime residence
330 and includes a subset for an individual who is exiting an
331 institution where he or she resided for ninety (90) days or less
332 and who resides in an emergency shelter or a place not meant for
333 human habitation immediately before entering that institution.

334 Any funds appropriated herein to hire additional staff or
335 employ staff shall only be used to implement this housing program.

336 **SECTION 21.** It is the intention of the Legislature that an
337 annual financial report based upon the state's fiscal year shall
338 be provided to the Attorney General, the Chairman of Senate



339 Appropriations, the Chairman of House Appropriations, and the
340 Legislative Budget Office.

341 **SECTION 22.** It is the intention of the Legislature that none
342 of the funds appropriated under the provisions of this act for the
343 Mississippi Home Corporation (MHC) shall be expended for the
344 purpose of making a payment of any kind or for any purpose,
345 directly or indirectly, to a member of the State of Mississippi
346 Legislature, state official, MHC board member, or person who has
347 been a member of the MHC within the last year.

348 **SECTION 23.** Of the funds appropriated in Section 2, Twelve
349 Million Dollars (\$12,000,000.00) shall be expended from the
350 Capitol Complex Improvement District Project Fund, as established
351 in Section 29-5-215, Mississippi Code of 1972.

352 **SECTION 24.** Of the funds appropriated under the provisions
353 of this act, the department is authorized to enter into a contract
354 for use by state agencies to establish a pilot program for Fleet
355 Management Services, to include vehicle leasing and disposal,
356 without being subject to the provisions of law otherwise
357 applicable to fleet management.

358 **SECTION 25.** It is the intention of the Legislature that the
359 funds herein appropriated shall be expended in compliance with
360 Section 27-104-25, Mississippi Code of 1972, that no state agency
361 shall incur obligations or indebtedness in excess of their
362 appropriation and that the responsible officers, either personally



363 or upon their official bonds, shall be held responsible for
364 actions contrary to this provision.

365 **SECTION 26.** It is the intention of the Legislature, in
366 accordance with House Bill No. 974, 2021 Regular Session, the
367 Department of Finance and Administration shall transfer all
368 employees, equipment, inventory and resources of the Capitol
369 Police employed and used as law enforcement personnel to the
370 Department of Public Safety on July 1, 2021. The transfer of
371 personnel shall be commensurate with the number and classification
372 of positions allocated to that law enforcement. The transfer shall
373 also include direct support, clerical, data processing and
374 communications positions allocated to that law enforcement.

375 **SECTION 27.** In addition to all sums otherwise appropriated,
376 the following sum, or so much thereof as may be necessary, is
377 appropriated out of the Coronavirus Local Fiscal Recovery Fund
378 created in House Bill No. 109, 2021 Regular Session, to the
379 Department of Finance and Administration for the purpose of
380 allocating funds to nonentitlement units of local government in
381 accordance with the provisions applicable to the Coronavirus Local
382 Fiscal Recovery Fund in Section 9901 of the American Rescue Plan
383 Act of 2021 (Public Law No. 117-2) and any applicable federal
384 guidelines for the period upon passage and through
385 June 30, 2022\$ 260,000,000.00

386 **SECTION 28.** In addition to all other funds herein
387 appropriated, the following sum, or so much thereof as may be



388 necessary, shall be derived out of any money in the State Treasury
389 to the credit of the Capital Expense Fund, as created in Section
390 27-103-303, Mississippi Code of 1972, and allocated in a manner as
391 determined by the Treasurer's Office, for the repair, renovation,
392 and improvements of state-owned properties, universities, and
393 community colleges\$16,600,000.00.

394 Any amounts allocated to a project that are in excess of that
395 needed to complete the project may be used for general repairs and
396 renovations at state-owned facilities, universities and community
397 colleges at the discretion of the Department of Finance and
398 Administration.

399 **SECTION 29.** Of the funds appropriated under the provisions
400 of Section 2, Ninety-seven Million Five Hundred Sixty-eight
401 Thousand Eight Hundred Dollars (\$97,568,800.00) or so much
402 thereof, shall be derived out of any money in the State Treasury
403 to the credit of the Capital Expense Fund, as created in Section
404 27-103-303, Mississippi Code of 1972, and allocated in a manner as
405 determined by the Treasurer. These funds are provided for such
406 purposes as follows:

407 (a) To assist the City of Hattiesburg in
408 paying the costs associated with the 12th Circuit
409 Community Service Inmate Program\$ 125,000.00

410 (b) To assist the City of Heidelberg in paying
411 the costs associated with repairs to Magnolia Street
412 and East Poplar Street\$ 100,000.00



413 (c) To assist Marshall County in paying the
414 costs associated with improvements to Barringer
415 Road\$ 1,200,000.00

416 (d) To assist the City of Byram in paying
417 the costs associated with Flood Control
418 Project\$ 400,000.00

419 (e) To assist Hinds County in paying the
420 costs associated with the District Attorney's
421 Office\$ 150,000.00

422 (f) To assist the City of Shannon in paying
423 the costs associated with the construction/improvements
424 to its Community Center\$ 300,000.00

425 (g) To assist the Windows of Amory, a nonprofit
426 corporation, for expenses related to improvements and
427 operations of the First Christian Church in Amory,
428 Mississippi, known as "The Windows"\$ 200,000.00

429 (h) To assist the City of Hazlehurst in
430 paying the costs associated with Reflective
431 Signs\$ 75,000.00

432 (i) Funding is provided to Rankin County
433 for the purpose of advancing implementation
434 of its comprehensive stormwater management program,
435 including, but not limited to, activities in connection
436 with Section 51-29-1 et seq., Mississippi Code of 1972,
437 and for related purposes\$ 2,000,000.00



438 (j) To assist the City of Winona in paying
439 the costs associated with the construction and
440 replacement of historic clock tower\$ 100,000.00

441 (k) To assist the Town of Leakesville in
442 paying the costs associated with infrastructure
443 upgrades\$ 500,000.00

444 (l) To assist the Jackson County Economic
445 Development Foundation for infrastructure
446 Upgrades\$ 500,000.00

447 (m) To assist the Town of Sumrall in
448 paying the costs associated with Phase II of
449 Sportsplex\$ 600,000.00

450 (n) To assist Rankin County in paying the
451 costs associated with improvements to Andrew Chapel
452 Road\$ 1,000,000.00

453 (o) To assist the City of Brandon in paying
454 the costs associated with its downtown revitalization
455 project\$ 1,250,000.00

456 (p) To assist the Pearl River Valley Water
457 Supply District in paying the costs associated with
458 Dredging\$ 500,000.00

459 (q) To assist Rankin County in paying the
460 costs associated with improvements to Gunter
461 Road\$ 750,000.00

462 (r) To assist City of Picayune in paying the
