## HOUSE BILL NO. 235

AN ACT TO REQUIRE THAT COMPREHENSIVE SEX EDUCATION BE TAUGHT

2 IN GRADES K THROUGH 12; TO REQUIRE THAT THE INSTRUCTION EMPHASIZE 3 ABSTINENCE AS THE EXPECTED NORM; TO ESTABLISH THE CRITERIA REQUIRED FOR THE INSTRUCTION OF SEX EDUCATION COURSES IN A MANNER 5 THAT IS AGE AND DEVELOPMENTALLY APPROPRIATE; TO AMEND SECTION 6 37-13-135, MISSISSIPPI CODE OF 1972, TO DIRECT THE LOCAL SCHOOL 7 BOARDS TO ADOPT PLANS FOR THE IMPLEMENTATION OF THE COMPREHENSIVE 8 SCHOOL HEALTH EDUCATION PROGRAM, WHICH SHALL INCLUDE INSTRUCTION 9 IN COMPREHENSIVE SEX EDUCATION; TO AMEND SECTION 37-14-3, 10 MISSISSIPPI CODE OF 1972, TO REQUIRE PUBLIC SCHOOL NURSES TO 11 PROVIDE INSTRUCTION IN EACH OF THE COMPONENTS OF THE COMPREHENSIVE 12 SCHOOL HEALTH EDUCATION PROGRAM; TO REQUIRE THE OFFICE OF HEALTHY 13 SCHOOLS TO SUBMIT POLICY RECOMMENDATIONS TO THE STATE BOARD OF EDUCATION FOR THE ADOPTION OF ANY RULES AND REGULATIONS RELATING 14 TO THE PROGRAM; TO AMEND SECTIONS 37-13-131 AND 37-13-171, 15 16 MISSISSIPPI CODE OF 1972, IN CONFORMITY TO THE PROVISIONS OF THIS 17 ACT; AND FOR RELATED PURPOSES. 18 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 19 **SECTION 1.** (1) (a) No student shall be required to take or 20 participate in any class or course in comprehensive sex education 21 if the student's parent or guardian submits written objection to 22 that participation in a manner consistent with notice required of schools under Section 37-13-173, informing the parent or quardian 23 of the right to exclude their child from participation. Objection 24 and refusal to take or participate in the course or program shall 25

- 26 be without detriment to the student for suspension or expulsion.
- 27 Each class or course in comprehensive sex education offered in any
- 28 of Grades K through 12 shall include instruction on the prevention
- 29 of sexually transmitted infections, including the prevention,
- 30 transmission and spread of HIV. Nothing in this section prohibits
- 31 instruction in sanitation, hygiene or traditional courses in
- 32 biology.
- 33 (b) All public elementary, junior high and senior high
- 34 school classes that teach sex education and discuss sexual
- 35 activity or behavior shall emphasize that abstinence is the
- 36 expected norm in that abstinence from sexual activity or behavior
- 37 is the only protection that is one hundred percent (100%)
- 38 effective against unwanted teenage pregnancy, sexually transmitted
- 39 infections and HIV when transmitted sexually.
- 40 (2) (a) For the purposes of this subsection:
- 41 (i) "Factual information" includes, without
- 42 limitation, medical, psychiatric, psychological, empirical and
- 43 statistical statements.
- 44 (ii) "Medically accurate" means verified or
- 45 supported by research conducted in compliance with scientific
- 46 methods, published in peer-review journals, where appropriate, and
- 47 recognized as accurate and objective by professional organizations
- 48 and agencies with expertise in the relevant field.
- 49 (b) All sex education courses that discuss sexual
- 50 activity or behavior must satisfy the following criteria:

52	material and instruction shall be medically accurate and
53	objective;
54	(ii) All course material and instruction shall be
55	age and developmentally appropriate;
56	(iii) Course material and instruction shall
57	include a discussion of sexual abstinence as a method to prevent
58	unintended pregnancy and sexually transmitted infections,
59	including HIV;
60	(iv) Course material and instruction shall present
61	the latest medically factual information regarding both the
62	possible side effects and health benefits of all forms of
63	contraception, including the success and failure rates for the
64	prevention of pregnancy and sexually transmitted infections,
65	including HIV;
66	(v) Course material and instruction shall include
67	a discussion of the possible consequences of unintended pregnancy
68	and sexually transmitted infections, including HIV;
69	(vi) Course material and instruction shall stress
70	that sexually transmitted infections are serious possible hazards
71	of sexual activity or behavior. Students shall be provided with
72	statistics based on the latest medical information citing the

failure and success rates of all contraceptive methods in

preventing unintended pregnancies and HIV and other sexually

transmitted infection;

76	(vii) Course material and instruction shall advise
77	students of the laws pertaining to their financial responsibility
78	to children born in and out of wedlock;
79	(viii) Course material and instruction shall
80	advise students that it is unlawful for males or females of any
81	age to engage in sexual conduct or have sexual relations with a
82	minor under a certain age;
83	(ix) Course material and instruction shall discuss
84	and provide for the development of positive communication skills
85	to maintain healthy relationships and avoid unwanted sexual
86	activity;
87	(x) Course material and instruction shall
88	emphasize that the student has the power to control personal
89	behavior. Students shall be encouraged to base their actions on
90	reasoning, self-discipline, sense of responsibility, self-control,
91	and ethical considerations, such as respect for oneself and
92	others;
93	(xi) Course material and instruction shall teach
94	students to refrain from making unwanted physical and verbal
95	sexual advances and how to reject unwanted sexual advances and
96	shall include information about verbal, physical, and visual
97	sexual harassment, including, without limitation, nonconsensual
98	sexual advances, nonconsensual physical sexual contact, and rape
99	by an acquaintance. The course material and instruction shall

contain methods of preventing sexual assault by an acquaintance,

- 102 impairs one's judgment. The course material and instruction shall
- 103 emphasize personal accountability and respect for others and shall
- 104 also encourage youth to resist negative peer pressure. The course
- 105 material and instruction shall inform students of the potential
- 106 legal consequences of sexual assault by an acquaintance;
- 107 (xii) Course material and instruction shall teach
- 108 male students about male accountability for sexual violence and
- 109 shall teach female students about reducing vulnerability for
- 110 sexual violence;
- 111 (xiii) Course material and instruction shall teach
- 112 students about counseling, medical, and legal resources available
- 113 to survivors of sexual abuse and sexual assault, including
- 114 resources for escaping violent relationships;
- 115 (xiv) Course material and instruction shall teach
- 116 students that it is wrong to take advantage of or to exploit
- 117 another person; and
- 118 (xv) Course material and instruction shall be free
- 119 of racial, ethnic, gender, religious or sexual orientation biases.
- 120 (c) An opportunity shall be afforded to parents or
- 121 quardians to examine the instructional materials to be used in the
- 122 class or course.
- 123 (3) Nothing in this section shall be construed to conflict
- 124 with or repeal the provisions of laws relating to abstinence-only

- 125 or abstinence-plus education and its components under Section
- 126 37-13-171.
- 127 **SECTION 2.** Section 37-13-135, Mississippi Code of 1972, is
- 128 amended as follows:
- 129 37-13-135. (1) In addition to all other authority, duties
- 130 and powers the school boards of the school districts of this state
- 131 may now have, each \* \* \* school board shall adopt plans for the
- implementation of the Comprehensive School Health Education
- 133 Program into the local school curriculum, which shall include
- 134 instruction in comprehensive sex education.
- 135 (2) School boards shall appoint a local health education
- 136 council to make recommendations regarding a comprehensive health
- 137 education curriculum.
- 138 (3) There shall be cooperation between the State Department
- 139 of Education, Office of Comprehensive School Health Education and
- 140 the school boards of the several school districts in implementing
- 141 this program as it best suits the needs of the individual
- 142 districts.
- 143 (4) The Commission on School Accreditation shall encourage
- 144 the development of plans of comprehensive school health education
- 145 and the implementation thereof.
- SECTION 3. Section 37-14-3, Mississippi Code of 1972, is
- 147 amended as follows:
- 37-14-3. (1) The State Department of Education is

149 designated as the state agency responsible for the administration

150 and supervision of the school nurse program as an education	and

- 151 wellness curriculum in the public schools of the State of
- 152 Mississippi. The public school nurse program administered by the
- 153 State Department of Education shall be known and may be cited as
- 154 the "Mary Kirkpatrick Haskell-Mary Sprayberry Public School Nurse
- 155 Program." It is the intent of the Legislature that all funds made
- 156 available to the State Department of Education for the purpose of
- 157 employing school nurses shall be administered by the State
- 158 Department of Education.
- 159 (2) The State Department of Education, through the Office of
- 160 Healthy Schools, shall develop standards, procedures and criteria
- 161 for the public school nurse programs in Kindergarten through Grade
- 162 12. The Office of Healthy Schools of the State Department of
- 163 Education shall assume the responsibility for promoting a
- 164 statewide school nurse program designed to prepare local school
- 165 districts to incorporate the school program into their local
- 166 educational programs.
- 167 (3) From and after July 1, 2007, the School Nurse
- 168 Intervention Program administered and funded by the State
- 169 Department of Health shall be transferred to the Office of Healthy
- 170 Schools of the State Department of Education. Any administrative
- 171 personnel employed by the State Department of Health for the
- 172 administration of school nurses under the School Nurse
- 173 Intervention Program may be considered for employment by the
- 174 Office of Healthy Schools of the State Department of Education for

- 176 school districts. Any administrative personnel formerly employed
- 177 by the Partnership for a Healthy Mississippi, Inc., for the

- 180 State Department of Education for the purpose of coordinating the
- 181 employment of school nurses in the school districts. All records
- 182 and unexpended balances of accounts in the School Nurse
- 183 Intervention Program relating to the employment of school nurses
- 184 shall be transferred to the Office of Healthy Schools in the State
- 185 Department of Education in accordance with the transfer of
- 186 responsibility under this chapter.
- 187 (4) The nurses in the Mary Kirkpatrick Haskell-Mary
- 188 Sprayberry Public School Nurse Program shall have the following
- 189 specific responsibilities:
- 190 (a) Serve as the coordinator of the health services
- 191 program and provide nursing care;
- 192 (b) Provide health education to students, including
- 193 providing instruction in each of the components of the
- 194 Comprehensive School Health Education Program provided for in
- 195 Section 37-13-131(3);
- 196 (c) Implement activities to promote health and prevent
- 197 tobacco, alcohol and substance use and abuse;
- 198 (d) Identify health and safety concerns in the school
- 199 environment and promote a nurturing social environment;

- 208 The Office of Healthy Schools of the State Department of (5) 209 Education shall provide resources to all public school nurses so 210 that those schools with school nurses will be prepared to provide 211 health education in Mississippi schools and support the 212 Mississippi Comprehensive Health Framework, Mississippi Physical
- 213 Education Framework, Wellness Policy, coordinated approach to
- school health, and other resources required by the State Board of 214
- 215 Education.
- 216 In administering the Mary Kirkpatrick Haskell-Mary Sprayberry Public School Nurse Program, the Office of Healthy 217 218 Schools of the State Department of Education shall perform the 219 following duties:
- 220 (a) Execute any contracts, agreements or other 221 documents with any governmental agency or any person, corporation, 222 association, partnership or other organization or entity that are 223 necessary to accomplish the purposes of this chapter;

- (c) Submit to the State Auditor any financial records
  that are necessary for the Auditor to perform an annual audit of
  the commission as required by law;
- 230 (d) \* \* \* Submit policy recommendations to the State
  231 Board of Education for the adoption of any rules or regulations
  232 that are necessary to carry out the purposes of this chapter;
- 233 (e) Develop criteria to measure the effectiveness of a 234 school nurse;
- 235 (f) Communicate to superintendents and principals how 236 to maximize the effectiveness of a public school nurse;
- 237 (g) Develop recommended salary structure for school 238 districts to use when hiring a school nurse;
- 239 (h) Communicate to superintendents, principals and
  240 other appropriate school officials regarding the statutes and
  241 regulations prohibiting the use of tobacco by school personnel on
  242 school property and at school events, and to monitor the
  243 effectiveness of this ban;
- 244 (i) Implement policies to reduce unnecessary paperwork 245 by public school nurses; and
- 246 (j) Take any other actions that are necessary to carry 247 out the purposes of this chapter.

248	SECTION 4.	Section	37-13-131,	Mississippi	Code	of	1972,	is
249	amended as follo	ws:						

37-13-131. (1) The State Department of Education is
designated as the state agency responsible for the administration
and supervision of the Comprehensive School Health Education
Program as an educational curriculum in the State of Mississippi.
It is the intent of the Legislature that all funds made available
to the State Department of Education for the purpose of
comprehensive school health education shall be administered by the

State Department of Education.

- 258 \* \* \* In accordance with the provisions of subsection 259 (1) of this section, the State Department of Education is 260 authorized to establish an Office of Comprehensive School Health 261 Education within the framework of the State Department of 262 Education for the purpose of developing standards, procedures and 263 criteria for the administration and supervision of a statewide 264 program of health education in Kindergarten through Grade 12. 265 State Department of Education, through the Office of Comprehensive 266 School Health Education, shall assume the further responsibility 267 for promoting a statewide effort designed to prepare local school 268 faculties and staffs to incorporate the comprehensive health 269 education concept into their local educational programs.
- 270 (3) The Mississippi Department of Health, in conjunction 271 with the Office of Student Development-Branch of Health-Related 272 Services of the State Department of Education, shall develop a

- 273 long-range strategic plan for a Comprehensive School Health
- 274 Education Program in Grades K through 12. The Comprehensive
- 275 School Health Education Program shall encompass \* \* \* five (5)
- 276 interdependent components:
- 277 (a) Health education;
- 278 (b) Health service;
- 279 (c) Physical education and fitness; \* \* \*
- 280 (d) A healthful school environment \* \* \*; and
- 281 (e) Sex education as provided under Section 1 of this
- 282 act.
- These curriculum components shall be designed to develop
- 284 decision-making competencies related to health and health
- 285 behavior. \* \* \* These curriculum components are intended to
- 286 motivate health maintenance and promote wellness, not only to
- 287 prevent disease or disability. \* \* \*
- SECTION 5. Section 37-13-171, Mississippi Code of 1972, is
- 289 amended as follows:
- 290 37-13-171. (1) The local school board of every public
- 291 school district shall adopt a policy to implement abstinence-only
- 292 or abstinence-plus education or sexual risk avoidance education
- 293 into its curriculum, which instruction in those subjects shall be
- 294 implemented not later than the start of the 2023-2024 school year
- 295 or the local school board shall adopt the program which has been
- 296 developed by the Mississippi Department of Human Services and the
- 297 Mississippi Department of Health. The State Department of

298	Education shall approve each district's curriculum for sex-related
299	education and shall establish a protocol to be used by districts
300	to provide continuity in teaching the approved curriculum in a
301	manner that is age, grade and developmentally appropriate.

- (2) Notwithstanding any other provision to the contrary, abstinence-only education shall remain the state standard for any sex-related education taught in the public schools. For purposes of this section, abstinence-only education includes any type of instruction or program which, at an appropriate age and grade:
- (a) Teaches the social, psychological and health gains to be realized by abstaining from sexual activity, and the likely negative psychological and physical effects of not abstaining;
- (b) Teaches the harmful consequences to the child, the child's parents and society that bearing children out of marriage is likely to produce, including the health, educational, financial and other difficulties the child and his or her parents are likely to face, as well as the inappropriateness of the social and economic burden placed on others;
- (c) Teaches that unwanted sexual advances are irresponsible and teaches how to reject sexual advances and how alcohol and drug use increases vulnerability to sexual advances;
- (d) Teaches that abstinence from sexual activity before marriage, and fidelity within marriage, is the only certain way to avoid out-of- marriage pregnancy, sexually transmitted diseases and related health problems. The instruction or program may

323	include a discussion on condoms or contraceptives, but only if
324	that discussion includes a factual presentation of the risks and
325	failure rates of those contraceptives. In no case shall the

326 instruction or program include any demonstration of how condoms or

327 other contraceptives are applied;

- 328 (e) Teaches the current state law related to sexual 329 conduct, including forcible rape, statutory rape, paternity 330 establishment, child support and homosexual activity; and
- 331 (f) Teaches that a mutually faithful, monogamous 332 relationship in the context of marriage is the only appropriate 333 setting for sexual intercourse.
  - (3) A program or instruction on sex-related education need not include every component listed in subsection (2) of this section for abstinence-only education. However, no program or instruction under an abstinence-only curriculum may include anything that contradicts the excluded components. For purposes of this section, abstinence-plus education includes every component listed under subsection (2) of this section that is age and grade appropriate, in addition to any other programmatic or instructional component approved by the department, which shall not include instruction and demonstrations on the application and use of condoms. Abstinence-plus education may discuss other contraceptives, the nature, causes and effects of sexually transmitted diseases, or the prevention of sexually transmitted

- Any course containing sex-related education offered in 349 350 the public schools shall include instruction in either 351 abstinence-only or abstinence-plus education. However, the local 352 school board may authorize, by an affirmative vote of a majority 353 of its members, the teaching of sex education without instruction 354 on abstinence. In that event, the curriculum offered in the 355 school relating to sex education must be approved by a majority of 356 the school board members.
- 357 (5) Local school districts, in their discretion, may host 358 programs designed to teach parents how to discuss abstinence with 359 their children.
- 360 (6) There shall be no effort in either an abstinence-only or 361 an abstinence-plus curriculum to teach that abortion can be used 362 to prevent the birth of a baby.
- 363 (7) At all times when sex-related education is discussed or 364 taught, boys and girls shall be separated according to gender into 365 different classrooms, sex-related education instruction may not be 366 conducted when boys and girls are in the company of any students 367 of the opposite gender.
- 368 **SECTION 6.** This act shall take effect and be in force from and after July 1, 2024.
