HOUSE BILL NO. 429

1 AN ACT TO CREATE THE CHILDREN'S RESOURCE COMMISSION; TO
 2 PROVIDE THAT THE COMMISSION IS CHARGED WITH COORDINATING AND
 3 STREAMLINING THE STATE'S EFFORTS TO PROVIDE NEEDED SERVICES TO
 4 MISSISSIPPI'S CHILDREN; TO PROVIDE THE NUMBER OF MEMBERS ON THE
 5 COMMISSION; TO REQUIRE THE COMMISSION TO REPORT TO THE GOVERNOR
 6 AND CERTAIN COMMITTEES OF THE LEGISLATURE NOT LATER THAN DECEMBER
 7 1 OF EACH YEAR; TO REQUIRE THE COMMISSION TO ADOPT INTERNAL
 8 ORGANIZATIONAL PROCEDURES NECESSARY FOR THE EFFICIENT OPERATION OF
 9 THE COMMISSION; TO AUTHORIZE THE COMMISSION TO ESTABLISH
 10 SUBCOMMITTEES FOR CONDUCTING SPECIFIC PROGRAMS AND ACTIVITIES; TO
 11 REQUIRE THE COMMISSION TO CREATE RESOURCE MAPS OF ALL FUNDS
 12 RECEIVED FOR PROGRAMS AND SERVICES THAT SUPPORT CHILDREN IN THIS
 13 STATE, TO ASSESS THE EFFECTIVENESS OF THOSE PROGRAMS AND SERVICES
 14 AND TO DETERMINE THE FEASIBILITY OF MERGING, CONTINUING OR
 15 DISCONTINUING THOSE PROGRAMS OR SERVICES; TO REQUIRE ALL AGENCIES,
 16 DEPARTMENTS, INSTITUTIONS AND POLITICAL SUBDIVISIONS OF THE STATE
 17 THAT PROVIDE PROGRAMS OR SERVICES TO CHILDREN IN THIS STATE TO
 18 CREATE AN ITEMIZED LIST OF THOSE PROGRAMS AND SERVICES, AND TO
 19 COOPERATE WITH THE COMMISSION; TO PROVIDE THAT THE ITEMIZED LISTS
 20 OF PROGRAMS AND SERVICES SHALL BE PROVIDED TO THE JOHN C. STENNIS
 21 INSTITUTE OF GOVERNMENT AT MISSISSIPPI STATE UNIVERSITY NOT LATER
 22 THAN SEPTEMBER 1 OF EACH YEAR; TO PROVIDE THAT THE STENNIS
 23 INSTITUTE SHALL COMPILE THE INFORMATION IN THOSE LISTS INTO ONE
 24 DOCUMENT, AND PROVIDE THE COMPILED INFORMATION TO THE COMMISSION
 25 AND CERTAIN COMMITTEES OF THE LEGISLATURE EACH YEAR; TO REQUIRE
 26 THE COMMISSION TO PROVIDE THE INFORMATION RECEIVED AND PREPARED BY
 27 IT TO THE DEPARTMENT OF HUMAN SERVICES; AND FOR RELATED PURPOSES.

28 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

29 **SECTION 1.** (1) There is created the Children's Resource
 30 Commission, which is charged with coordinating and streamlining



31 the state's efforts to provide needed services to Mississippi's
32 children. The commission shall focus on a broad range of issues
33 and challenges, including fighting abuse and neglect, promoting
34 foster care and adoption, and raising public awareness of
35 children's issues.

36 (2) The commission shall have seventeen (17) members,
37 consisting of the following:

38 (a) One (1) person appointed by the Governor who has
39 demonstrated a strong commitment to and understanding of the
40 challenges and issues affecting Mississippi's children;

41 (b) The Executive Director of the Department of Human
42 Services, or his designee;

43 (c) A representative from a Mississippi public school
44 program, appointed by the Speaker of the House;

45 (d) A representative from a Mississippi private school
46 program, appointed by the Lieutenant Governor;

47 (e) The Executive Director of the State Department of
48 Health, or his designee;

49 (f) The Executive Director of the State Department of
50 Mental Health, or his designee;

51 (g) The Commissioner of Higher Education, or his
52 designee;

53 (h) The Executive Director of the State Board for
54 Community and Junior Colleges, or his designee;



55 (i) The State Superintendent of Public Education, or
56 his designee;

57 (j) A member of the Mississippi Association of
58 Counselor Educators and Supervisors;

59 (k) A member of the Mississippi School Counselors
60 Association;

61 (l) A member of the Mississippi Community and Junior
62 College Counselors Association;

63 (m) A member of the Mississippi Association of Social
64 Workers;

65 (n) A member of the Mississippi Association of Marriage
66 and Family Therapists;

67 (o) A member of the Mississippi Primary Health Care
68 Association;

69 (p) A member of the Mississippi State Workforce
70 Investment Board; and

71 (q) A member of the Mississippi Speech-Language-Hearing
72 Association.

73 (3) The commission shall conduct its first meeting not
74 later than August 1, 2024. During its first meeting, the
75 commission shall choose a chairperson, a vice chairperson and a
76 secretary by majority vote, who shall serve in these positions for
77 twelve (12) months. The commission shall vote on these positions
78 annually. After the commission holds its first meeting, it shall
79 meet at such times and places as determined by its chairperson or



80 a majority of the members of the commission. The commission shall
81 meet and conduct business at least quarterly.

82 The commission shall adopt internal organizational
83 procedures necessary for the efficient operation of the commission
84 and may establish subcommittees for conducting specific programs
85 and activities. The procedures must include duties of officers, a
86 process for selecting officers, duties of subcommittees, quorum
87 requirements for conducting business and policies for any staff.
88 Members of the commission who are agency or department employees
89 shall designate necessary staff of their departments to assist the
90 commission in performing its duties and responsibilities.

91 Meetings of the commission shall be open to the public, and
92 opportunity for public comment must be made available at each
93 meeting. The staff of the commission shall notify all persons who
94 request that notice as to the date, time and place of each
95 meeting.

96 (4) The commission shall have the following duties:

97 (a) Design and oversee an itemized resource mapping of
98 all federal and state funding sources that support the health,
99 safety, permanence, growth, development and education of children
100 in this state from conception through the age of majority;

101 (b) Assess the effectiveness of programs and services
102 provided by agencies, departments, institutions and political
103 subdivisions of the state that receive federal and state funds for
104 the health, safety, permanence, growth, development and education



105 of children in this state from conception through the age of
106 majority;

107 (c) Determine the feasibility of merging, continuing or
108 discontinuing the existence of those programs and services
109 provided by agencies, departments, institutions or political
110 subdivisions of the state;

111 (d) File a report with the Chairperson and Vice
112 Chairperson of the Appropriations, Education and Public Health and
113 Human Services Committees of the Mississippi House of
114 Representatives, and the Appropriations, Education and Public
115 Health and Welfare Committees of the Mississippi Senate by
116 December 1 of each year; and

117 (e) Conduct a meeting with the report to the
118 Chairperson and Vice Chairperson of the Appropriations, Education
119 and Public Health and Human Services Committees of the Mississippi
120 House of Representatives, and the Appropriations, Education and
121 Public Health and Welfare Committees of the Mississippi Senate to
122 explain the statewide impact of the report by December 15 of each
123 year.

124 (5) The resource mapping required by subsection (4) of this
125 section shall provide:

126 (a) An inventory of all federal and state funding
127 sources that support children in this state;

128 (b) An inventory of all state, federal or government
129 subsidized services and programs offered to children in this



130 state, set out by program, target population, geographical region,
131 agency or any other grouping that would assist the commission in
132 determining whether there are overlapping programs that lead to
133 duplication within the state, gaps in service delivery and any
134 administrative inefficiencies generally;

135 (c) A description of the manner in which the funds are
136 being used within the agencies or organizations, the performance
137 measures in place to assess the use of such funding, the intended
138 outcomes of the programs and services and the actual outcomes of
139 the programs and services;

140 (d) Government mandates for the use of the funds, if
141 any; and

142 (e) An inventory of the funds for which the state may
143 be eligible, but is currently not receiving or using, and the
144 reasons why the funds are not being used.

145 (6) Members of the commission shall receive no compensation
146 for their service on the panel but may receive reimbursement for
147 travel expenses incurred while engaged in the official business of
148 the commission.

149 **SECTION 2.** (1) All agencies, departments, institutions and
150 political subdivisions of the state that provide programs or
151 services to children in this state shall create an itemized list
152 of the programs and services provided by that agency, department,
153 institution or political subdivision. The itemized list shall
154 provide the following information:



155 (a) A description of the programs and services,
156 categorized by program, target population and geographical region;
157 (b) An itemized resource map of all federal and state
158 funds received for the programs and services;
159 (c) The performance measures used to assess the
160 expenditure of those funds, the intended outcomes of the programs
161 and services and the actual outcomes of the programs and services;
162 (d) Any costs associated with operating the programs
163 and services; and
164 (e) The number of children served by the programs and
165 services.

166 (2) The agencies, departments, institutions and political
167 subdivisions shall provide the itemized lists of the programs and
168 services required by subsection (1) of this section to the John C.
169 Stennis Institute of Government at Mississippi State University
170 not later than September 1 of each year. The Stennis Institute
171 shall compile the information in those lists into one (1)
172 document, organized both by programs and services and by the
173 agencies, departments, institutions and political subdivisions
174 providing the programs and services. The Stennis Institute shall
175 provide the compiled information to the Children's Resource
176 Commission not later than November 1 of each year, and shall make
177 the compiled information available to the Chairperson and Vice
178 Chairperson of the Appropriations, Education and Public Health and
179 Human Services Committees of the Mississippi House of



180 Representatives, and the Appropriations, Education and Public
181 Health and Welfare Committees of the Mississippi Senate not later
182 than December 1 of each year.

183 (3) All agencies, departments, institutions and political
184 subdivisions of the state shall cooperate with the Children's
185 Resource Commission in fulfilling its duties. The information
186 required by this section shall be updated and provided to the
187 Children's Resource Commission not later than September 1 of each
188 year.

189 (4) The Children's Resource Commission shall provide the
190 information received by the commission and the information
191 prepared by the commission to the Division of Early Childhood Care
192 and Development of the Department of Human Services in a format
193 that does not identify any individuals.

194 **SECTION 3.** This act shall take effect and be in force from
195 and after July 1, 2024.
