HOUSE BILL NO. 873

AN ACT TO CREATE NEW SECTION 45-41-3, MISSISSIPPI CODE OF 2 1972, TO ESTABLISH THE PURPLE ALERT AS AN ADDITIONAL MEANS TO 3 ENGAGE THE PUBLIC IN THE SEARCH OF A MISSING PERSON; TO AUTHORIZE A LOCAL LAW ENFORCEMENT AGENCY TO ACTIVATE A PURPLE ALERT, 5 NOTWITHSTANDING THE EXISTENCE OF AN ACTIVE SILVER ALERT OR AMBER 6 ALERT, FOR MISSING PERSONS HAVING A COGNITIVE DISABILITY THAT IS 7 NOT DEMENTIA-RELATED; TO AUTHORIZE THE BROADCASTING OF INFORMATION RELATING TO A MISSING PERSON'S CASE TO THE LOCAL MEDIA AND 8 9 NOTIFICATION SUBSCRIBERS IN THE AREA IN WHICH THE MISSING PERSON 10 IS BELIEVED TO BE LOCATED; TO AMEND SECTION 45-41-1, MISSISSIPPI 11 CODE OF 1972, IN CONFORMITY TO THE PROVISIONS OF THIS ACT; AND FOR 12 RELATED PURPOSES. 13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 14 SECTION 1. The following shall be codified as Section 45-41-3, Mississippi Code of 1972: 15 16 45-41-3. (1) In addition to the statewide Silver Alert 17 System required under Section 45-41-1 and the Amber Alert System 18 operated by the Mississippi Bureau of Investigation of the Department of Public Safety, there is established the Purple Alert 19 as a standardized system to be used by local law enforcement 20 21 agencies to aid in the search of a missing person. A Purple Alert 22 may be in addition to: an active Amber Alert; an active Silver 23 Alert; or any mass notification provided by email regarding a

- 24 person's disappearance that does not meet the criteria for a
- 25 Silver Alert, as authorized under Section 45-41-1(7).
- 26 (2) At a minimum, a Purple Alert must:
- 27 (a) Be determined by a local law enforcement agency, in
- 28 an emergency situation, to be a viable means by which a missing
- 29 person is likely to be returned to safety;
- 30 (b) Provide, to the greatest extent possible, for the
- 31 protection of the privacy, dignity and independence of the missing
- 32 person by including standards aimed at preventing the inadvertent
- 33 or unnecessary broadcasting or dissemination of sensitive health
- 34 and diagnostic information;
- 35 (c) Limit the broadcasting and dissemination of alerts
- 36 and related information to the geographic areas where the missing
- 37 person could reasonably be, considering the person's circumstances
- 38 and physical and mental condition, the potential modes of
- 39 transportation available to the person or suspected to be
- 40 involved, and the known or suspected circumstances of the person's
- 41 disappearance; and
- (d) Be activated only when a law enforcement agency
- 43 receives a report of a missing person which includes the
- 44 information required under Section 45-41-1(4)(d).
- 45 (3) Under a Purple Alert, a local law enforcement agency may
- 46 broadcast information concerning a missing person:
- 47 (a) Who has: a mental or cognitive disability that is
- 48 not Alzheimer's disease or a dementia-related disorder; an

- 49 intellectual disability or a developmental disability; a brain
- 50 injury; another physical, mental or emotional disability that is
- 51 not related to substance abuse; or a combination of any of these;
- 52 (b) Whose disappearance indicates a credible threat of
- 53 immediate danger or serious bodily harm to himself or herself, as
- 54 determined by the local law enforcement agency; and
- (c) Who most likely cannot be returned to safety
- 56 without law enforcement intervention.
- 57 (4) If a Purple Alert is determined to be necessary and
- 58 appropriate, the local law enforcement agency having jurisdiction
- 59 must notify the media and persons who have subscribed to receive
- 60 alert notifications in the jurisdiction or jurisdictions where the
- 61 missing person may be located. The law enforcement agency also
- 62 must report the person missing to the Mississippi Bureau of
- 63 Investigation of the Department of Public Safety.
- 64 (5) The Purple Alert system must include procedures to
- 65 monitor the use, activation and results of alerts and a strategy
- 66 for informing and educating law enforcement, the media and other
- 67 stakeholders concerning the alert.
- 68 (6) A local law enforcement agency may activate a Purple
- 69 Alert notwithstanding the existence of an active Silver Alert or
- 70 Amber Alert for the same missing person if the agency determines
- 71 that a Purple Alert may improve the chances of finding the person.
- 72 **SECTION 2.** Section 45-41-1, Mississippi Code of 1972, is
- 73 amended as follows:

(2) The Legislature finds that:

- 77 (a) Wandering is a common behavior among those persons 78 with dementia or other cognitive impairments that causes great 79 concern for the families and caregivers of this state;
- 80 (b) This state is not currently equipped with the
 81 systems necessary to locate those with dementia or other cognitive
 82 impairments in a timely manner, with the unfortunate result that
 83 some individuals are never returned home to their families; and
- (c) It is imperative that this state * * * develop a

 85 plan to ensure that if an individual with dementia or other

 86 cognitive impairments is missing, the appropriate infrastructure

 87 is available and can be easily and timely activated to protect the

 88 health and safety of these vulnerable citizens.
- 89 (3) When used in this section, unless the context requires a 90 different definition, the following terms shall have the following 91 meanings:
- 92 (a) "E911" means Enhanced Universal Emergency Number 93 Service or Enhanced 911 Service, which is a telephone exchange 94 communications service by which a Public Safety Answering Point 95 designated by the county or local communication district may 96 receive telephone calls dialed to the telephone number 911.
- 97 (b) "First responders" means state and local law 98 enforcement personnel, fire department personnel, emergency

- 99 medical personnel, emergency management personnel and public works
- 100 personnel who may be deployed to bioterrorism attacks, terrorist
- 101 attacks, catastrophic or natural disasters and emergencies.
- 102 (c) "Originating local law enforcement agency" means a
- 103 local police or sheriff's office that has jurisdiction over the
- 104 area where a person became missing.
- 105 (4) (a) The Bureau of Investigation of the Department of
- 106 Public Safety shall implement a statewide "Silver Alert System"
- 107 that has the purpose of providing a tiered, rapid response system
- 108 to notify the public about missing endangered adults, who are age
- 109 18 or older, with dementia or other cognitive impairments. The
- 110 initial response may be local, statewide or national based on
- 111 available information about the missing person.
- 112 (b) A Silver Alert activation request may be made only
- 113 by a law enforcement agency, and the Bureau of Investigation of
- 114 the Department of Public Safety may only activate a Silver Alert
- 115 after a request is made.
- 116 (c) To activate a Silver Alert, all of the following
- 117 criteria must be met:
- 118 (i) The missing adult, age 18 or older, is
- 119 believed to have dementia or other cognitive impairments;
- 120 (ii) The person is believed to be missing and in
- 121 imminent danger regardless of circumstance;
- 122 (iii) The family, legal caregiver or custodian of
- 123 the missing person has submitted a missing person's report to the

- 126 (iv) The law enforcement agency that has

- 131 (d) To initiate a request to activate a Silver Alert,
- 132 the family, legal caregiver or custodian of the missing person
- 133 must file immediately a report of the missing person with the
- 134 local law enforcement agency where the person became missing that
- 135 includes the following information:
- 136 (i) A description of the missing person including
- 137 physical characteristics, clothing and photos, if available;
- 138 (ii) A description of the known circumstances
- 139 under which the person became missing including the time, place,
- 140 direction, possible destinations, whether the person is walking or
- 141 in a vehicle, and all other pertinent information concerning where
- 142 the person may have become missing; and
- 143 (iii) Updates on the missing person as new
- 144 information becomes available.
- 145 (e) The originating local law enforcement agency, after
- 146 completing the investigation expeditiously and determining that
- 147 the case meets the qualifying criteria prescribed in this section,
- 148 shall:

149	(i) Waive in the case of a Silver Alert, any
150	waiting periods for a missing person's report in order to
151	galvanize the appropriate communities rapidly to assist in the
152	search for and the safe recovery of the missing person;
153	(ii) Notify the Mississippi Highway Patrol
154	Headquarters Communication Center and electronically send to the
155	center the completed Silver Alert forms and available photos,
156	signed by the police chief, sheriff, commanding officer or his or
157	her designee;
158	(iii) Enter the information into the National
159	Crime Information Center (NCIC);
160	(iv) Using a tiered approach based on known
161	circumstances, initiate an alert bulletin to all local law
162	enforcement, E911 and first responder agencies to search the
163	immediate area;
164	(v) Activate secondary alert systems to residents,
165	businesses, and broadcast media in the immediate area;
166	(vi) Provide a twenty-four-hour phone number to
167	receive calls while continuing the investigation; and
168	(vii) Update the family, legal caregiver or
169	custodian of the missing person as new information becomes
170	available.
171	(5) (a) After the Bureau of Investigation of the Department
172	of Public Safety has been contacted by a local law enforcement
173	agency requesting a Silver Alert activation, the Criminal

- 175 Silver Alert procedures by the Silver Alert coordinator, or his or
- 176 her designee, the information contained in the initial Silver
- 177 Alert report form to ensure that it meets all criteria specified
- 178 in subsection (4)(c) of this section. Elements of the missing
- 179 person case to be considered are:
- 180 (i) Threat of imminent harm or death to the
- 181 missing person because of age, health, mental or physical
- 182 disability, environmental or weather conditions;
- 183 (ii) Time of initial report in relation to the
- 184 time of disappearance, including whether the disappearance is
- 185 unexplained, involuntary or is under suspicious circumstances;
- 186 (iii) Believed to be walking or in a vehicle;
- 187 (iv) Witness information;
- 188 (v) Possible domestic dispute involving the
- 189 missing person; and
- 190 (vi) Other facts that indicate the missing person
- 191 is in danger of serious injury or death, including whether there
- 192 is possible criminal intent toward the missing person or whether
- 193 someone witnessed the disappearance.
- 194 (b) Each case shall be reviewed on its own merits, and
- 195 if there are extenuating circumstances, the required criteria in
- 196 this section may be amended or expanded depending on the merits

- 202 (i) Prepare an announcement concerning the missing 203 person;
- 204 (ii) Contact the designated media stations to activate the alert; and
- 206 (iii) Request the Mississippi Department of 207 Transportation to activate electronic signs, if appropriate.
- 208 (d) If the missing person is believed to be in a
 209 vehicle, the Silver Alert coordinator shall send information and
 210 available photos via emails and fax to the statewide
 211 communications systems, news media and other forms of public
 212 communication or electronic resources.
- 213 (6) (a) Following the initial alert, a Silver Alert
 214 broadcast shall be updated by television and radio stations as
 215 necessary until such time that an end of alert message is received
 216 from the law enforcement agency that requested the initial Silver
 217 Alert.
- 218 (b) Local and statewide broadcast stations shall
 219 exercise their own independent discretions as to whether to repeat
 220 the required broadcasts prescribed in this section more frequently
 221 and shall determine the frequency in which the alert is
 222 re-broadcast following the initial alert.

223	(c) The Silver Alert termination notification shall be
224	issued twenty-four (24) hours after the airing of the latest and
225	most current information or when the case has been resolved and
226	verification from the originating local law enforcement agency has
227	been received by the Department of Public Safety.

- (7) (a) If the circumstances of a person's disappearance do
 not meet the criteria for a Silver Alert to activate statewide
 communication systems, in addition to a local law enforcement
 agency activating a Purple Alert, the Bureau of Investigation of
 the Department of Public Safety may offer an alternate form of
 mass notification as provided in this section.
- 234 (b) The alternate form of mass notification may be an email that includes a photograph and the Silver Alert initial reporting form that is sent through a statewide network of law enforcement and first responder agencies, news media offices and other forms of public communication.
- 239 (c) The email authorized in paragraph (b) of this 240 subsection (7) shall contain information taken from the Silver 241 Alert initial reporting form that is submitted by the originating 242 local law enforcement agency.
- 243 (d) The email alerting news media and law enforcement 244 agencies of a person's disappearance that does not meet the 245 criteria of a Silver Alert activation shall include the following 246 paragraph at the beginning of the email:

247	"The (name of law enforcement agency) has requested the
248	following information be provided to the Mississippi
249	news media and law enforcement agencies: At the
