HOUSE BILL NO. 1129

AN ACT TO AMEND SECTIONS 41-123-1, 41-123-3, 41-123-5, 2 41-123-7, 41-123-9, AND 41-123-11, MISSISSIPPI CODE OF 1972, TO 3 TRANSFER THE OFFICE OF MISSISSIPPI PHYSICIAN WORKFORCE FROM THE UNIVERSITY OF MISSISSIPPI MEDICAL CENTER TO THE STATE DEPARTMENT 5 OF HEALTH; TO BRING FORWARD SECTION 41-123-13, MISSISSIPPI CODE OF 6 1972, FOR THE PURPOSE OF POSSIBLE AMENDMENT; AND FOR RELATED 7 PURPOSES.

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 41-123-1, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 41-123-1. There is established the Office of Mississippi
- Physician Workforce within the * * * State Department of Health 12
- 13 for the purpose of overseeing the physician workforce development
- 14 and needs, both in numbers and distribution, of the State of
- 15 Mississippi. The office shall have a director, who must be a
- 16 physician licensed in the State of Mississippi and who shall be
- appointed by the State Health Officer. In addition, the office 17
- 18 shall have a researcher to assist the director in collecting and
- analyzing data concerning the physician workforce needs of 19

- 20 Mississippi and other necessary staff to assist in its work. The
- 21 office shall have the following duties, at a minimum:
- 22 (a) Assessing the current numbers, ages, types of
- 23 practice, hospital affiliations, and geographic distribution of
- 24 physicians in each medical specialty in Mississippi;
- 25 (b) Assessing the current and future physician
- 26 workforce needs of the State of Mississippi;
- 27 (c) Assisting in the creation and/or support of
- 28 Accreditation Council for Graduate Medical Education (ACGME)
- 29 accredited GME training programs in the State of Mississippi based
- 30 on needs analysis and criteria established by the office and the
- 31 advisory board while maintaining a strong and continued priority
- 32 focus on family medicine. This support may include the awarding
- 33 of state financial assistance as available, for the creation or
- 34 support of family medicine residencies and other GME programs
- 35 approved by the advisory board;
- 36 (d) Encouraging the development of an adequate and
- 37 geographically distributed physician workforce in all specialties
- 38 for the State of Mississippi with an evolving strategic plan; and
- 39 (e) Providing an annual report to the Governor * * *
- 40 and the Legislature * * * on the current status of the physician
- 41 workforce and training programs in Mississippi.
- 42 **SECTION 2.** Section 41-123-3, Mississippi Code of 1972, is
- 43 amended as follows:

- 44 41-123-3. (1) The Office of Mississippi Physician Workforce
- 45 shall be administered by * * * the State Department of Health. Ar
- 46 advisory board shall be created to assist * * * the department in
- 47 achieving the purpose of this chapter to be known as the
- 48 "Mississippi Physician Workforce Advisory Board." The advisory
- 49 board shall be composed of the following members:
- 50 (a) The Chairman of the State Board of Health or his or
- 51 her designee. * * *
- 52 (***b) Two (2) physicians appointed by and from the
- 53 membership of the Mississippi State Medical Association for a term
- of three (3) years. Any member appointed under this paragraph may
- 55 be reappointed for two (2) additional terms.
- (* * *c) Two (2) physicians appointed by and from the
- 57 membership of the Mississippi Academy of Family Physicians for a
- 58 term of three (3) years. Any member appointed under this
- 59 paragraph may be reappointed for two (2) additional terms.
- 60 (* * *d) One (1) physician appointed by and from the
- 61 membership of each of the following organizations, whose terms
- 62 shall be for three (3) years and who may be reappointed for two
- 63 (2) additional terms:
- 64 (i) Mississippi Osteopathic Medical Association;
- 65 (ii) Mississippi Chapter, American College of
- 66 Physicians;
- 67 (iii) Mississippi Chapter, American Academy of

68 Pediatrics;

- 69 (iv) Mississippi Chapter, American College of
- 70 OB-GYN; and
- 71 Mississippi Medical and Surgical Association.
- 72 (* * *e) Two (2) physician designees of the Dean of
- 73 the University of Mississippi School of Medicine, who will serve
- 74 at the will and pleasure of the dean. One (1) of the members
- appointed under this paragraph must be responsible for Graduate 75
- 76 Medical Education at the University of Mississippi School of
- 77 Medicine.
- The Chair of the Department of Family 78 (* * *f)
- 79 Medicine at the University of Mississippi School of Medicine.
- 80 A member of the State Board of Medical (***4)
- 81 Licensure, who will serve at the will and pleasure of that board.
- 82 (* * *h) * * * Two (2) designees of the Dean of the
- William Carey * * * University College of Osteopathic Medicine, 83
- 84 who will serve at the will and pleasure of the dean. One (1) of
- 85 the designees shall be responsible for GME.
- (* * *i) One (1) representative of the Mississippi 86
- 87 Economic Council appointed by the president of the council, and
- 88 who will serve at the will and pleasure of the president.
- 89 (* * *j) One (1) representative of the Mississippi
- 90 Development Authority appointed by the executive director of the
- 91 authority, who will serve at the will and pleasure of the
- 92 executive director.

- 93 (***k) One (1) representative of the Mississippi
- 94 Hospital Association, who will serve at the will and pleasure of
- 95 the association.
- 96 (* * *1) Two (2) representatives of the * * *
- 97 Community Health Center Association of Mississippi (CHCAM), who
- 98 will serve at the will and pleasure of the association.
- 99 (2) Vacancies on the advisory board must be filled in a
- 100 manner consistent with the original appointments.
- 101 (3) * * * The advisory board * * * shall establish rules for
- 102 transacting its business. A majority of the members of the
- 103 advisory board shall constitute a quorum at all advisory board
- 104 meetings. An affirmative vote of a majority of the members
- 105 present and voting shall be required in the making of
- 106 recommendations by the advisory board. * * * The advisory board
- 107 shall elect a chair and vice chair from * * * among its
- 108 members * * *. The chair shall serve for a term of two (2) years,
- 109 upon the expiration of which the vice chair shall assume the
- 110 office of chair.
- 111 (4) * * * The advisory board shall hold no less than two (2)
- 112 meetings annually.
- 113 (5) The advisory board may form an executive committee for
- 114 the purpose of transacting business that must be conducted before
- 115 the next regularly scheduled meeting of the advisory board. All
- 116 actions taken by the executive committee must be ratified by the
- 117 advisory board at its next regularly scheduled meeting.

118	(6) Members of the advisory board shall serve without
119	compensation, but may be reimbursed, subject to the availability
120	of funding, for mileage and actual and necessary expenses incurred
121	in attending meetings of the advisory board, as provided in
122	Section 25-3-41.

- 123 (7) The advisory board shall be housed at the * * * <u>State</u> 124 Department of Health.
- 125 **SECTION 3.** Section 41-123-5, Mississippi Code of 1972, is 126 amended as follows:
- 127 41-123-5. The Office of Mississippi Physician Workforce 128 shall have the following powers and duties, at a minimum:
- 129 (a) Developing the administrative policy for the 130 advisory board and the office * * *;
 - (b) Developing and implementing strategies and activities for the office and for the implementation of an evolving strategic plan to provide for the physician workforce needs of Mississippi. In developing these strategies, the Office of Mississippi Physician Workforce and the advisory board shall seek the input of various organizations and entities including the Mississippi State Medical Association, the Mississippi Academy of Family Physicians, the Mississippi Chapters of the American College of Physicians, American Academy of Pediatrics, and American College of OB-GYN, the Mississippi Medical and Surgical Association, and the Mississippi Osteopathic Medicine Association;

148	SECTION 4. Section 41-123-7, Mississippi Code of 1972, is
149	amended as follows:
150	41-123-7. (1) The advisory board shall recommend policies
151	and procedures for the awarding of state funding that creates
152	and/or provides sustaining support for the desired number of ACGME
153	accredited Family Medicine residency programs and other valued and
154	needed <u>fellowships</u> and ACGME residencies approved by the advisory
155	board that will accept both M.D. and D.O. students or trainees.
156	(2) * * * Office of Mississippi Physician Workforce, with
157	the input of the advisory board, shall have the authority to award
158	financial support, from funds specifically appropriated for that
159	purpose by the Legislature, of up to Three Million Dollars
160	(\$3,000,000.00) to any hospital or entity with demonstrated
161	commitment and resources, as determined by * * * office, with
162	input from the advisory board, to establish and operate an ACGME
163	accredited Family Medicine residency program or other GME programs
164	or fellowships qualifying under subsection (1) of this section.

(c) Establishing a budget to support the activities of

- with input from the advisory board, and may include start-up funding and/or provide sustaining support for residency programs.
- 168 (3) Each applicant for state financial support for creation
 169 of an ACGME residency program or fellowship as authorized under
 170 this section must submit an application to * * * the office * * *
 171 that conforms to requirements established by this chapter and
- 172 by * * * the office, with input from the advisory board.
- 173 (4) In selecting recipients for state financial support

 174 authorized under this section, following criteria and

 175 recommendations from the advisory board, * * * the office may use

 176 its discretion to award funding based on demographic needs and the

 177 future success of the residency program.
- 178 (5) An applicant for state financial support for creation of
 179 an ACGME accredited residency or fellowship program may receive
 180 funding only upon approval of * * * office, with input from the
 181 advisory board.
- SECTION 5. Section 41-123-9, Mississippi Code of 1972, is amended as follows:
- 41-123-9. (1) Hospitals, other entities and/or residency programs must adhere to the policies and practices as stipulated by the Office of Mississippi Physician Workforce to continue receiving state financial support under this chapter.
- 188 (2) Hospitals, other entities and/or residency programs may
 189 receive state financial support that may be provided by the
 190 office * * * pursuant to this chapter. Any financial support

191 awarded by the office * * * must be used for only the creation	or

- 192 support of a residency or * * * fellowship's operational expenses,
- 193 or the recipient will be liable for repayment of any financial
- 194 support received under this chapter.
- 195 **SECTION 6.** Section 41-123-11, Mississippi Code of 1972, is
- 196 amended as follows:
- 197 41-123-11. Any residency program or fellowship established
- 198 with state financial support must at a minimum be capable of
- 199 accepting students or trainees from both allopathic and
- 200 osteopathic medical schools that are accredited by the Liaison
- 201 Committee on Medical Education (LCME) or the Commission on
- 202 Osteopathic College Accreditation (COCA) of the American
- 203 Osteopathic Association (AOA).
- 204 **SECTION 7.** Section 41-123-13, Mississippi Code of 1972, is
- 205 brought forward as follows:
- 206 41-123-13. Funding for the operation of the Office of
- 207 Mississippi Physician Workforce and the Mississippi Physician
- 208 Workforce Advisory Board, including the salary of the director of
- 209 the office and all necessary staff, shall be paid from funds
- 210 specifically appropriated for that purpose by the Legislature.
- 211 **SECTION 8.** This act shall take effect and be in force from
- 212 and after July 1, 2024.
