HOUSE BILL NO. 1594

1 AN ACT TO PROHIBIT PERSONS UNDER THE AGE OF TWENTY-ONE YEARS 2 FROM ENTERING THE PREMISES OF A RETAILER THAT SELLS, STORES, OR 3 MAINTAINS KRATOM PRODUCTS; TO PROHIBIT PERSONS UNDER THE AGE OF 4 TWENTY-ONE YEARS FROM PURCHASING, RECEIVING, OR HAVING IN HIS OR 5 HER POSSESSION ANY KRATOM PRODUCTS; TO PROHIBIT RETAILERS FROM 6 SELLING ANY KRATOM PRODUCTS TO ANY PERSON UNDER THE AGE OF 7 TWENTY-ONE YEARS; TO REQUIRE RETAILERS THAT SELL, STORE, OR MAINTAIN KRATOM PRODUCTS TO POST A SIGN IN A CONSPICUOUS PLACE AT 8 9 OR NEAR EACH ENTRANCE STATING THAT ONLY PERSONS TWENTY-ONE YEARS 10 OF AGE OR OLDER ARE PERMITTED TO ENTER THE PREMISES; TO DEFINE 11 CERTAIN TERMS RELATING TO THIS ACT; TO PROVIDE PENALTIES FOR A 12 VIOLATION OF THIS ACT; AND FOR RELATED PURPOSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. As used in this act, the following terms have the meanings as defined in this section, unless the context clearly indicates otherwise: (a) "Kratom product" means a product containing any part of the leaf of the plant Mitragyna Speciosa, or an extract of it processed as a powder, capsule, pill, beverage, or any other

20 edible or consumable form, or any product containing Mitragynine

21 or 7-hydroxymitragynine.

22 (b) "Retailer" means any individual, partnership,

27 <u>SECTION 2.</u> (1) (a) No person under the age of twenty-one 28 (21) years shall be permitted to enter the premises of a retailer 29 that sells, stores, or maintains kratom products.

30 (b) No person under the age of twenty-one (21) years 31 shall purchase, receive, or have in his or her possession in any 32 public place, any kratom product.

(2) (a) No retailer, nor any owner, operator, employee,
representative, or agent of such retailer, shall sell, furnish,
dispose of, give, or cause to be sold, furnished, disposed of, or
given, any kratom product to any person under the age of
twenty-one (21) years.

38 (b) Retailers that sell, store, or maintain kratom 39 products shall post a sign in a conspicuous place at or near each 40 entrance stating that only persons twenty-one (21) years of age or 41 older are permitted to enter the premises.

42 SECTION 3. (a) Any person under the age of twenty-one (1)43 (21) years who falsely states he or she is twenty-one (21) years 44 of age or older, or presents any document that indicates he or she 45 is twenty-one (21) years of age or older, for the purpose of entering the premises of a retailer that sells, stores, or 46 47 maintains kratom products shall be guilty of a misdemeanor, and shall be punished by a fine of not less than Two Hundred Dollars 48

51 (b) Any person under the age of twenty-one (21) years 52 who purchases, receives, or has in his or her possession in any 53 public place, any kratom product, shall be guilty of a misdemeanor 54 and shall be punished by a fine of not less than Two Hundred 55 Dollars (\$200.00) nor more than Five Hundred Dollars (\$500.00).

56 Any owner, operator, employee, representative, or (2)(a) 57 agent of a retailer that sells, stores, or maintains kratom products, who violates, or permits the violation of, Section 2 58 59 (1) (a) of this act, upon conviction, shall be punished by a fine of not more than One Thousand Dollars (\$1,000.00), or imprisoned 60 61 in the county jail not more than six (6) months, or by both such 62 fine and imprisonment.

(b) Any owner, operator, employee, representative, or 63 agent of a retailer that sells, stores, or maintains kratom 64 65 products, who shall sell, furnish, dispose of, give, or cause to be sold, furnished, disposed of, or given, any kratom product to 66 67 any person under the age of twenty-one (21) years, upon 68 conviction, shall be punished by a fine of not more than One 69 Thousand Dollars (\$1,000.00), or imprisoned in the county jail not 70 more than six (6) months, or by both such fine and imprisonment. 71 SECTION 4. This act shall take effect and be in force from

72 and after July 1, 2024.
