## HOUSE BILL NO. 1695

1 AN ACT TO REQUIRE THE DEPARTMENT OF MENTAL HEALTH TO 2 ESTABLISH A PROGRAM TO MAKE GRANTS TO REGIONAL COMMISSIONS, 3 COUNTIES AND MUNICIPALITIES FOR THE PURPOSE OF ASSISTING IN PAYING COSTS ASSOCIATED WITH SERVICES PROVIDED BY CRISIS STABILIZATION 5 UNITS, EXPENSES OF OPERATING CRISIS STABILIZATION UNIT FACILITIES 6 AND REPAIRING, RENOVATING, UPGRADING AND IMPROVING CRISIS 7 STABILIZATION UNIT FACILITIES; TO CREATE A SPECIAL FUND IN THE 8 STATE TREASURY TO BE DESIGNATED AS THE "CRISIS STABILIZATION UNIT 9 FACILITIES FUND"; AND FOR RELATED PURPOSES.

- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 **SECTION 1.** (1) The Department of Mental Health shall
- 12 establish a program to make grants to regional commissions
- 13 established under Section 41-19-33, counties and municipalities
- 14 for the purpose of assisting the commissions in paying costs
- 15 associated with (a) services provided by crisis stabilization
- 16 units, (b) expenses of operating crisis stabilization unit
- 17 facilities and (c) repairing, renovating, upgrading and improving
- 18 crisis stabilization unit facilities. The maximum amount of a
- 19 grant made to a regional commission, county or municipality for a
- 20 single project during a fiscal year cannot exceed Five Hundred
- 21 Thousand Dollars (\$500,000.00). A regional commission, county or

- 25 (2) A regional commission, county or municipality desiring a
- 26 grant under this section must submit an application to the
- 27 Department of Mental Health. The application must include a
- 28 description of the purpose for which the grant is requested, the
- 29 cost of the purpose for which the grant is requested, the amount
- 30 of the grant requested, funds from any other sources that are
- 31 available for such purpose and any other information required by
- 32 the department.
- 33 (3) There is hereby created in the State Treasury a special
- 34 fund to be designated as the "Crisis Stabilization Unit Facilities
- 35 Fund," which shall consist of funds made available by the
- 36 Legislature in any manner and funds from any other source
- 37 designated for deposit into such fund. Unexpended amounts
- 38 remaining in the fund at the end of a fiscal year shall not lapse
- 39 into the State General Fund, and any investment earnings or
- 40 interest earned on amounts in the fund shall be deposited to the
- 41 credit of the fund. Monies in the fund shall be used by the
- 42 Department of Mental Health, upon appropriation by the
- 43 Legislature, for the purposes provided in this section.
- 44 (4) The Department of Mental Health shall have all powers
- 45 necessary to implement and administer the program established
- 46 under this section, and the department shall promulgate rules and

- 47 regulations, in accordance with the Mississippi Administrative
- 48 Procedures Law, necessary for the implementation of this section.
- 49 **SECTION 2.** This act shall take effect and be in force from
- 50 and after July 1, 2024.
