HOUSE BILL NO. 1830
(As Sent to Governor)

1 AN ACT TO PROVIDE AN ADDITIONAL APPROPRIATION OF GENERAL
2 FUNDS AND SPECIAL FUNDS TO DEFRAY THE OPERATING EXPENSES OF THE
3 SECRETARY OF STATE, THE MISSISSIPPI DEVELOPMENT AUTHORITY, AND THE
4 OFFICE OF THE ATTORNEY GENERAL FOR FISCAL YEARS 2024 AND 2025; AND
5 FOR RELATED PURPOSES.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** In addition to all other sums herein
8 appropriated, the following sum, or so much thereof as may be
9 necessary, is appropriated out of any money in the State Treasury,
10 to the credit of the Secretary of State, and allocated in a manner
11 as determined by the Treasurer's Office, to defray the expenses of
12 the Secretary of State for the period beginning upon passage, and
13 ending June 30, 2025.....\$ 14,025,000.00.

14 The purpose of these funds is for grants from the Secretary
15 of State Land Improvement Fund.

16 **SECTION 2.** In addition to all other sums herein
17 appropriated, the following sum, or so much thereof as may be
18 necessary, is appropriated out of any money in the State Treasury,
19 to the credit of the Mississippi Development Authority and



20 allocated in a manner as determined by the Treasurer's Office to
21 defray the expenses of the Mississippi Development Authority for
22 the period beginning upon passage, and ending June 30, 2025.....
23\$ 500,000.00.

24 The purpose of these funds is to provide grants from the
25 Small Unmanned Aircraft System Manufacturer Grant Fund.

26 **SECTION 3.** In addition to all other sums herein
27 appropriated, the following sum, or so much thereof as may be
28 necessary, is appropriated out of any money to the credit of the
29 General Fund, and allocated in a manner as determined by the
30 Treasurer's Office, to defray the expenses of the Office of the
31 Attorney General for the period beginning upon passage of this
32 act, and ending June 30, 2025.....\$ 2,500,000.00.

33 This additional appropriation is for the purpose of defraying
34 allowable expenses for Victims of Human Trafficking and Commercial
35 Sexual Exploitation pursuant to Sections 97-3-54.10 through
36 97-3-54.13, Mississippi Code of 1972.

37 **SECTION 4.** This act shall take effect and be in force from
38 and after its passage.
