SENATE BILL NO. 2065

AN ACT TO CREATE THE "REINFORCING COLLEGE EDUCATION ON 1 2 AMERICA'S CONSTITUTIONAL HERITAGE ACT" OR THE "REACH ACT"; TO 3 REQUIRE THAT EACH INSTITUTION OF HIGHER LEARNING MUST PROVIDE 4 INSTRUCTION CONCERNING THE UNITED STATES CONSTITUTION, THE 5 DECLARATION OF INDEPENDENCE, THE FEDERALIST PAPERS, THE 6 EMANCIPATION PROCLAMATION, ABRAHAM LINCOLN'S GETTYSBURG ADDRESS, AND DR. MARTIN LUTHER KING JR.'S LETTER FROM BIRMINGHAM JAIL TO 7 EACH UNDERGRADUATE STUDENT FOR THREE SEMESTER CREDIT HOURS; TO 8 9 CREATE EXCEPTIONS TO THE REQUIREMENT; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 10 11 **SECTION 1.** (1) Each state institution of higher learning 12 must provide undergraduate students instruction concerning the 13 United States Constitution, the Declaration of Independence, the 14 Federalist Papers, the Emancipation Proclamation, Abraham 15 Lincoln's Gettysburg Address, and the Letter from Birmingham Jail by Dr. Martin Luther King, Jr. No state institution of higher 16 17 learning may grant a diploma for a baccalaureate degree program to a student unless the student successfully completes the 18 requirements described in subsection (2) of this section. 19 20 (2) Each state institution of higher learning must require each undergraduate student, except a student eligible for the 21

exemption provided in subsection (3) of this section, to complete no fewer than three (3) credit hours in the subject of American government or American history. The American Government or American History course must, at a minimum, require each undergraduate student to:

27 (a) Read the United States Constitution in its28 entirety;

29 (b) Read the Declaration of Independence in its30 entirety;

31 (C) Read the Emancipation Proclamation in its entirety; 32 (d) Read a minimum of five (5) essays in their entirety 33 from the Federalist Papers as selected by the course instructor; 34 Read Lincoln's Gettysburg Address in its entirety; (e) 35 Read the Letter from Birmingham Jail by Dr. Martin (f) 36 Luther King, Jr., in its entirety; and

(g) Pass a cumulative final examination at the conclusion of the course, testing for student proficiency in the provisions and principles of the United States Constitution, the Declaration of Independence, the Federalist Papers, the Emancipation Proclamation, Lincoln's Gettysburg Address, and the Letter from Birmingham Jail by Dr. Martin Luther King, Jr.

43 (3) A state institution of higher learning may exempt a 44 student from the requirements of subsection (2) of this section 45 who has successfully completed three (3) credit hours, or the 46 equivalent, as follows:

48 American government or American history if the Advanced Placement
49 course satisfies the requirements of subsection (2) of this
50 section;

51 (b) In a dual-enrollment course in the subject of 52 American government or American history, if the dual-enrollment 53 course satisfies the requirements of subsection (2) of this 54 section;

55 (c) In an associate degree program in a community or 56 junior college if the completed three (3) credit hours, or their 57 equivalent, in the associate degree program satisfies the 58 requirements of subsection (2) of this section; or

(d) In an International Baccalaureate (IB) course in
the subject of American government or American history, if the
International Baccalaureate course satisfies the requirements of
subsection (2) of this section.

63 (4) Each state institution of higher learning must ensure 64 that the requirements of this subsection (2) of this section are 65 incorporated into the degree requirements of all baccalaureate 66 degree programs in a manner that does not add to the total number 67 of credit hours for any baccalaureate degree program.

68 (5) The Board of Trustees of the Institutions of Higher 69 Learning must ensure the compliance of each state institution of 70 higher learning with all the provisions of this section. The 71 board annually must collect information and compile it into a

This report must be submitted annually to the 77 chairpersons of the following legislative committees: The Senate Appropriations Committee; the House of Representatives Ways and 78 79 Means Committee; the Senate Universities and Colleges Committee; 80 and the House of Representatives Universities and Colleges 81 Committee.

82 <u>SECTION 2.</u> This act applies to all freshman classes enrolled 83 in baccalaureate degree programs after the effective date of this 84 act. Nothing in this act shall be construed to prevent an 85 undergraduate student enrolled in a state institution of higher 86 learning on or before the effective date of this act from 87 receiving a diploma.

88 <u>SECTION 3.</u> If any state institution of higher learning fails 89 to enforce the provisions of this act for more than one (1) 90 academic year, the Board of Trustees of State Institutions of 91 Higher Learning shall remove the head of that institution from his 92 or her position.

93 SECTION 4. This act shall take effect and be in force from 94 and after July 1, 2025, and shall apply to freshman classes 95 entering for the 2025-2026 school year and all subsequent freshman 96 classes.
