## REPORT OF CONFERENCE COMMITTEE

## MR. SPEAKER AND MR. PRESIDENT:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 1298: Mississippi Wild Turkey Stamp; establish.

We, therefore, respectfully submit the following report and recommendation:

- 1. That the Senate recede from its Amendment No. 1.
- 2. That the House and Senate adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 13 **SECTION 1.** (1) For the purposes of this section, the
- 14 following words and phrases shall have the meanings ascribed
- 15 herein unless the context clearly indicates otherwise:
- 16 (a) "Wild turkey" means the game bird Meleagris
- 17 gallopavo.
- 18 (b) "Stamp" means the state wild turkey stamp, either
- 19 in its physical or electronic form, furnished by the commission.
- 20 A stamp is a specialized permit required for hunting wild turkeys,
- 21 with proceeds directly dispersed into the conservation,
- 22 management, protection or scientific research of wild turkeys.
- 23 (c) "Harvest tag" means the electronic tool used to
- 24 serve as an inventory of the annual bag limit allotted to
- 25 individual wild turkey hunters. Harvest tags are invalidated upon
- 26 the harvest of a wild turkey.

- 27 (d) "Nongovernmental entity" means a nonprofit
- 28 organization primarily concerned with the protection and
- 29 conservation of land and natural resources, as evidenced by its
- 30 organizational documents.
- 31 (2) (a) It shall be unlawful for any person not exempt
- 32 under paragraph (b) of this subsection to hunt or take wild
- 33 turkeys during any open wild turkey season in this state without
- 34 first having procured a stamp. The electronic stamp on file with
- 35 the commission shall serve as proof of procurement.
- 36 (b) Any resident citizen of this state who has not
- 37 reached the age of sixteen (16) years or who has reached the age
- 38 of sixty-five (65) years, or any resident citizen who is blind,
- 39 paraplegic, or a multiple amputee, or who has been adjudged by the
- 40 Veterans Administration as having a total service-connected
- 41 disability, or has been adjudged to be totally disabled by the
- 42 Social Security Administration shall be exempt from the
- 43 requirements of this section. Further, the holder of any lifetime
- 44 sportsman license authorized under Section 49-7-153 shall be
- 45 exempt from the requirements of this section.
- 46 (3) The fee to resident hunters for each stamp shall be Ten
- 47 Dollars (\$10.00). The fee to nonresident hunters for each stamp
- 48 shall be One Hundred Dollars (\$100.00). Each stamp shall be valid
- 49 through the final day of the spring wild turkey season following
- 50 its purchase. After its expiration, another stamp must be

- 51 procured in order to hunt or take wild turkeys in a future open
- 52 wild turkey season.
- 53 (4) Except for persons exempted under subsection (2) (b) of
- 54 this section, the commission may make the procurement of harvest
- 55 tags dependent upon the purchase of a stamp.
- 56 (5) The commission shall determine the form of the stamp.
- 57 The commission shall furnish physical stamps to bonded agents for
- 58 issuance or sale in the same manner as other types of licenses or
- 59 shall cause the electronic stamp to accrue to the purchaser's
- 60 benefit when purchased from an automated point-of-sale source.
- 61 (6) Any person violating any of the provisions of this
- 62 section shall be guilty of a misdemeanor and, upon conviction,
- 63 shall be fined not less than Twenty-five Dollars (\$25.00) nor more
- 64 than One Hundred Dollars (\$100.00) as prescribed in Section
- 65 49-7-101.
- 66 (7) All revenue from the proceeds of stamps shall be
- 67 deposited into the Fisheries and Wildlife Fund created in Section
- 68 49-5-21 and shall be used and expended only for the following
- 69 objectives:
- 70 (a) Paying administrative or processing costs
- 71 associated with an electronic harvest tag program, or any other
- 72 program governing or regulating the harvest of wild turkeys;
- 73 (b) Restoring, enhancing or protecting wild turkey
- 74 populations or their habitats on public or private lands in
- 75 Mississippi as prescribed by the department;

- 76 (c) Funding scientific research, as conducted by
- 77 qualified professionals, into the ecology or management of wild
- 78 turkeys, their habitats or their predators; and
- 79 (d) Increasing access to publicly available turkey
- 80 hunting opportunities.
- 81 (8) Proceeds from stamps may be used as matching funds or
- 82 fiscal leverage to secure grants or other financial awards which
- 83 are deemed to align with the objectives in subsection (7) of this
- 84 section. No such proceeds shall be expended for administrative
- 85 salaries.

- 86 (9) The commission may enter into agreements with other
- 87 state, federal or nongovernmental entities to execute the
- 88 objectives in subsection (7) of this section.
- SECTION 2. Section 1 of this act shall be codified as a new
- 90 section in Title 49, Chapter 7, Mississippi Code of 1972.
- 91 **SECTION 3.** This act shall take effect and be in force from
- 92 and after July 1, 2024.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO IMPOSE THE REQUIREMENT OF PROCURING A WILD TURKEY STAMP BEFORE HUNTING WILD TURKEYS IN THE STATE OF MISSISSIPPI; TO PROVIDE EXEMPTIONS FROM THE REQUIREMENT; TO ESTABLISH THE FEE FOR

4 RESIDENT AND NONRESIDENT HUNTERS; TO PROVIDE FOR THE FURNISHING OF

- 5 THE STAMP; TO SET PENALTIES FOR VIOLATIONS; TO PROVIDE THAT ALL
- 6 REVENUE FROM THE PROCEEDS OF STAMPS SHALL BE DEPOSITED INTO THE
- 7 FISHERIES AND WILDLIFE FUND, AND TO PROVIDE THE OBJECTIVES FOR
- 8 WHICH SUCH REVENUE MAY BE USED AND EXPENDED; TO AUTHORIZE THE
- 9 COMMISSION ON WILDLIFE, FISHERIES AND PARKS TO ENTER INTO

10 AGREEMENTS WITH OTHER STATE, FEDERAL OR NONGOVERNMENTAL ENTITIES

TO EXECUTE SUCH OBJECTIVES; AND FOR RELATED PURPOSES. 11
