REPORT OF CONFERENCE COMMITTEE

MR. SPEAKER AND MR. PRESIDENT:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 1785: Appropriation; Pat Harrison Waterway District.

We, therefore, respectfully submit the following report and recommendation:

- That the Senate recede from its Amendment No. 1.
- 2. That the House and Senate adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is authorized and approved for expenditure out of any
7	funds which are received by or otherwise become available to the
8	Pat Harrison Waterway District, for the purpose of defraying the
9	expenses of the district for the fiscal year beginning
10	July 1, 2024, and ending June 30, 2025
11	\$ 8,055,463.00.
12	SECTION 2. Of the funds approved for expenditure under the
13	provisions of Section 1, the following positions are authorized:

15	Permanent: 55
16	Time-Limited: 0
16 17	Time-Limited: 0 With the funds herein appropriated, it shall be the agency's

- 19 Services for Fiscal Year 2026 do not exceed Fiscal Year 2025 funds
- 20 appropriated for that purpose unless programs or positions are
- 21 added to the agency's Fiscal Year 2025 budget by the Mississippi
- 22 Legislature. The Legislature shall determine the agency's
- 23 personal services appropriation, which the State Personnel Board
- 24 shall publish. The agency's personal services appropriation may
- 25 consist of restricted funds for approved vacancies for Fiscal Year
- 26 2025 that may be utilized to fill vacant Fiscal Year 2024
- 27 headcount. It shall be the agency's responsibility to ensure that
- 28 the funds provided for vacancies are used to increase headcount
- 29 and not for promotions, title changes, in-range salary adjustments
- 30 or any other mechanism for increasing salaries for current
- 31 employees. It is the Legislature's intention that no employee
- 32 salary falls below the minimum salary established by the
- 33 Mississippi State Personnel Board.
- 34 Additionally, the State Personnel Board shall determine and
- 35 publish the projected annualized payroll costs based on current
- 36 employees. It shall be the responsibility of the agency head to
- 37 ensure that actual personnel expenditures for Fiscal Year 2025 do
- 38 not exceed the data provided by the Legislative Budget Office. If
- 39 the agency's Fiscal Year 2025 projected cost exceeds the
- 40 annualized costs, no salary actions shall be processed by the
- 41 State Personnel Board except for new hires determined to be
- 42 essential for the agency.

- 43 Any transfers or escalations shall be made in accordance with the terms, conditions, and procedures established by law or 44 allowable under the terms set forth within this act. 45 Personnel Board shall not escalate positions without written 46 47 approval from the Department of Finance and Administration. 48 Department of Finance and Administration shall not provide written approval to escalate any funds for salaries and/or positions 49 50 without proof of availability of new or additional funds above the 51 appropriated level.
- 52 No general funds authorized to be expended herein shall be 53 used to replace federal funds and/or other special funds used for 54 salaries authorized under the provisions of this act and which are 55 withdrawn and no longer available.
- 56 None of the funds herein appropriated shall be used in violation of the Internal Revenue Service's Publication 15-A 57 58 relating to the reporting of income paid to contract employees, as 59 interpreted by the Office of the State Auditor.
- 60 SECTION 3. It is the intention of the Legislature that the 61 Pat Harrison Waterway District shall maintain complete accounting 62 and personnel records related to the expenditure of all funds 63 appropriated under this act and that such records shall be in the 64 same format and level of detail as maintained for Fiscal Year 2024. It is further the intention of the Legislature that the 65 66 agency's budget request for Fiscal Year 2026 shall be submitted to 67 the Joint Legislative Budget Committee in a format and level of

- 68 detail comparable to the format and level of detail provided
- 69 during the Fiscal Year 2025 budget request process.
- 70 **SECTION 4.** It is the intention of the Legislature that
- 71 whenever two (2) or more bids are received by this agency for the
- 72 purchase of commodities or equipment, and whenever all things
- 73 stated in such received bids are equal with respect to price,
- 74 quality and service, the Mississippi Industries for the Blind
- 75 shall be given preference. A similar preference shall be given to
- 76 the Mississippi Industries for the Blind whenever purchases are
- 77 made without competitive bids.
- 78 **SECTION 5.** The funds herein approved for expenditure, except
- 79 and less an amount approved by the State Fiscal Officer which
- 80 shall be sufficient to cover disbursements for current operations,
- 81 shall be deposited at interest with any official depository of the
- 82 state at a rate of interest numerically not less than one percent
- 83 (1%) below the bank discount rate on United States Treasury bills
- 84 of comparable maturity as determined by the State Treasurer.
- 85 **SECTION 6.** Of the funds appropriated in Section 1, Seven
- 86 Hundred Thousand Dollars (\$700,000.00) is authorized to be
- 87 expended to defray the cost of park facilities repairs only.
- 88 These repairs are to include bath houses and cabins and to exclude
- 89 any Flint Creek Horse Trail repairs.
- 90 **SECTION 7.** Of the funds appropriated in Section 1, Four
- 91 Hundred Eighty Thousand Dollars (\$480,000.00) is authorized to be
- 92 expended to defray the cost of dam repairs.

- 93 **SECTION 8.** The Pat Harrison Waterway District shall provide
- 94 a report on completed park facilities repairs. This report shall
- 95 be provided to the Legislature by December 1, 2024, and shall
- 96 include photos of stated repairs. The Pat Harrison Waterway
- 97 District shall provide the Joint Legislative Budget Committee a
- 98 copy of this report with the subsequent fiscal year's budget
- 99 submission.
- 100 **SECTION 9.** The Pat Harrison Waterway District shall provide
- 101 an annual five-year plan containing a prioritized list detailing
- 102 the purposes, goals and projected costs of projects which it
- 103 intends to implement or is in the process of implementing. This
- 104 report shall be provided to the Legislature on or before July 15
- 105 of each year as required in Section 51-15-119(2). The Pat
- 106 Harrison Waterway District shall provide the Joint Legislative
- 107 Budget Committee a copy of this report with the current year's
- 108 budget submission.
- 109 **SECTION 10.** The Pat Harrison Waterway District shall provide
- 110 an annual audit of the district operations. This report shall be
- 111 provided to the Legislature as required in Section 51-15-119(3).
- 112 The Pat Harrison Waterway District shall provide the Joint
- 113 Legislative Budget Committee a copy of this report with the
- 114 current year's budget submission.
- 115 **SECTION 11.** It is the intention of the Legislature that the
- 116 funds herein appropriated shall be expended in compliance with
- 117 Section 27-104-25, Mississippi Code of 1972, that no state agency

- 120 or upon their official bonds, shall be held responsible for
- 121 actions contrary to this provision.
- 122 **SECTION 12.** The money herein approved for expenditure shall
- 123 be disbursed upon bank checks signed by the proper person, officer
- 124 or officers, in the manner provided by law.
- 125 **SECTION 13.** This act shall take effect and be in force from
- 126 and after July 1, 2024.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE PAT HARRISON WATERWAY DISTRICT FOR THE FISCAL YEAR 2025.
