REPORT OF CONFERENCE COMMITTEE

MR. SPEAKER AND MR. PRESIDENT:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 1803: Appropriation; Nursing, Board of.

We, therefore, respectfully submit the following report and recommendation:

- 1. That the Senate recede from its Amendment No. 1.
- 2. That the House and Senate adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 11 **SECTION 2.** Of the funds appropriated under the provisions of
- 12 Section 1, the following positions are authorized:
- 13 AUTHORIZED HEADCOUNT:
- 14 Permanent: 40
- 15 Time-Limited: 0
- With the funds herein appropriated, it shall be the agency's
- 17 responsibility to make certain that funds required for Personal
- 18 Services for Fiscal Year 2026 do not exceed Fiscal Year 2025 funds

- 19 appropriated for that purpose unless programs or positions are
- 20 added to the agency's Fiscal Year 2025 budget by the Mississippi
- 21 Legislature. The Legislature shall determine the agency's
- 22 personal services appropriation, which the State Personnel Board
- 23 shall publish. The agency's personal services appropriation may
- 24 consist of restricted funds for approved vacancies for Fiscal Year
- 25 2025 that may be utilized to fill vacant Fiscal Year 2024
- 26 headcount. It shall be the agency's responsibility to ensure that
- 27 the funds provided for vacancies are used to increase headcount
- 28 and not for promotions, title changes, in-range salary adjustments
- 29 or any other mechanism for increasing salaries for current
- 30 employees. It is the Legislature's intention that no employee
- 31 salary falls below the minimum salary established by the
- 32 Mississippi State Personnel Board.
- 33 Additionally, the State Personnel Board shall determine and
- 34 publish the projected annualized payroll costs based on current
- 35 employees. It shall be the responsibility of the agency head to
- 36 ensure that actual personnel expenditures for Fiscal Year 2025 do
- 37 not exceed the data provided by the Legislative Budget Office. If
- 38 the agency's Fiscal Year 2025 projected cost exceeds the
- 39 annualized costs, no salary actions shall be processed by the
- 40 State Personnel Board except for new hires determined to be
- 41 essential for the agency.
- 42 Any transfers or escalations shall be made in accordance with
- 43 the terms, conditions, and procedures established by law or

- 44 allowable under the terms set forth within this act. The State
- 45 Personnel Board shall not escalate positions without written
- 46 approval from the Department of Finance and Administration. The
- 47 Department of Finance and Administration shall not provide written
- 48 approval to escalate any funds for salaries and/or positions
- 49 without proof of availability of new or additional funds above the
- 50 appropriated level.
- No general funds authorized to be expended herein shall be
- 52 used to replace federal funds and/or other special funds used for
- 53 salaries authorized under the provisions of this act and which are
- 54 withdrawn and no longer available.
- None of the funds herein appropriated shall be used in
- 56 violation of the Internal Revenue Service's Publication 15-A
- 57 relating to the reporting of income paid to contract employees, as
- 58 interpreted by the Office of the State Auditor.
- 59 **SECTION 3.** Of the funds provided for herein, One Million
- 60 Five Hundred Sixty Thousand Dollars (\$1,560,000.00) shall be
- 61 provided for the Office of Nursing Workforce (ONW). In accordance
- 62 with Section 73-15-18(1), Mississippi Code of 1972, the
- 63 Mississippi Board of Nursing is designated as the state agency
- 64 responsible for the administration and supervision of the Nursing
- 65 Workforce Program as an educational curriculum. The mission of
- 66 the Office of Nursing Workforce is to carry out the scope of
- 67 service and leadership tasks required of the profession by



- 68 promoting a strong educational infrastructure between nursing
- 69 practice and nursing education.
- 70 **SECTION 4.** Of the funds provided under the provisions of
- 71 this act, an amount not to exceed One Hundred Five Thousand
- 72 Dollars (\$105,000.00) may be allocated to the Mississippi Board of
- 73 Pharmacy to defray the expenses of the Mississippi Prescription
- 74 Monitoring Program.
- 75 **SECTION 5.** As a condition of receiving the funds
- 76 appropriated in this act, the Mississippi Board of Nursing shall
- 77 develop a plan to revise the nursing licensure laws to provide
- 78 eligibility for licensure to those who have completed the Air
- 79 Force 4N Training Program or possess a practical nursing degree
- 80 from the Community College of the Air Force, alongside individuals
- 81 who completed the Army's practical nurse program and Navy Corpsman
- 82 course, and present the plan to the Legislature not later than the
- 83 first day of the 2025 Regular Session for consideration by the
- 84 Legislature. The purpose of authorizing such licensure
- 85 eligibility is to acknowledge the value of military training in
- 86 nursing, expedite licensure procedures for those persons, and
- 87 efficiently integrate qualified military-trained individuals into
- 88 the nursing workforce which will help in addressing the state's
- 89 healthcare needs effectively and economically.
- 90 **SECTION 6.** It is the intention of the Legislature that the
- 91 funds are appropriated here in accordance with a signed Memorandum
- 92 of Understanding with the Mississippi Department of Health to

93 assist with the implementation of the Medical Cannabis Act for

94 registering and monitoring compliance with the rules and

95 regulations of the Act.

96 SECTION 7. It is the intention of the Legislature that the 97 Mississippi Board of Nursing shall maintain complete accounting

98 and personnel records related to the expenditure of all funds

appropriated under this act and that such records shall be in the 99

same format and level of detail as maintained for Fiscal Year 100

101 2024. It is further the intention of the Legislature that the

102 agency's budget request for Fiscal Year 2026 shall be submitted to

103 the Joint Legislative Budget Committee in a format and level of

detail comparable to the format and level of detail provided

105 during the Fiscal Year 2025 budget request process.

106 SECTION 8. It is the intention of the Legislature that 107 whenever two (2) or more bids are received by this agency for the 108 purchase of commodities or equipment, and whenever all things 109 stated in such received bids are equal with respect to price, quality and service, the Mississippi Industries for the Blind 110 111 shall be given preference. A similar preference shall be given to 112 the Mississippi Industries for the Blind whenever purchases are

113 made without competitive bids.

> SECTION 9. It is the intention of the Legislature that the funds herein appropriated shall be expended in compliance with Section 27-104-25, Mississippi Code of 1972, that no state agency shall incur obligations or indebtedness in excess of their

appropriation and that the responsible officers, either personally or upon their official bonds, shall be held responsible for actions contrary to this provision.

SECTION 10. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law.

127 **SECTION 11.** This act shall take effect and be in force from 128 and after July 1, 2024.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE STATE TREASURY FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE MISSISSIPPI BOARD OF NURSING FOR THE FISCAL YEAR 2025.
